## JAMB, NRC AND NBET EXCEL IN ICPC INTEGRITY TEST

The Joint Admissions and Matriculation Board (JAMB), the Nigerian Railway Corporation (NRC), and the Nigerian Bulk Electricity Trading Plc (NBET) have been recognized as the top performers in the Independent Corrupt Practices and Other Related Offences Commission (ICPC) 2024 Ethics and Integrity Compliance Scorecard (EICS), achieving impressive scores of 89.75%, 89.33%, and 88.73%, respectively.

The ICPC unveiled the report during a press conference on Thursday, which evaluated the ethical standards, anti-corruption measures, and governance practices of 330 Ministries, Departments, and Agencies (MDAs) nationwide. The assessment focused on critical indicators, including governance and executive management practices, financial and auditing processes, as well as policies regarding ethics education

The Director of the Joint Admissions and Matriculation Board, JAMB Zonal Office Lagos(HA), Mr. Shittu Billiaminu, has called on tertiary institutions in the State to uphold the principles of fairness, transparency, and credibility during their admission processes.

Mr. Shittu made this call while receiving the Rector, Timeon Kairos Polytechnic, Lagos, Rev. Dr. Titus Kolawole Oyeyemi, who was at the State Office to officially announce the full accreditation of almost all the key programmes of the institution by the National Board for Technical Education (NBTE). According to him, the accredited

programmes included Mass Communication, Banking and Finance, Business Administration and Management, Marketing, and Public Administration.

Rev. Dr. Oyeyemi also used the occasion to emphasize the institution's readiness to adhere to all extant admission guidelines issued by the Board while providing quality education to students. He commended the Board for its pivotal role in ensuring a standardized and merit-based admission process across Nigerian institutions stressing that his institution remains dedicated to fairness and transparency.

Earlier, the State Technical Officer, Mr. Akinwale Afolabi, had highlighted the parameters by which the centres would be assessed during the exercise.

At the end of the exercise on Tuesday, 17th December, 2024, the team converged on the JAMB Ogun State Office, Abeokuta, to harmonise their reports.

In his remarks, the CEE, who was represented by Dr. Oyewole, expressed appreciation to all the team members for their commitment to the exercise and urged them to make useful recommendations capable of generating appropriate remedial actions.

and whistle-blowing mechanisms. The findings indicated that no MDA achieved full compliance; 29.55% attained substantial compliance, 51.62% had partial compliance, 15.91% demonstrated poor compliance, and 2.92% were classified as non-compliant.

The ICPC identified several common gaps in the assessments, including the absence of whistle-blower policies, lack of strategic plans, and ineffective stock verification units. Additionally, many MDAs did not conduct internal system reviews or

submit timely financial and audit reports.

Dr. Musa Aliyu, Chairman of the Commission, emphasized that the EICS aims to bolster the transparency, accountability, and integrity of government institutions, thereby contributing to the ongoing fight against corruption.

Aliyu stated that the Commission will continue to recognize and reward MDAs that demonstrate substantial compliance, while also holding non-compliant institutions accountable through enforcement actions.

"The Commission acknowledges MDAs with substantial compliance and will persist in utilizing these tools to promote integrity and accountability. Non-compliant MDAs will face necessary actions, including enforcement, to ensure adherence to government directives. We are confident that these efforts will further reinforce ICPC's commitment to enhancing good governance and combating corruption," he asserted.

**PUNCH, MONDAY, DECEMBER 16, 2024:** FG renames UniAbuja Yakubu Gowon Varsity: – The Federal Executive Council has approved the renaming of the University of Abuja as Yakubu Gowon University.

The Minister of Information and National Orientation, Mohammed Idris, revealed this to State House correspondents after the council held its last meeting for 2024 at the Aso Rock Villa, Abuja.

Idris said, "The third item is that there is also a decision taken by the Federal Executive Council to rename the University of Abuja to honour elder statesman, General Yakubu Gowon."

"The University of Abuja will, henceforth, be called Yakubu Gowon University. Of course, the process will have to go to the National Assembly for all legislative work in that direction, but FEC has taken that decision to write to the National Assembly to change the name of the University of Abuja."

**PUNCH, TUESDAY, DECEMBER 17, 2024:** Polytechnic Denies Issuing Fake Medical Lab Science Admission Letters: - Ibom Metropolitan Polytechnic, a privately owned institution in Akwa Ibom State, has dismissed claims of issuing false admission letters for a Medical Laboratory Science programme.

In a statement issued on Monday, December 16, 2024 in Uyo, the Acting Rector, Mr. Samuel Etim, clarified that the polytechnic does not offer a degree programme in Medical Laboratory Science, nor does it have a department for the course.

The clarification comes in response to a report published by the Association of University Academic Medical Laboratory Scientists in the Nigerian Tribune on December 13, 2024. The publication, titled "Illegal Mounting of Medical Lab Science Degree Programme," alleged that Ibom Polytechnic issued admission letters to candidates for the course.

To be classified as a "Best High Performer," an agency must achieve a score between 75% and 100% and consistently demonstrate exceptional performance, efficiency, and effectiveness in service delivery. Following this category are "Strong

Contenders" (61%-74%), "Developing Agencies" (50%-60%), and "Underperforming Agencies" (40%-49%). Agencies scoring between 0%-39% are categorized as severely underperforming and in need of critical intervention.

During the presentation of the awards, Mrs. Nnenna Akajemeli, the National Coordinator/Chief Executive of SERVICOM, applauded JAMB for its remarkable achievements. She noted that agencies recognized as "Best High Performers" will be featured on the SERVICOM website and across its social media platforms, a distinction they will hold until the next annual awards.

In her remarks, Mrs. Akajemeli stated,

### ...STEAM EDUCATION MODEL: Stakeholders Canvass for Support

Nigerian Young Academy (NYA) equally called on Federal, State Governments and other eminent groups to key into this noble initiative.

Briefing newsmen shortly after the presentation of the implementation report to the Registrar of JAMB, Prof. Is-haq Oloyede, the Chairperson, STEAM Implementation Team and Fellow Academy of Sciences (FAS), Prof. Emerita Obioma Nwaorgu, pointed out that the objective of the project was to advocate and mainstream locally-appropriate STEAM policies into education in schools, adding that the journey had started with members of the project committee, comprising JAMB and academics, developing strategies to articulate these policies.

According to her, one of the achievements recorded by the project was its inclusion in the 2024 Education Roadmap of the Federal Government as well as in the draft policy document for STEAM education in Nigeria. The STEAM initiative was launched in six pilot States: Adamawa, Ebonyi, Nasarawa, Ondo, Rivers and Sokoto, while the team interacted with a total of 222 teachers on a train-the-trainers basis.

The Chairman also informed the gathering that the Implementation Committee had paid advocacy visits to the National Universities Commission (NUC), Universal Basic Education Commission (UBEC), and other development partners towards spreading the STEAM gospel.

She said, "We now have a major document which we can present to the National Assembly whenever the need arises. In effect, there is increased awareness as some people, who had never heard about STEAM are now talking about it. An example is that of the Ondo State Government, which had expressed support for the STEAM Initiative in a letter, among other notable achievements. All these are, of course, apart from strengthening the capacity of teachers with respect to STEAM education. In all, prospective UTME candidates and teachers are now aware of how to improve their performance in the education value chain. We want to go beyond this."

Prof. Nwaorgu also expressed her expectation of improvement in the UTME performance in the six pilot States of the STEAM project. While stating that the team had delivered on its goals and objectives, she

stated that the implementation of STEAM educational model in Nigeria is achievable. She, however, said there was a need for sustainability so that the initiative could move to the next level of implementation.

To achieve this, she said, "We need more States to key into the STEAM education for improvement. When you introduce design into the learning programme, it makes it better and you can start teaching children at a younger age, moulding them to have critical minds at a younger age."

The team recommends the replication of the STEAM educational initiative in the 30 remaining States of the Federation and the FCT.

In his remarks, the Registrar, Prof. Is-haq Oloyede, represented by the Director of Finance and Accounts, Mr. Mufutau Bello, urged the team to leverage opportunities available in research to positively impact the education sector. He also stated that the Board holds the project in high esteem and expressed hope that the initiative would be the beginning of an enduring collaboration among various academies in the country.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
