The 2024 Management Retreat will feature participation from key stakeholders in the education sector, including members of the academic community, professionals from both local and international backgrounds, and representatives from sister agencies.

The retreat will take a holistic approach to the Board's operations, aiming to devise strategies that enhance its future engagements and provide added value services to the public and its clients. Additionally, it will assess progress in implementing the Honourable Minister's roadmap for the education sector.


During this brainstorming session, Zonal Directors, State Coordinators, and service providers will be present to review the accuracy and completeness of data resources, evaluate progress and achievements, enhance communication with key stakeholders, ensure compliance with policy statements, and gather stakeholders' views and suggestions. This collaborative effort aims to facilitate quicker and more informed decision-making on significant issues.

Among the topics for discussion will be the Board's performance in the 2024 UTME, the overall effectiveness of Computer-Based Test (CBT)

centers, the impact of innovations introduced during the 2024 UTME exercise, and the performance of service providers, test engines, helpline desks, monitoring groups, and examination officials.

Additionally, the retreat will address various advisories concerning institutions, admission deadlines, operational procedures regarding age limits for admissions, and the agenda for the 2025 UTME. The upcoming Africa Regional Conference on Equal Opportunity of Access to Higher Education (ARCEAHED), scheduled for September 17, 2024, will also be discussed to ensure its success.

In a brief goodwill message, the PCA highlighted JAMB's dedication to addressing the challenges faced by individuals with disabilities in accessing higher education in Nigeria.

He noted that the Board has established the JAMB Equal Opportunity Group (JEOG) to support candidates living with disabilities, provided free UTME application forms for candidates with five credits in O/L, and facilitated admissions for those meeting the minimum accepted mark for entry into tertiary institutions.

Dr. Benjamin mentioned that JAMB organized a two-day maiden National Conference on Equal Opportunity of Access to Higher

the auspices of JEOG. This conference, held in Abuja from September 25 to 26, 2023, focused on increasing equal opportunities for access to higher education.

He explained that critical stakeholders at the conference extensively discussed the welfare of PWDs, analyzed the challenges facing higher education in Nigeria, particularly for individuals with special needs, and proposed actionable solutions to improve national education policies. The discussions aimed to address inequalities in access to higher education for groups such as the blind, albinos, persons with autism, and those in correctional centres.

Dr. Benjamin also announced the upcoming first African Regional Conference on Equal Opportunity of Access to Higher Education (ARCEAHED), scheduled for September 17-19, 2024, in Abuja. He encouraged attendees to take advantage

of this regional conference to improve the conditions for PWDs.

He revealed that representatives from at least eight African countries would participate in the conference, which aims to advocate for the rights and inclusion of persons with disabilities across the continent.

The PCA reaffirmed JAMB's commitment to PWDs and encouraged well-meaning Nigerians to support this initiative and the renewed hope agenda of President Bola Ahmed Tinubu, which aims to enhance the lives of these individuals and the broader Nigerian community. Additionally, he highlighted various interventions by JAMB under its Corporate Social Responsibility (CSR) initiatives, including school adoptions, the deployment of educational staff to selected schools, the provision of essential amenities, health interventions, and the donation of medical facilities to Bwari General Hospital, among other efforts.

Keynote addresses were delivered by Distinguished Senator Babanaida Uba on "Why Do We Care," while Ambassador Prof. Steve Ugbah focused on "Appealing to the Horizon: Passion for Special Needs Children," among other speakers.





PUNCH, SUNDAY, AUGUST 18, 2024: UNICAL Mobilised Bread Seller for Service, Says NYSC: The National Youth Service Corps (NYSC) has expressed concern over the University of Calabar's inclusion of a bread seller on its graduation list for the mandatory one-year national service. To address this issue, the NYSC has demobilised 54 illegally mobilised graduates from the university to prevent unqualified individuals from receiving NYSC certificates.

According to a statement by Eddy Megwa, Director of Information and Public Relations, the NYSC Director-General, Brigadier-General Yusha'u Ahmed, announced that the illegal graduates would face prosecution. The statement also revealed that 19 out of 54 initially registered online for mobilisation were prevented from service and 4 certificates for other culprits were not produced by the scheme

The NYSC will intensify collaboration with Heads of Corps Producing Institutions and stakeholders to combat this issue. Ahmed emphasised that mobilisation process failures reflect on the institution's management integrity, stressing the need for data handlers to be people of integrity.

He urged employers to verify the authenticity of Certificates of National Service presented for job placement with the NYSC. This follows the NYSC's earlier invalidation of certificates for 101 illegally Mobilised UNICAL graduates who participated in the scheme between 2021-2023.

The University's Pro-Chancellor, DIG Udom Ekpoudom (retd.), commended the NYSC for exposing fake graduates and pledged to take action against staff involved in the mobilisation of fake graduates.

PUNCH, SUNDAY, AUGUST 18, 2024: FG Eyes \$500m World Bank Loan to Boost Education, Health Sectors: The Federal Government is seeking a \$500 million loan from the World Bank to address human resource challenges in Nigeria's education and healthcare sectors. The loan, part of the Nigeria Human Capital Opportunities for Prosperity and Equity Governance Programme, aims to tackle longstanding staffing gaps and enhance performance management for basic education teachers and primary healthcare workers.

According to the Programme Information Document, obtained by Sunday PUNCH, the World Bank is expected to give final approval for the loan on September 26, 2024. The implementing agencies include the Ministry of Budget and Economic Planning, the Ministry of Education, and the Ministry of Health.

The loan will focus on three key areas: Improving recruitment, deployment, and performance management of sector workers; Enhancing workforce planning; and Implementing new systems for payroll management and fraud reduction, including the Central Bank of Nigeria's Bank Verification Numbering system and National Identity Numbers platforms

The loan will provide necessary financial resources to enhance recruitment processes, ensuring qualified professionals are deployed where needed. This will strengthen financial and human resource management in basic education and primary healthcare sectors.

PUNCH, MONDAY, AUGUST 19, 2024: NDLEA Commander Proposes Drug Test for Admission Seekers: The Commander of the National Drug

Law Enforcement Agency (NDLEA) Kwara State Command, Hajia Fatima Abiola-Popoola, has called on the National Universities Commission to make drug testing a mandatory requirement for admission into tertiary institutions. She emphasised the need for students to pass drug tests before gaining admission, citing the alarming increase in drug users, particularly among females.

Abiola-Popoola stressed the importance of collaboration with traditional rulers in combating drug trafficking and abuse. She urged them to take an active role in monitoring their communities, gathering intelligence, and inviting NDLEA when necessary.

The Commander expressed gratitude to the Emir of Ilorin, Dr. Ibrahim Sulu-Gambari, for his support and cooperation. She noted that the Emir had pledged to mobilize other traditional rulers in Kwara State to support the NDLEA's efforts, ensuring that communities are informed of their presence and activities.

Abiola-Popoola believes that success in the fight against drug abuse depends on the support of stakeholders, particularly traditional institutions. She emphasised the need for a collective effort to address the growing drug menace in the country.

PUNCH, MONDAY, AUGUST 19, 2024: Fake Degrees: FG Orders Varsities to Submit Matriculation Lists: The Federal Government has directed all higher institutions in Nigeria to submit their matriculation lists to the Federal Ministry of Education within three months of matriculation ceremonies. The lists must be submitted through the Joint Admissions and Matriculation Board's dedicated channel.

This directive is part of the government's efforts to combat fake degree mills and certificate racketeers. In March, an Inter-Ministerial Investigative Committee was constituted to investigate certificate racketeering following an exposé by Daily Nigerian on fake degree mills in the Benin Republic.

A memo from the education ministry to JAMB on July 15, 2024, stated that the committee's report has been submitted and its recommendations approved for implementation. The recommendations include mandatory use of the Central Admissions Processing System by all tertiary institutions for admissions and regular submission of matriculation lists to the Federal Ministry of Education within three months of matriculation ceremonies through JAMB's dedicated channel.

The government aims to enforce these measures to prevent certificate racketeering and ensure the authenticity of degree certificates. Also in Blueprint, Monday, August 19, 2024.

BLUEPRINT, TUESDAY, AUGUST 20, 2024: <u>2024</u>: <u>UBEC to launch 12 New</u> <u>Model Smart Schools in September</u>: The Universal Basic Education Commission (UBEC) is set to launch 12 new model smart schools across various states in Nigeria. Dr Hamid Bobboyi, the Executive Secretary of UBEC, made this announcement during an interactive session with stakeholders at the Commission's Digital Resource Centre (DRC) in Abuja.

Representing Dr Bobboyi, Professor Bashir Galadanci, National Coordinator of the UBEC DRC, highlighted the significance of the meeting, which focused on the proposed launch of the smart schools by September 2024. He emphasised the benefits of the smart school initiative and expressed optimism for a productive dialogue among stakeholders.

Dr. Hafsat Lawal Kontagora, head of the capacity development unit at UBEC DRC, discussed the commission's goal of revolutionising basic education through innovative teaching and learning methods, such as blended learning. She solicited input from stakeholders to assess the preparedness of the smart schools for a successful launch.

The stakeholders present included directors of State Universal Basic Education Board (SUBEB), desk officers overseeing smart schools, UBEC state coordinators, and zonal directors.

PUNCH, TUESDAY, AUGUST 20, 2024: <u>WAEC Opens Portals for 2025</u> <u>WASSCE School Recognition</u>: The West African Examinations Council (WAEC) has announced the opening of online portals for school recognition and Continuous Assessment Scores (CASS) upload for the 2025 West African Senior School Certificate Examination (WASSCE). Schools presenting candidates for the 2025 WASSCE must complete their recognition process and upload the necessary CASS data within the stipulated deadlines.

According to a statement (BN/ZC/MOE/15/VOL.2/139) signed by Mr A. Adebolu, Head of Examinations for the Branch Controller, the school recognition portal will be open from September 2 to December 13, 2024, for new schools. All schools seeking approval for WASSCE (SC) 2025 must make the required payments and complete their application process within this period.

The online recognition portal will be accessible from September 2 to December 13, 2024, for new schools, while the CASS 1 & 2 upload portal will remain open from September 2 to December 20, 2024. Schools must ensure timely compliance, as the portals will close at midnight on the respective due dates.

BLUEPRINT, WEDNESDAY, AUGUST 21, 2024: <u>Uganda, Kenyan Probe Nigerian</u> <u>Students' Credentials as Fake</u> <u>Certificates Spread:</u> The Joint Admissions and Matriculation Board (JAMB) has revealed that examination boards in Kenya and Uganda are now verifying the records of Nigerian candidates seeking admission into tertiary institutions in their countries.

This development is aimed at ensuring the authenticity of credentials presented by Nigerian students.

According to a document released by JAMB for the 2024 policy meeting, the Board emphasised its commitment to upholding the integrity of Nigeria's tertiary education system and will not falsify any student's records.

This move comes after the Federal Government suspended the verification of degree certificates from several countries, including Uganda, Kenya, Benin Republic, Togo, and others, due to allegations of certificate racketeering. An Inter-Ministerial Investigative Committee was established in March to investigate the activities of certificate racketeers, following an exposé by Daily Nigerian on fake degree mills in the Benin Republic.

The committee's report, received by the Minister of Education, Tahir Mamman, led to the decision to flush out holders of fake degrees from Nigerian and foreign universities. The report also recommended that universities conduct admissions through the Central Admissions Processing System (CAPS) and submit matriculation lists to the Federal Ministry of Education.

JAMB's announcement highlights the growing collaboration between examination boards in Africa to combat academic fraud and ensure the credibility of educational credentials. DAILY POST, WEDNESDAY, AUGUST 21, 2024: <u>Reps Committee to Carry Out</u> <u>Forensic Investigation in UNILAG,</u> <u>UNIPORT, Others:</u> The House of Representatives Committee on University Education has resolved to conduct a forensic investigation into

the financial activities of several universities, including the University of Calabar, University of Port Harcourt, Federal University of Petroleum Resources, and Federal University Uyo, among others. This decision follows the committee's oversight visit to universities in the South-South Region, where inconsistencies were observed in their submissions.

Committee Chairman Abubakar Hassan Fulata announced that the forensic examination is necessary due to discrepancies and irreconcilable data in the documents presented. Additional universities requiring further investigation include Federal University Otuoke and Nigerian Maritime University Okerenkoko.

The committee also cautioned newly established universities to avoid the mistakes of older institutions, such as noncompliance with federal character principles and unauthorised spending of internally generated revenue. The universities advised include the Federal University of Medical Health Science Kwale and the Federal University of Technology Ikot Abasi.

Fulata stated that the committee has visited over 30 federal universities in 21 states and the Federal Capital Territory, Abuja, in recent weeks. Despite challenges, including logistics and travel difficulties, the committee remains committed to making a positive impact.

BLUEPRINT, THURSDAY, AUGUST 22, 2024: Enforce Mandatory Admission on CAPS, Education Ministry Tells JAMB: The Federal Ministry of Education has directed the Joint Admissions and Matriculation Board (JAMB) to enforce the mandatory use of the Central Admissions Processing System (CAPS) for all tertiary institutions in Nigeria. This directive follows the submission of a report by an Inter-Ministerial Committee, constituted to investigate allegations of certificate racketeering involving foreign institutions, particularly in Cotonou, Benin Republic.

According to JAMB's weekly bulletin, the Minister's request for implementation of the report's recommendations was conveyed by the then Permanent Secretary, now Head of Service of the Federation, Mrs Didi Esther Walson-Jack.

The bulletin stated that JAMB has automated the CAPS platform to eliminate biases and abuses associated with manual admissions. However, some institutions have continued to admit students outside of the platform, perpetuating unacceptable practices. The directive reinforces JAMB's commitment to closing avenues for illegal admissions. Candidates are warned not to accept admissions not offered through CAPS, as the Board will fully implement this ministerial directive.

TRIBUNE, THURSDAY, AUGUST 22, 2024: 149 Private Universities Only Cater for 10% of Students' Population-NUC: The Acting Executive Secretary of the National Universities Commission (NUC), Mr Chris Maiyaki, has disclosed that Nigeria's 149 private universities can only accommodate about 10% of the country's university-aged population. Despite the presence of 274 universities (62 federal, 63 state, and 149 private), the institutions can only admit between 500,000 and 700,000 candidates out of the over two million prospective students seeking admission annually.

Maiyaki made this revelation during a meeting with a delegation from the International Institute of Online Education (IIOE), China, an affiliate of UNESCO, led by Professor Jiansheng Liang. The IIOE aims to enhance teacher competency and access to quality higher education resources in developing countries.

The NUC's expansion efforts coincide with the IIOE delegation's visit, as the commission seeks to increase access to university education. Maiyaki emphasised the need to address the significant gap between demand and available university spaces, reiterating the commission's commitment to facilitating the establishment of additional universities across Nigeria.

DAILY INDEPENDENT, THURSDAY, AUGUST 22, 2024: <u>2024 Admission:</u> Anchor Varsity Commences

Screening, Vows to Comply with JAMB Regulations: Anchor University, Ayobo, Lagos, has reaffirmed its commitment to fully comply with the Joint Admission Matriculation Board (JAMB) regulations during its Post-UTME admission screening exercise. The Vice-Chancellor, Prof. Samuel Bandele, made this declaration, stating that the university will adhere strictly to JAMB's guidelines to avoid any potential ambiguity that could jeopardize students' efforts.

The online screening exercise, scheduled to start on August 26, 2024, at 10 a.m. daily, will be conducted in accordance with JAMB's regulations. Prof. Bandele emphasized that Anchor University has always maintained the standard of admission set by the regulatory body and will continue to do so.

He encouraged candidates who have chosen Anchor University as their first choice to adhere to the admission regulations. Additionally, those who wish to change their first choice to Anchor University must do so through JAMB.

To accommodate more students, the university has set a minimum UTME score of 150 for the post-UTME screening exercise. Prof. Bandele urged candidates to upload their O'level results to the JAMB website as soon as possible, warning that noncompliance may hinder their admission.

THISDAY, THURSDAY, AUGUST 22, 2024: No More Admission Malpractices: JAMB Unveils New Strategies to Enforce Compliance: The Joint Admissions and Matriculation Board (JAMB) has declared war on illegal admissions in Nigerian tertiary institutions, vowing to eradicate admission malpractices. At a meeting with admission officers from Ogun State institutions on August 21 2024, JAMB Coordinator Alhaji Abdulhakeem Abdulhammed unveiled new strategies to enforce compliance and ensure merit-based admissions.

The meeting, themed: "Towards Doing Admissions Right in Nigerian Institutions," emphasised JAMB's

determination to process all admissions through the Central Admission Process System (CAPS). Abdulhammed warned that noncompliance would face severe sanctions from the Minister of Education.

Key highlights of the new measures include complete automation of JAMB services; online accreditation of centres; remote exams; and digital payment systems.

Institutions have a one-month grace period to disclose all undisclosed admissions before facing sanctions. Abdulhammed reiterated JAMB's commitment to guiding institutions in adopting federal government policies.

The meeting marked a significant turning point in Nigeria's fight against education corruption, ushering in a new era of transparency and accountability. Dr. Stella Mofunanya, Rector of Redeemer's College of Technology and Management emphasised the collective responsibility of ensuring a flawless admission process.

PUNCH, FRIDAY, AUGUST 23, 2024: FG Installs Power Plants In Six Federal Universities: The Federal Government, through the Rural Electrification Agency, has successfully installed power plants in six federal universities, marking a significant milestone in its efforts to provide reliable power to critical sectors of society. This achievement is part of the agency's progress in advancing Nigeria's electrification projects, as highlighted by Managing Director Abba Abubakar Aliyu in a recent briefing to the Minister of Finance and Coordinating Minister for the Economy, Mr Wale Edun.

The beneficiary institutions include the University of Abuja; University of Maiduguri; Michael Okpara University of Agriculture in Umudike; Federal University Gashua in Yobe; Federal University of Agriculture in Abeokuta; and the Nigerian Defence Academy in Kaduna

This initiative demonstrates the government's commitment to

improving access to reliable power in critical sectors, including education.

PUNCH, SATURDAY, AUGUST 24, 2024: <u>Poly Develops Electric Tricycle, Seeks</u> <u>FG Support for Mass Production:</u> The Rector of the Federal Polytechnic, Ilaro, Ogun State, Dr Mukail Akinde, on Friday said the institution is planning to have a mini assembly plant for the production of its newly invented electric automated tricycle.

Dr. Akinde also called on the Federal Government as well as corporate organisations especially in the manufacturing sector to help drive the commitment of the polytechnic to see to the commercial production of the invention.

The rector said that the success of the commercial production of the tricycle would help a lot to cut importation, "reduce the pressure on our foreign exchange and boost job opportunities for our teeming youths." Dr. Akinde disclosed this while speaking when the Governing Council of the institution led by its Chairman, Alhaji Garba Gashua and the National Automotive Design and Development Council visited the innovation centre of the institution to inspect the newly invented electric automated tricycle.

The polytechnic is said to be the first institution to produce this brand of tricycle, built and assembled at the institution's innovation centre. The rector appealed to the Federal Government to inject more funds into the institution to birth more innovations, research, and development.

He said, "If we cannot produce this tricycle in commercial quantity, it means that we shall be importing it and this will pile more pressure on our exchange rate. So we are asking for agencies that will support us and also fund this polytechnic so that we can do better.

PUNCH, FRIDAY, AUGUST 23, 2024: Over 22,500 Nigerians Parading Fake Certificates From Benin, Togo –FG: The Minister of Education, Prof. Tahir Mamman, has disclosed that over 22,500 Nigerians are parading fake certificates obtained from universities in Benin Republic and Togo between 2019 and 2023.

He said over 21,600 obtained the certificates from an unaccredited university in Benin Republic within the timeframe, while about 1,105 obtained theirs from some unaccredited universities in Togo.

This is coming after an undercover investigation by a journalist revealed how he obtained a degree within six weeks and even proceeded to embark on mandatory youth service under the National Youth Service. The minister, who disclosed this at a press conference to mark his first-year anniversary on Friday in Abuja, said some of the numbers were harvested from records from the National Youth Service Corp (NYSC) and other sources.

"Sadly, these people have used the fake certificates to apply and secure job opportunities in government and private organizations with the mindset that they schooled abroad, while people who studied day and night are out there looking for job opportunities," he said.

The minister, however, confirmed that a circular was being prepared from the Office of Head of Service of the Federation that would enable them fish out the people for due prosecution. "Private sector operators are also encouraged to carry out further investigations on their staff who are parading foreign certificates and ensure that anyone parading a certificate obtain from these countries between 2019 and 2023 are fished out and handed over to the Federal Ministry of Education for prosecution. The circular from the Head of Service will also be binding on private sector operators." In summary, criminology is a multifaceted discipline that seeks to understand crime from various perspectives and applies this knowledge to improve the effectiveness of the criminal justice system and enhance public safety.

Branches of criminology include criminal law, correction, victimology, cybercrime, forensic science, policing and law enforcement, etc.

Governor, Gombe State, Muhammad Inuwa Yahaya. The meeting, which was at the instance of the State Government, was attended by critical stakeholders in the State's educational sector as well as members of the committee constituted by the Governor to seek collaboration with the Board in the establishment of Mega CBT centres. The meeting was held at the Office of the Gombe State Commissioner of Education, Gombe, on Monday, 12th August, 2024.

In her opening remarks, the Gombe State Commissioner of Education, Dr. Aishatu Umar Maigeri, welcomed the State Coordinator and his team and informed him that the meeting was sequel to the support he solicited from the State Government on his assumption of office as the State Coordinator to establish a Mega CBT centre in the State. She commended the current leadership of the Board for its various achievements and expressed the readiness of the State Government to support the Board's activities in the State as well as leverage on other areas of competences of the Board. In his paper presentation titled: "The Contributions of CBT Centres to National Development in Nigeria" the State Coordinator gave historical perspectives on how CBT was birthed in the Board. He noted that various challenges such as examination malpractice, among others, in the Paper and Pencil Testing (PPT) prompted the Board to switch to Computer-Based Testing (CBT) in 2013. the mode of testing brought about a number of challenges especially with regard to the issue of inadequate CBT centres to accommodate the teeming numbers of UTME candidates yearly. He stressed that the resources needed to build adequate number of centres was beyond the capacity of the Board, hence, the Board had to enter into Public Private Partnership (PPP) to bridge the infrastructural gap. He added that with minimal number of centres at the inception of the CBT, there are currently over seven hundred (700) accredited CBT centres nationwide. Continuing, the State Coordinator, however, disclosed that the inadequate number of CBT centres

### MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR <u>PROGRAMMES</u>

# This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).

3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.

4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.

5. No candidate can use the process to change any of the data already supplied to the Board.

6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institutions a processing fee as determined by the respective institutions.

### CONDONMENT OF ILLEGAL ADMISSIONS BY JAMB

The Board has discovered widespread and unwholesome practices whereby some institutions were colluding with candidates to falsify vital records such as backdated year of entry and subsequent age adjustments to utilise certificates of genuine candidates with similar names and to facilitate condoning illegal admissions carried out before 2017 to enable participation of fake candidates in the National Youth Service Corps (NYSC) scheme.


2. Similarly, the Board has observed that some institutions continue to admit candidates outside CAPS after 2020 and subsequently apply for Condonement of Undisclosed Illegal Institutional Admissions (CUIIA) backdating such recent admissions to 2020 to fit within the timeframe of CUIIA. This is an abuse of the waiver granted by the former Minister of Education, on the recommendation of JAMB.

3. The Board has considered measures to close these abused windows while still reaffirming that CAPS is the only authorized platform for admissions. The following has been decided: -

- a. The Board will no longer entertain absorption of (pre-2017) illegal admissions through the window of "Condonment of Illegal Admissions without Registration Number". The Window (for mop-up of pre-2017 unofficial/unrecorded admissions) has been on now for 7 years and is being abused.
- b. The Board is terminating the aspect of the CUIIA process (2017-2020 illegal admissions) that allows completely unregistered (without registration) candidates to be introduced to the system.

# 4. Consequently, institutions are hereby required to now (or never) disclose, through the CAPS mail:

- i. All their candidates who were admitted illegally before 2017, whose records are on their system, within the next one (1) month beginning from 1<sup>st</sup> August 2024.
- ii. All their students who fall within the 2017-2020 window for the Condonment of Undisclosed Illegal Institutional Admissions (CUIIA) that had not been included in the earlier declaration as required via letter No. JAMB/R/225H/VOL.17 dated 6<sup>th</sup> December 2021. This is to be done within the next one (1) month beginning from 1<sup>st</sup> August 2024.





5. The dateline for all these disclosures will be 31<sup>st</sup> August 2024 after which no declaration will be entertained. Any admission purportedly given within these periods (pre-2017 and 2017-2020) will no longer be recognised or condoned unless disclosed within this one-month window. Only students on the declared list will be allowed to register with the Board. The window for all condonments will be closed at a date to be communicated soon.

6. This recent move is aimed at curbing illegal admissions and falsification of records. Any institution found to have admitted any candidate outside CAPS after 2020, will be made to face appropriate sanctions in addition to the forfeiture of the said admission with its legal implications.

7. Institutions are therefore advised to comply with this directive as there will not be any further condonement of hitherto unrecorded candidates who did not even register with JAMB not to talk of sitting for any examination.

8. While urging you to accord this circular the attention it deserves, accept the best regards of the Board, please.

that had hitherto been a source of weakness to the Board had been turned into one of opportunity as the development of such edifice could be leveraged upon as an alternative source of funding. He pointed out that many institutions of learning, public and private organisations have also keyed into the idea of establishing Mega CBT centres owing to its numerous advantages.

He further revealed that apart from improved productivity, cost effectiveness and credibility of the UTME conducted therein, CBT centres have also contributed to national development in Nigeria by providing individuals with basic means of livelihood.

Furthermore, Adebiyi explained that the establishment of CBT centres would not only boost the ICT skills of students but can also be used to attract Internally-Generated Revenue (IGR) to the State Government especially from the conduct of UTME and other Board's third-party examinations such as recruitment, promotion, and scholarship examinations, as well as fostering the day -to-day activities of the Board.

He disclosed further that the holding halls of CBT centres can also be used as training venues for skill acquisition programmes to stimulate the growth of small-scale enterprises so as to reduce youth unemployment and promote self-sustenance and selfreliance among the populace.

He added that the facilities should not be allowed to remain idle as they can as well serve as event centres for social activities like weddings, birthdays, meetings for sociocultural groups, among others.

Speaking further, he stated that On the ent well-equipped CBT centres could be leveraged upon as a technical hub and innovation centre in the State, where many businesses related to technology could collaborate to

facilitate cross-pollination of ideas, enabling individuals and organisations to exchange ideas, share knowledge, and form partnerships.

The Coordinator concluded that CBT centres play an important role in creating new jobs, new sources of income, improving digital and entrepreneurial skills, and by extension, national development in Nigeria.

In her closing remarks, Dr. Maigeri thanked the Coordinator for his insightful presentation and promised the readiness of the State Government to synergise with the Board to upgrade its existing computer centres to Mega CBT centres across the State.

On the entourage of the State Coordinator, were some notable staff of the State Office, among whom were: Mr. Mubarak Sani Aliyu, Mr. Idris Jungudo, and Mr. Umar Muhammed.

## MINISTERIAL DIRECTIVES ON THE RECOMMENDATIONS OF THE INTER-MINISTERIAL INVESTIGATIVE COMMITTEE ON DEGREE CERTIFICATE MILLING: REQUEST FOR IMPLEMENTATION

You are aware that the Federal Government through an inter-ministerial committee had investigated the issues of certificate racketeering involving some foreign institutions around Nigeria. The investigations also looked at the issue of illegal admissions by institutions in Nigeria and the issuance of fake certificates by the institutions. The Hon. Minister of Education has now directed the implementation of the recommendations contained in the report of the investigation committee.

2. I therefore convey the directives of the Honourable Minister to the Board for implementation of the following recommendations (a copy of the letter from the Hon. Minister is attached):

- i. Enforce the mandatory requirement for all tertiary institutions in Nigeria to exclusively conduct their admissions processes through the Central Admissions Processing System (CAPS) under the auspices of the Joint Admissions and Matriculation Board (JAMB).
- ii. Mandate all tertiary institutions in Nigeria to regularly submit their matriculation lists to the Federal Ministry of Education not later than three months after matriculation ceremonies through the dedicated channel of the Joint Admissions and Matriculation Board (JAMB).

3. Consequently, the Board reiterates the Policy that under no condition shall any candidate be admitted outside CAPS. Furthermore, the recent circular No. JAMB/ADMS/DO/192/V.I dated 31<sup>st</sup> July 2024 by the Board, emphasizes that no illegal admission will henceforth be condoned and any institution found to have admitted any candidate outside CAPS will be made to face appropriate sanctions. This is in addition to the forfeiture of the said admission with its legal implications.



4. Each Institution is expected to promptly respond to JAMB analysis of its matriculation list so that the list and the responses could be forwarded, as directed, to the Honourable Minister of Education.



# DOING ADMISSIONS RIGHT, IS OUR COLLECTIVE RESPONSIBILITY - RECTOR RECTEM

call has gone to all stakeholders in the education sector to adhere strictly to admission guidelines into the nation's tertiary institutions.

The call was made by the Rector, Redeemer's College of Technology and Management (RECTEM), Mowe, Ogun State, Dr. Stella. I. Mofunanya, during the meeting with all Admission Officers in the State with the State Coordinator, Mr. Hakeem AbdulHameed, in the College Chapel, on Wednesday, 21st August, 2024.

According to Dr. Mofunanya, doing admissions right is a collective responsibility and not just the duty of Admission Officers alone as stakeholders in the education sector must ensure that all their admissions conform with extant admission policies, especially with regard to admitting students through the Central Admissions Processing System (CAPS).

Speaking further, the Rector urged Admission Officers to be diligent while discharging their duties and always seek clarifications when in doubt.

The Admission Officer, Babcock University, Dr. Mrs. Chioma Nemezu, took other participants through a practical and step-by-step admission process on CAPS using the 2023 admissions platform by leveraging on its user-friendly interface, which allows for easy navigation to previous years, among others.

The Admission Officer, Gateway Industrial and Petro-Gas Institute, Mr. Alaba Olufemi, expressed appreciation to the Rector and Management of RECTEM for their hospitality and thanked the State Coordinator for his foresight and for always ensuring compliance with all admissions guidelines across all tertiary institutions in the State.

Earlier, the State Coordinator, in his welcome address, thanked the institution for willingly agreeing to host the significant event. He told the Admission Officers that the maiden meeting themed: "Towards doing Admissions right in Nigerian Institutions" became necessary to reiterate and expatiate on important information passed at the justconcluded 2024 Policy Meeting, which took place in Abuja. He added that he would not relent in his efforts to ensure that admission is done correctly according to the Board's guidelines by all the institutions in the State.

Also, the Head, Matriculation Monitoring Unit, JAMB State Office, Mrs. Kafayat Ibiwoye, gave the participants a comprehensive lecture on the correct admission procedures.

Furthermore, she outlined some of the wrong process as: admissions outside CAPS, admitting above approved quota, admitting to study unaccredited programme, using below-standard O' level results. putting non-regular programmes, especially Part- Time under Condonement of Undisclosed Illegal Institutional Admission (CUIIA), directing Part- Time students to apply for Condonement of Illegitimate Admissions (With or Without Registration Number) for the purpose of enrolling for NYSC, amona others.

Mrs. Ibiwoye further counseled the Admission Officers to be law abiding by processing all admissions on CAPS, collect only N2,000 for Post-UTME screening, submit Matriculation List for analysis, stop admitting students that have already gained admissions into other institutions, guard their login details jealously, upload their Post-UTME results, reserve 5% of their admission quota for students with disabilities, among others. She reminded them that the conduct of matriculation ceremonies ends the admissions' process.

Among the distinguished personalities, who graced the occasion, was a top media

practitioner and friend of the Board. Alhaji Najeem Jimoh, who delivered his goodwill message by commending Dr. Mofunanya for making the meeting, which he described as first of its kind in the country, possible. He uraed the Admission Officers to stop admission outside CAPS as it poses serious problems to candidates. He also charged the participants to ensure the holding of subsequent meetings as that would give room for the much-needed clarifications on issues discussed at the Policy Meetina.

Alhaji Najeem commended the initiative of the State Coordinator for convening the meeting and recalled that an institution in Ogun State, Ogun State Institute of Technology, Igbesa, had won the sum of 75 Million naira as the most-compliant institution in adhering to admission guidelines in 2019. He expressed hope that more institutions in Ogun State would be awarded prizes in next year edition of the National Admissions Performance Merit Awards (NATAP-M).

While giving the vote of thanks, the Head, SERVICOM/PR Unit of the State Office, Ms. Abiola Adekunle, also thanked Dr. Mrs. Stella Mofunanya, and the Management of the esteemed institution for hosting the meeting. She thanked all the Admission Officers for attending the meeting and urged them to be responsive to the innovations of the Board at all times.

The meeting witnessed an impressive turnout of participants as forty-six Admission Officers from various institutions in the State were in attendance.

# **CESSATION OF ILLEGAL/IRREGULAR ADMISSIONS**

- All applications of admissions to First Degree, National Diploma, National Innovation Diploma and the Nigeria Certificate in Education into Full-Time, Distance Learning, Part-Time, Outreach, Sandwich, etc., must be processed ONLY through the Joint Admissions and Matriculation Board (JAMB).
- No Institution should advertise or sell "application forms" for admissions into the programmes. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
- Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.

The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.

It should be reiterated that no Institution should advertise or sell application forms" for admissions into the programmes listed above.
