he year 2024 holds significant promise for individuals, organizations, and nations alike. In Nigeria, under the leadership of President Bola Ahmad Tinubu, economic reforms are taking shape, evident in the gradual decline of PMS pump prices, signaling a shift towards a more competitive market. For the Joint Admissions and Matriculation Board (JAMB), 2024 represents a pivotal moment-a time to

reap the rewards of the various innovations the Board has implemented. One area where the Board has demonstrated commendable courage over the years is in enhancing accountability, transparency, and openness in its financial practices. Since 2017, the Board has consistently provided weekly income and expenditure reports for public scrutiny.

As we reflect on 2024, it is essential to uphold our commitment to transparency by sharing our financial performance for the year. In 2024, the Board generated a total income of N22,996,653,265.25. From this amount, It expended N18,198,739,362.68 towards conducting examinations (UTME), paid service providers, and covering essential expenses, including staff claims amounting to N2,119,571,022.88.

Upon assuming office, Professor Ishaq Oloyede's management team prioritized financial responsibility. In line with government regulations, it remitted over N7billion from its operational surplus during the first year. Additionally, management initiated a programme to give back to candidates by reducing the cost of its application documents by

N1,500, a practice that has continued with subsequent remittances to the federal treasury. In 2024, the Board remitted N6,034,605,510.69 to the government. When combined with the N1,500 reduction per form for candidates multiple by the number of candidates that benefited in 2024, the total remittance by JAMB would

amount to N9,013,068,510.69. Looking ahead to 2025, the Board remains committed to maintaining accountability, transparency, and openness in all financial dealings. The Board will also continue to ensure equity and fairness for all candidates in the admission process, which remains its core mandate.

2025 UTME/DE REGISTRATION: COLLABORATIVE EFFORTS CRITICAL TO SUCCESSFUL OUTCOME – ADEBIYI

n line with the dictum that says, "He who fails to plan, plans to fail" the Gombe State Coordinator, Mr. Johnson Adebiyi, on Tuesday, 31st December, 2024, organised a one-day capacity building workshop for staff of the State Office ahead of the commencement of the 2025 UTME/DE registration exercise.

While stating the objectives of the workshop, the Coordinator declared that it was borne out of the desire to set meaningful goals for the State Office and its staff during the upcoming 2025 UTME registration exercise so as to achieve a seamless exercise as well as foster teamwork. Adebiyi stated that the office workspace had been structured to prevent overcrowding at the Board's Professional Registration Centre (PRC) and the adjoining holding areas to ensure a seamless registration exercise.

According to him, this initiative became expedient in view of the recent reports of stampedes recorded in some public places across the country noting that the Board as a responsible and responsive organisation is duty bound to display a high level of professionalism to ensure the safety of candidates and staff during the registration exercise. He added that to achieve maximum result, the principle of management by objectives would be adopted to measure performance against a series of set targets to gauge staff overall performance in their assigned responsibilities.

Furthermore, he stated that the 2025 UTME/DE registration exercise scheduled for January, 2025, is time bound, and, therefore, urged staff to be committed and dedicated to their duties to prevent disruption of the Board's Calendar for 2025. To this

end, he revealed that the State Office would set reminders to review daily goals, keep up-to-date records on the 2025 UTME/DE registration dashboard, eliminate time wasting activities, deploy productivity apps, motivate staff, as well as offer a wellness programme during the exercise.

Adebiyi further advised staff to shun any act unbecoming of an officer of the Board as anyone found wanting would be sanctioned appropriately. He reiterated that all hands must be on deck to achieve the goals of the Board and solicited the cooperation of all staff in this direction.

At the end of the training, the staff expressed appreciation to the State Coordinator for organising the workshop and pledged their support as he repositioned the State Office for enhanced productivity.

NATION, THURSDAY, JANUARY 2, 2025: NELFUND Has Paid N24b as Loan, Upkeep for 335,000 Students:

_ More than N18.5 billion has been paid to tertiary institutions as student loans, the Managing Director of the Nigerian Education Loan Fund (NELFUND), Mr. Akintude Sawyerr, has confirmed.

Mr. Sawyerr, who spoke on a TVC programme, said additional N5.5 billion has been paid directly to 115,000 students as pocket cash. He said the payments covered the fees and upkeep of the 335,000 students who have benefitted from the loan

initiative since its take-off last year. "Currently, we have disturbed N18.5 billion to institutions. They have received that amount of money in their accounts. The upkeep is paid monthly. We have distributed about N5.5 billion so far for students' upkeep."

PREMIUM TIMES, THURSDAY, JANUARY 2, 2025: Again, Nigerian Govt Reintroduces History into Education Curriculum: – The Nigerian government has announced the reintroduction of history as a subject in the basic education curriculum.

The Minister of Education, Dr. Tunji Alausa, disclosed this during a recent appearance on Channels Television programme.

Dr. Alausa said history, a vital part of nation building has been missing in the Nigerian education system for a long time, noting that the subject will now be taught in schools from 2025.

"We now have people up to 30year-old totally disconnected from our history. It doesn't happen in any part of the world," he said.

He said president Bola Tinubu has mandated that the subject be reintroduced into the curriculum.

PUNCH, FRIDAY, JANUARY 3, 2025: NUT Tells FG to Simplify Curriculum in 2025: – The Nigeria Union of Teachers has advised the Federal Government of Nigerian to simplify and clarify the ambiguous curriculum.

According to Secretary-General of NUT, Dr. Mike Ike-Ene, the curriculum should be geared towards making the learners productive and employers of labour, adding that any content outside of these should be removed.

Dr. Ike-Ene made this statement while suggesting key areas in the basic education sector that the government should prioritise in 2025. "One key area that requires attention is the curriculum. The government should reconsider the current approach, which is outdated and too rigid. It is too big. The focus should not solely be on preparing individuals for white-collar jobs but rather on empowering people to become employers. Therefore, the curriculum must be tailored to make individuals more productive and equip them with practical skills for the modern economy."

MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular.**

- 2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
- 3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
- 4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
- 5. No candidate can use the process to change any of the data already supplied to the Board.
- 6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
- 7. Please be guided for compliance.

Shortly thereafter, the Bureau of Public Service Reforms (BPSR) rated JAMB highly in its performance index using its Self-Assessment Tool (SAT). During an official visit to JAMB's National Headquarters in Bwari, Abuja, on March 19, 2024, BPSR Director-General Dr. Dasuki Arabi praised the Board for its commitment to efficient service delivery and acknowledged Prof. Oloyede's visionary leadership.

In response to the government's confidence in JAMB, the Board was tasked with combating the prevalence of fake degrees and certificates in the country. To enhance its efforts in this area, JAMB collaborated with relevant agencies, including the National Youth Service Corps (NYSC). In April 2024, this partnership was formalized to protect the integrity of tertiary education certificates, helping to identify fraudulent candidates seeking to participate in the NYSC scheme.

The year 2024 also marked a commitment to inclusivity, as JAMB announced a refund of registration fees for all candidates with disabilities and pledged to provide free Unified Tertiary Matriculation Examination (UTME) and Direct Entry (DE) forms for Persons with Disabilities (PWDs) to alleviate their financial burdens.

Recognition continued throughout the year, with the National Assembly, particularly the House of Representatives, commending JAMB for its rigorous examination processes and transparency regarding the Mmesoma matter. The Deputy Senate President further lauded the Board's unprecedented achievements, advocating for honors to be bestowed upon its leadership.

To sustain its high performance, JAMB adopted a new Performance

In a significant achievement, JAMB successfully conducted the 2024 UTME without any disruptions, including the foreign component of the examination held in eight countries in July 2024. Additionally, Prof. Oloyede's management introduced a novel initiative by allocating one billion naira to support the Renewed Hope Housing Scheme, aiming to assist staff with low incomes in securing housing and discouraging unethical practices.

The Board continued to promote excellence in admissions into tertiary institutions, consolidating the gains of the National Tertiary Admissions Performance Merit Award (NATAP-M), which recognizes compliance with admission guidelines. The fourth edition of the award, covering the 2021/2022 and 2022/2023 academic years, featured a cash prize pool of ₹710 million. The University of Ilorin emerged as the top institution, receiving a ₹500 million prize, while Ahmadu Bello University and Borno State University followed closely with cash prizes of ₹75 million and ₹25 million, respectively.

In a decisive move, JAMB declared that it would no longer accommodate illegal admissions through the "Condonement of Illegal Admissions without Registration Number," a practice that allowed the absorption of candidates who had been admitted illegally prior to 2017.

In a groundbreaking initiative, JAMB hosted the first-ever Africa Regional Conference on Equal Opportunity of Access to Higher Education (ARCEAHED) in Abuja from September 16-19, 2024. This conference aimed to advocate for the rights and inclusion of persons with disabilities in higher education across the African continent.

As part of its annual self-assessment, JAMB held its 2024 Annual Management Retreat from August 26-29, focusing on reviewing operational processes, including the 2024 UTME. This retreat aimed to identify challenges, develop strategies for improvement, and reinforce successful practices. Participants at the retreat recognized JAMB's exemplary service delivery and contributions to the education sector.

The year also saw numerous nominations and awards for JAMB and Prof. Oloyede, including the COEASU Legacy Award for Educational Advancement, the Hallmarks of Labour Honours, and the ICPC award for top-performing agency. Prof. Oloyede was also honored with the title of Kulliyan Sokoto by His Eminence, the Sultan of Sokoto.

Additionally, JAMB celebrated the success of its staff member, Mr. Jamilu Musa Jauro, whose project won the DG's Best Project award at the NISS Executive Intelligence Management Course, securing a prize of N15 million.

To further address the ongoing challenges of theft or missing Subscriber Identity Modules (SIMs), JAMB collaborated with the Nigerian Communications Commission (NCC) to provide customized SIMs for UTME/DE candidates for the 2025 registration cycle.

Overall, 2024 was a landmark year for JAMB, characterized by significant achievements, robust collaborations, and a steadfast commitment to enhancing the integrity and accessibility of higher education in Nigeria.

JAMB DATA MANAGEMENT: EFFICENCY AND ACCOUNTABILITY IN ACTION - LANRE APATA



In complying with the 21st-century global standards in the education and e-testing industry, the Joint Admissions and Matriculation Board (JAMB) has taken the bull by the horns in ensuring the security of personal data as it delivers on its mandate. This singular mindset has not only facilitated a commendable scorecard of data safety, transparency, accountability, but also the elimination of bias.

Remarkably, JAMB, as an examination body, has been a frontrunner in ensuring that data privacy ethics are strictly adhered to within the ambits of the data protection laws in the country.

The Nigeria Data Protection Act of 2023 is the country's legal framework guiding the collection, processing, usage and storage of data collected. Its objectives summarily protect the fundamental rights of data subjects while creating means of recourse and remedies in cases of data breach or violation; promote data processing practices while ensuring data controllers and processors fulfil their obligations to data subjects within the confines of the Act and under the watch of an effective regulatory Commission.

This background informs the Board's understanding and prioritization of data safety and responsible management. As an examination body tasked with the responsibility of overseeing admission into tertiary institutions in the country, data is

regularly collected from candidates registering for UTME, DE,

Part-Time, Distance Learning, Sandwich and National Open University for the purpose of admission. This sensitive and rigorous process is often heightened during the yearly UTME/DE registration exercise where the Board registers close to two million candidates every year.

In its bid to foster data integrity and centralisation, the Board mandated the use of the National Identification Number (NIN) for UTME/DE candidates in 2021. This has accelerated the elimination of multiple databases and the expansion of the country's identity database as candidates have to register for NIN before initiating the process of UTME/DE registration. It is also pertinent to add that this process has eliminated the laborious collection of fresh data, a process susceptible to falsification as some unscrupulous candidates attempt to alter their earlier-generated personal data. Consequently, the Board's insistence on the possession of a valid NIN as opposed to the collection of fresh data evidences the willingness of an organisation grounded in responsible data collection and management.

It is also noteworthy to mention that the Board's introduction of Profile Codes based on personalised telephone numbers, and the use of biometric verification for preexamination, examination and postexamination activities are deliberate measures put in place to authenticate the genuineness of users, safeguard data and eliminate fraudulent practices.

These technology-driven innovations have put the Board miles ahead of scammers in terms of ensuring compliance with data regulations as unauthorised access, which could engender legal issues with the regulator and data subjects is no longer an issue.

As an examination body that prides itself in the integrity of its processes, JAMB, under the leadership of Professor Is-haq Oloyede, has invested in world-class ICT infrastructure to protect the reliability and integrity of its e-testing process. On different occasions and fora, the Board has expressed confidence in the safety and security of candidates' results through the deployment of a world-class data storage system. This, over the years, has allayed the fears of the public and has demonstrated the Board's unwavering commitment to the development of the nation's tertiary education system.

With its sound understanding of regulatory sanctions and its responsibilities to young Nigerians, JAMB does not shy away from meting out appropriate sanctions on erring parties to avert breaches and unethical practices in data usage and management. A recent example is the Board's decisiveness in sanctioning an accredited CBT centre where a non-JAMB centre staff had retrieved a candidate's data for unethical use in Lagos State. In conclusion, JAMB accords data protection a pride of place in its processes as evidenced in its ethical, meticulous and professional collection, usage, and storage of data. This posture has endeared the Board to Nigerians as they increasingly throng the Board's headquarters for their data and assessment needs.
