BPWD PAYS COURTESY VISIT TO OSUN STATE OFFICE

As part of measures to boost public awareness on inclusive education in Osun State especially as it affects People With Disabilities (PWDs) in the education sector, business and corporate circles, the Bureau for People With Disabilities (BPWD), has paid a courtesy visit to the JAMB State Office, Osogbo.

The Executive Secretary of the Agency, Rotarian, Ayobami Oyewumi Oyetunde, who led a delegation of the agency to the State Office recently, said the purpose of the visit was to discuss salient matters as they affect candidates with disabilities and to seek partnership in prioritizing their

well-being, among others.

Mr. Oyetunde revealed that the agency was established in January this year upon the enactment of the Discrimination Against Persons with Disability (Prohibition) Law (2024). more partnership in making life better and conducive for PWDs. He also restated the readiness of the agency to offer necessary support as well as partner with JAMB in alleviating the challenges facing PWDs.

In his remarks, the Osun State Coordinator, Mr. Babatunde Jacob, lauded the Governor for setting up the agency. He highlighted the decree that set up JAMB and informed them about the establishment of JAMB Equal Opportunity Group (JEOG) by the Registrar, Prof. Is-haq Oloyede, in 2017. JEOG, he said is saddled with the responsibility of creating an inclusive environment for individuals with disabilities to participate in the UTME as well as ensure that they

have equal access to higher education.

The Coordinator disclosed that the JEOG Conference, which was held in 2024 was the first of its kind and titled: "Africa Regional Conference on Equal Opportunity of Access to Higher Education" with its theme as: 'Advancing the Potentials of Persons with Disabilities (PWDs) in Educational and Economic Development'. He also cited other specific interventions by the Board, which included: establishing specially-adapted centres for candidates with disabilities in Oyo, Osun and Kwara; full funding for their examination; full responsibilities for their feeding and accommodation along with their guides; payment of general transport supplementation

for them and their guides; appointment of proctors for them to read out questions during the exam; provision of equipment such as Braille slates and stylus for the blind as well as branded T- shirts, refund of fees for the application documents for candidates with 5 O' level credits; provision of standby medical personnel during examination, among others.

In his concluding remarks, the Executive Secretary used the opportunity afforded by the visit to solicit the Board's consideration to set up a specially-adapted centre for candidates with disabilities in Osun State adding that the Governor is willing and would be excited if this request could be granted by the Board.

JAMB DELTA OFFICE RECEIVES BAGS OF RICE FROM FGN

The Delta State Office of the Joint Admissions and Matriculation Board (JAMB), Asaba, was agog recently as members of staff of the facility received their share of the President Tinubu's Renewed Hope Agenda bag of rice at the controlled price of N40,000.

It would be recalled that the Federal Government had initiated the sale of 50kg bags of rice at a subsidized price of N40,000 per bag for public servants with duly-registered National Identification Number.

This initiative is a part of the larger efforts to cushion the effect of the prevailing high food prices on civil servants in Nigeria as well as ensure

food security.

The commendation was made recently when the President of the Union, Comrade Cole David, and his executives paid a thank you visit to the State Office recently.

The Council emphasised that the questionable Facebook account was opened with the aim of defrauding unsuspecting members of the public.

NECO's Acting Director, Information and Public Relations, Mr. Azeez Sani, who made this announcement in a statement said, "The Council wishes to draw the attention of the public to the existence of this fake Facebook account in order to avoid being swindled by the fraudsters." PREMIUM TIMES, SUNDAY, JUNE 1, 2025: Why Nigeria is Converting Science Schools to Technical Colleges- Official: - The federal government says it is converting Federal Science and Technical Colleges (FSTC) to full-fledged Federal Technical Colleges (FTC) to overhaul technical education in the country.

The Executive Secretary, National Board for Technical Education (NBTE), Idris Bugaje, who disclosed this in an interview in Abuja said the reform was part of a broader

strategy to reposition Nigeria's Technical and Vocational Education and Training (TVET) sector as a viable and attractive pathway for youth employment and economic development.

According to him, the transition will begin in September, marking the start of a new admission cycle that will exclude science-based enrollments. He added that students already in the system would be allowed to complete their studies, but going forward, all new admissions would be strictly for technical education... Head of WAEC national office in Nigeria, Dr. Amos Dangut, tendered the apology on Monday, as he appeared before the House of Representatives Committee on Basic Education and Examination bodies, admitting logistical breakdowns, which he said were triggered by a last-minute question paper reprint due to leaks, forcing Nigerian candidates to sit for English Language papers as late as 9 p.m.

According to the examination body, internal printing press was operating at just 50 percent capacity, making it to opt for external vendors, an action he explained unfortunately compromised the process...

The Registrar, while speaking during the Education Writers' Association of Nigeria (EWAN) dialogue series with the theme: "CBT for SSCE: Is Nigeria Ready?" held virtually, disclosed that there were more than 2,000 CBT centres across the country, aside from National Open University CBT centres in all the states and some local councils...

Director of Senior Secondary Education, Hajia Binta Abdulkadir, in her remark, said the examination bodies, which include the West African Examinations Council (WAEC), have all it takes to conduct CBT exams...

She disclosed that a committee called Improvement of Public Examinations in Nigeria, headed by Registrar, Joint Admissions and Matriculation Board (JAMB), Prof. Is-haq Oloyede is working on such issues and will deliver the report soon.

VANGUARD, TUESDAY, JUNE 3, 2025: Minister Pledges Inclusivity, Fairness in CBT Rollout for WAEC, NECO: - The Minister of State for Education, Prof. Suwaiba Ahmad says no student whether in the urban or rural communities will be left behind in the Computer-Based Test transition.

Prof. Ahmad was speaking during the monitoring of the West African Senior School Certificate Examination (WASSCE) in some selected schools in Abuja.

"We will not roll out CBT in a way that excludes any student. Every child will have the opportunity to write their examination, regardless of location or infrastructure."

"Nigerians should bear with us. We are taking all concerns seriously, and by the time CBT is fully rolled out, no child will be put at disadvantage,"

she assured.

PUNCH, TUESDAY, JUNE 3, 2025: 2025 WASSCE English Language Examination Not Cancelled Says WAEC: - The West African Examinations Council, Nigeria, has debunked claims that the English Language paper written during the ongoing West African Senior School Certificate Examination for School Candidates, 2025, has been cancelled.

A viral press release, dated Friday, May 30, 2025, and circulated widely on social media platforms, falsely claimed that the May 28 English Language examination had been cancelled and that a new date would be announced.

However, in a statement issued on Tuesday, WAEC described the release as fake and the work of "mischief-makers." "The management of the West African Examinations Council would like to state that the press release being circulated did not emanate from the council. "The said examination has not been cancelled," the statement signed by the Acting Head of Public Affairs, Moyosola Adesina, read.

PUNCH, TUESDAY, JUNE 3, 2025: 150 Varsities, Polytechnics Ignore FG Order to Publish Budgets: - No fewer than 150 federal universities, polytechnics and monotronics have missed the May 31, 2025 deadline of the Federal Government to all tertiary institutions to update their website with key institutional data, including financial records.

Recall that, in April 2025, the FG asked all vice-chancellors of federal universities, rectors of polytechnic, and provosts of other institutions to, no later than May 31, 2025, publish their Annual Budgetary Allocation, Research Grant Revenue (Previous Year), TETFund Allocation (Current

Year), Endowment Fund (Previous Year) and Total Student Population (Undergraduate and Postgraduate)...

The Minister of Education, Dr. Tunji Alausa was then quoted in a statement by the ministry's Director of Press and Public Relations, Mrs. Boriowo Folasade, as stating that the move aimed to entrench transparency, accountability, and good governance in Nigeria's tertiary education system in line with global best practices.

GUARDIAN, WEDNESDAY, JUNE 4, 2025: FG Clamps Down on Varsities Operating Unapproved Satellite Campuses: The Federal Government said it will impose tough sanctions on any federal university that establishes a satellite campus without approval of the Minister of Education.

The Minister of Education, Dr. Tunji Alausa disclosed this in a memo sent to the National Universities Commission (NUC) on May 30, 2025. According to Dr. Alausa, the decision is borne out of the federal government determination to restore the quality and integrity of tertiary education in the country.

He directed the NUC to inform all federal universities that no satellite campuses be established without prior approval of the ministry through the Executive Secretary of the commission. He said that failure to comply would attract sanction.

"There has been noticeable and concerning trend of federal universities establishing satellite campuses across the country. Many of these campuses are created without clear strategic, academic or infrastructural justifications. "This practice undermines the integrity, quality and sustainability of tertiary education in Nigeria," the minister noted.

GUARDIAN, THURSDAY, JUNE 5, 2025: Don Urges NUC to Incorporate Virtual Space for University Accreditation: -

A university teacher, Prof. Ibrahim Olateju, has called on the National Universities Commission (NUC) to incorporate virtual space as a criterion for programme accreditation in Nigerian universities. Prof. Olateju, from the Department of Management Technology, Lagos State University (LASU), said this would ensure that institutions are effectively equipped to offer and manage online and hybrid learning environments.

Prof. Olateju, in his lecture titled: 'Balancing innovation and stability in project quality management: The roles of challengers and defenders for sustainable development,' said the commission should integrate virtual spaces as one of the criteria for programme accreditation in tertiary institutions...

"The practice of using a specified calendar for one-off examinations as the primary method of student appraisal should be discouraged. Instead, a more holistic assessment approach should be adopted," he said.

GUARDIAN, THURSDAY, JUNE 5, 2025: FG Unveils Quality Assurance Scheme for Secondary Schools: -

The Federal Government, through the National Senior Secondary Education Commission (NSSEC), has unveiled a nationwide quality assurance monitoring and evaluation scheme designed to transform the sub-sector.

The initiative aims to improve the quality of secondary education in line with the ongoing reforms in the sector. The initiative stemmed from concerns by stakeholders about the poor quality of students graduating from secondary schools who, invariably, will proceed to tertiary institutions.

The national assessment programme was formally flagged off at the Federal Government College, Malali, Kaduna, signalling the beginning of the campaign to improve learning environments, teachers' performance, and students' outcomes...

Speaking at the event, NSSEC Executive Secretary, Dr. Iyela Ajayi, described the initiative as a strategic tool needed to achieve the renewed hope agenda of President Bola Tinubu's administration, which prioritises human capital development through quality education...

LEADERSHIP, THURSDAY, JUNE 5, 2025: Summit University, Offa Gets Full NUC Accreditation for 6 Programmes: - The National Universities Commission (NUC) has approved full accreditation for six academic programmes of the Summit University, Offa, Kwara State.

The six programmes that underwent assessment by the NUC expert panels and were granted full accreditation status for the next five years are: Microbiology, Biochemistry, Computer Science, Accounting, Business Administration and Political Science.

In a statement by the national publicity secretary of the Ansar-ud-Deen Society of Nigeria, Dr. Sola Hassan, the society congratulated the faith based university on its achievement, saying, "This achievement reflects Summit University's strong academic structure, highly qualified faculty, state-of-the-art facilities, and dedication to upholding national and global standards in higher education.

DAILY SUN, TUESDAY, JUNE 3, 2025: WASSCE 2024 Examination Fraud: WAEC Warns KC, CMS, 106 Others, Derecognises 9 Schools: – The Nigeria Examinations Committee (NEC) of the West African Examinations Council (WAEC) has taken drastic actions against 118 public and private schools for alleged examination malpractices.

The NEC at the end of their meeting issued serious warning to 109 secondary schools and derecognized nine others for examination malpractices during the May/June 2024 West African Senior School Certificate Examination (WASSCE).

"The Nigeria Examinations Committee investigated various reported cases of examination malpractice and consequently decided to warn/derecognize the following schools for examinations malpractice, Oluju, L.O, senior deputy registrar stated.

Some of the schools issued warnings include Kings College, Lagos, CMS Grammar School, Bariga, Igbobi College, Yaba, Baptist Girls Academy, Obanikoro, Lagos State Model Senior College, Kankon, Whitesands School, Lekki, Vetland Senior Senior Grammar School, Ifako-Ijaiye, Keke Senior High School, Solomon Grace Secondary School, Abule-Egba...

A breakdown revealed that of the nine schools derecognized, two are state-owned schools and seven are privately-owned schools.

The nine derecognized schools did not present candidates for the ongoing May/June 2025 WASSCE. The candidates were taken to other schools to write the school examination.

VANGUARD, TUESDAY, JUNE 3, 2025: Examination Malpractices: Parents, Guardians Found Wanting'll Henceforth be Prosecuted- FG: – Parents and guardians found complicit in examination malpractices will henceforth be prosecuted, the federal government has warned. This came as the government directed all schools to immediately report any threats or breaches of examination conduct to law enforcement and the relevant educational authorities.

Minister of Education, Dr. Tunji Alausa, who said this in a statement, condemned the assault on the Vice Principal of Complete Child Development College, Akure, Ondo State, by thugs allegedly hired by the parents of a student caught cheating during an examination.

Dr. Alausa stated that any student found engaging in malpractice would be sanctioned by national examination guidelines.

In the statement issued through the Director of Press and Public Relations of the Federal Ministry of Education, Mrs. Boriowo Folasade, the minister reaffirmed the Ministry's zero-tolerance stance on examination malpractice, intimidation of school personnel, and all unethical conduct by students, parents, or guardians.

The statement reads in part: "The Federal Ministry of Education strongly condemns the unfortunate incident that occurred at Complete Child Development College, Aule, Akure, Ondo State, where suspected thugs, allegedly hired by the parents of a student, assaulted the Vice Principal, Mr. Rotifa, for performing his lawful duty of upholding the integrity of the ongoing West African Senior School Certificate Examination (WASSCE)..." VANGUARD, THURSDAY, JUNE 5, 2025: Examination Fraud: Enugu Priests Supporting Malpractice Risk Suspension: – Any Catholic priest or religious leader found to have overtly or tacitly supported examination malpractice in Enugu State now stands the risk of losing his or her faculty to operate as a clergy or religious.

The Catholic Bishop of Nsukka Diocese, Most Rev. Godfrey Igwebuikwe Onah, read the riot act while speaking about how to make the nation's education sector free from irregularities.

Most. Rev. Onah said, "As a church, we want to contribute to making our society better. We cannot all complain that things are bad while we ourselves are doing evil things. "If parents are not ready to allow us to train their children as Catholic students or pupils, they should enrol them elsewhere..."

MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
7. Please be guided for compliance.
