A total of 200,115 candidates initially expressed interest in participating; however, two candidates were withdrawn, resulting in 200,113 registered

DECOY WEBSITES: JAMB TO SANCTION 180 CANDIDATES FOR EXAMINATION INFRACTIONS

The Joint Admissions and Matriculation Board (JAMB) has announced its intention to sanction candidates who have engaged with and financially supported decoy websites established by the Board itself. In a proactive move to combat the unscrupulous activities of examination fraudsters, JAMB created these decoy websites to redirect traffic away from fraudulent sites operated by malicious individuals seeking to exploit desperate candidates looking for shortcuts to

success. Candidates who patronize these deceptive platforms, particularly during the 2025 Unified Tertiary Matriculation Examination (UTME) and Direct Entry admission process, will be considered equally culpable of attempting to engage in examination malpractice and will face penalties in accordance with existing regulations.

During a press conference on Thursday, April 10, 2025, after a monitoring visit to a Computer-Based Test (CBT) centre in

BVROs KEY TO THE WAR AGAINST MALPRACTICE - JAMB REGISTRAR

As the 2025 Unified Tertiary Matriculation Examination (UTME) draws closer, the Biometric Verification Registration Officers (BVROs) of the Board have been enjoined to see their responsibilities as crucial to the success of the fight against examination malpractice.

The Registrar, Joint Admissions and Matriculation Board (JAMB), Prof. Is-haq Oloyede, stated this at a virtual training for BVROs recently.

The Registrar, who spoke through the Chairman, Chief Technical

Advisors (CTAs), Prof. Bashir Galandanci, charged BVR Officers to be vigilant, diligent and exercise high level of professionalism to detect any forms of examination infractions in the upcoming UTME.

He advised them to work closely with their Technical Officers (TOs) to achieve a seamless examination noting that they are the eyes of the Board in all the centres as staff of the board.

He reminded these critical stakeholders in the conduct of the UTME to adhere strictly

candidates. Of those registered, 73,844 candidates were absent on the day of the examination, and 88 candidates failed the biometric verification screening. Consequently, 126,181 candidates successfully sat for the examination, and results for 115,735 of these candidates are now available for viewing. Additionally, 10,446 results are still being processed and will be released soon. The Board acknowledges the delays

experienced by some candidates during the examination and regrets any inconvenience caused. These challenges are anticipated due to the new features implemented to enhance the overall conduct of the main UTME. JAMB appreciates the support of candidates and parents in facilitating a smoother process. The mock examination serves as a trial version of the UTME, allowing the Board to test new innovations while helping candidates familiarize themselves with the CBT

environment. Over the years, this initiative has successfully achieved its objectives, addressing noted lapses and equipping candidates with valuable experience for the main examination. LEADERSHIP, SUNDAY, APRIL 6, 2025: Bauchi Education Ministry to Train JAMB Students: – Bauchi State Ministry of Education has announced plans to commence JAMB Computer-Based Test (CBT) training for all students sponsored by the state government. The training aims to equip them with the skills to excel in all examinations supported by the state government.

The Commissioner for Education, Dr. Lawal Mohammed, who revealed this, stated that the training was part of the government's broader efforts to enhance students' academic performance...

"Education remains a top priority for the Bauchi State government under the leadership of His Excellency, Governor Bala Abdulkadir Mohammed and the Ministry of Education is committed to ensuring the success of all students," the commissioner stated.

PUNCH, MONDAY, APRIL 7, 2025: HND/Degree Dichotomy Won't Affect NIPOGA-Minister: – The Federal government's plan to streamline the university degree with the Higher National Diploma being awarded by polytechnics will not affect the Nigeria Polytechnics Games, the Minister of Education, Dr. Tunji Alausa has said.

Speaking at the opening ceremony of the 22nd Nigeria Polytechnics Games themed, "Ijakadi 2025" holding at the Federal Polytechnic, Offa, Kwara State, Dr. Alausa said that despite the Federal Government's efforts to streamline HND/University Degree dichotomy, the polytechnics games would continue to hold.

The minister whose speech was delivered by the Director Polytechnic and Allied Education, Federal Ministry of Education, Dr. Ejeh Usman, said, "We will still have polytechnics... Some polytechnics that like to award

degrees could apply for it and if they are accredited by the National Universities Commission and the National Board for Technical Education, it's a dual mandate..."

THE CABLE, MONDAY, APRIL 7, 2025: Federal Tertiary Schools Ordered to Publish Financial Data by May 31: – The federal government has ordered the management of federal higher institutions to publish their financial data and academic capacity before May 31, 2025.

Dr. Tunji Alausa, the Minister of Education, said all vice-chancellors, rectors, and provosts must provide their annual budgetary allocation, including their personnel costs, overhead costs, and capital expenditure.

The Minister communicated this directive in a statement signed by Mrs. Boriwo Folasade, the ministry's spokesperson.

The directive further mandates them to publish the total value of

their endowment fund as recorded at the end of the previous year the statement reads in part. "This figure, which reflects funds donated or invested for the institution's long-term financial health, must be updated quarterly to ensure transparency." Also in Premium Times, Sunday, April 6, 2025

JAMB's Director of Finance, Mr. Mufutau Bello disclosed this during a meeting to assess the Board's readiness for the mock examination and the main UTME. He stated: "The Mock exercise is the first phase of our core mandate, and we must, as always, distinguish ourselves. Malpractices: - The Joint Admissions and Matriculation Board Registrar, Prof. Is-haq Oloyede, has said the body has deployed a decoy website to apprehend candidates seeking to cheat in the 2025 Unified Tertiary Matriculation Examination Mock examination. Prof. Oloyede disclosed this during a press briefing while monitoring the exercise at a CBT centre in Bwari, Abuja, the nation's capital. He expressed concerns that some candidates patronise rogue websites to cheat in the exam, adding that JAMB has also opened a decoy website targeting such individuals.

Prof. Oloyede said, "We need to let the students know that the best way to pass the examination, UTME in particular, is to study. We are aware of some rogue websites asking people to come and pay so that they can help. It cannot work. We have also opened our own rogue website. As of this morning, about 180 students have paid.

"Some of them are paying N30, 000 for something that will never work. And to some, when I look at those who have paid us this

money, I smile. We have about 180 of them. And we are going to deal with them firmly. We are going to cancel their results, both UTME and DE he added." Also in Daily Post, Thursday, April 10, 2025

Varsities Get FG's Waiver for

Staff Recruitment: - The Federal Government has lifted restrictions on employment in federal tertiary institutions, granting a waiver for staff recruitment through the Federal Ministry of Education.

The announcement of the waiver

followed a ban placed on public employment by former President Muhammadu Buhari. A statement by the Director of Press, FME, Folasade Boriowo, said institutions are mandated to submit their manpower needs to the committee on waiver and recruitment of the ministry for review.

"The honourable Minister of Education, Dr. Maruf Tunji Alausa, has directed all federal tertiary institutions that have been

granted waivers to recruit staff to publicly advertise the available vacancies in at least one national daily newspaper, on their respective websites, and in other relevant academic and professional journals. This directive aims to ensure a transparent, open, and competitive recruitment process that offers equal opportunity to all eligible Nigerians."

PREMIUM TIMES, SUNDAY, APRIL 6, 2025: ICPC Re-Arraigns Professor for Awarding Illegal Degrees: - The Independent Corrupt Practices and Other Related Offences Commission (ICPC) has re-arraigned Godwin Igbinoba, a professor, on degree peddling and forgery charges.

According to a statement shared by the anti-corruption agency posted via its X handle on Thursday, Mr Igbinoba was arraigned before trial judge A. N. Erhabor of the Edo State High Court in Benin City.

He pleaded not guilty to the three counts instituted against him.

The commission accused the don of unlawful award of academic degrees to members of the public via the Association of Professional Examination Board and the Association of Corporation of Chartered Secretaries, Benin City.

Mr. Igbinoba was reportedly involved in a scheme that issued Bachelor of Science Degrees and National Diplomas without the necessary approvals from the key regulatory authorities like the Federal Ministry of Education, the National Board for Technical Education, or the National Universities Commission.

The statement added that Mr Igbinoba faces another charge of forgery of a National Youth Service Corps (NYSC) Exemption Certificate, dated 12 March 2018, which he allegedly presented to one Osian Jude Tony. The commission said the act constituted an offence under section 465 of the Criminal Code Act.

LEADERSHIP, MONDAY, APRIL 7, 2025: Fedpoly Bauchi Installs CCTV Cameras to Curb Examination Malpractice, Security Breaches: - The Federal Polytechnic, Bauchi, has installed Closed-circuit Television (CCTV) cameras in select examination halls to combat examination malpractices and improve campus security.

Rector of the institution, Alhaji Sani Usman, disclosed this during the 2025 resource inspection and accreditation visit by the National Board for Technical Education (NBTE) recently.

He said: "We've installed cameras in key classrooms, leveraging solar inverters now available in many of our halls.

"Additionally, we're finalising a TETFund-supported research project from the last two years, which will allow us to expand CCTV coverage beyond classrooms to outdoor areas..."

The New York State Police say Prof. Rajiv Narula, 45, a former longtime chemistry professor on the St. Lawrence County campus, was arrested on Tuesday and charged with eight counts of bribery. The chemistry teacher allegedly accepted monetary bribes from students in exchange for higher grades.

According to court documents, Prof. Narula is accused of taking money from eight students in exchange for higher grades. The bribery allegedly happened during the spring, summer and fall semesters of 2021 and again during the 2022 spring semester.

VANGUARD, THURSDAY, APRIL 10, 2025: Student Loan: NELFUND Threatens Legal Action Against Institutions Engaging in Deceptive Practices: – The Nigerian Education Loan Fund (NELFUND) has threatened legal action against institutions found to be engaging in deceptive practices within the student loan scheme.

The threat is coming on the heels of recent findings that some institutions, after receiving student loan disbursements directly into their accounts, failed to notify the affected students or reflect the payments in their school fee records.

Some institutions were found to have failed to inform students of loan disbursements made on their behalf while still demanding payment of institutional fees from the same students. Reacting to the development in a statement he signed yesterday, the Managing Director and Chief Executive of the NELFUND, Mr. Akintunde Sawyer warned institutions against withholding student loan disbursement information. Describing the act of withholding financial information from students as not only unethical but also a direct violation of the principles upon which NELFUND was established.

Bwari, Abuja, JAMB Registrar Prof. Is-haq Oloyede emphasized the Board's commitment to addressing examination malpractice. He highlighted that the decoy websites serve as traps designed to reduce the growing incidence of fraud and corruption among the nation's youth. Prof. Oloyede reiterated that JAMB is legally mandated to regulate the UTME and Direct Entry admissions while ensuring that only qualified candidates are placed in tertiary institutions.

Prof. Oloyede revealed that, as part of the ongoing sting operation, JAMB has identified no fewer than 180 candidates who have paid amounts ranging from N30,000 and above to these fraudulent sites in exchange for non-existent services, such as "leaked examination items" and score augmentation. These candidates will face sanctions that may include the cancellation of their UTME and Direct Entry results, as well as potential legal prosecution.

The Registrar reaffirmed the Board's

unwavering commitment to tackling examination malpractice and noted that the strategy of launching decoy websites is proving effective. He reiterated JAMB's zero-tolerance policy towards examination fraud and cautioned candidates against engaging with fraudulent platforms that promise unrealistic success.

Additionally, Prof. Oloyede expressed JAMB's dedication to enhancing the UTME process through the continuous implementation of innovative measures. He described the recent Mock-UTME examination as a vital testing ground for the Board's latest strategies and innovations in preparation for the main UTME set to commence on April 25, 2025.

"Besides providing candidates with an opportunity to familiarize themselves with the examination environment, the mock exercise allows us to evaluate the effectiveness of newly introduced measures aimed at improving examination conduct and security.

Each year, as we implement new strategies to combat examination malpractice, fraudsters also adapt their tactics. Therefore, we must consistently stay one step ahead," he stated.

Prof. Oloyede also took the opportunity to remind the media that the UTME is not a school-based examination. He urged educational institutions to abandon the pursuit of "high-score glory" and encouraged students to focus on their studies, as this is the only true path to success in the examinations. Over 126,000 candidates participated in the 2025 Mock-UTME across more than 800 accredited Computer-Based Test (CBT) centers nationwide.

MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
7. Please be guided for compliance.

2025 UTME: WE'RE SET FOR 2025 UTME- CTA, AKWA IBOM



The Akwa Ibom State Chief Technical Advisor (CTA), Prof. Uyinomen Ekong, has reiterated the State's readiness for the forthcoming 2025 Unified Tertiary Matriculation Examination (UTME).

Speaking to JAMBulletin at the Pastor Patience Umo-Eno ICT Centre, located at the Nsit Ubium Local Government Council Headquarters on Thursday, 10th April, 2025, while monitoring the just-concluded 2025 Mock-UTME, she submitted that Akwa Ibom State is set for the examination, stressing that most of the Computer-Based Testing (CBT) centres in the State are top-notch with state-of-the-art facilities.

Explaining further, she said, generally speaking, there was no CBT centre out of those she had

visited so far presenting any challenge.

"So far, we have visited four centres and there has not been any technical challenge in any of these centres aside the general nationwide biometric verification issue that affected everyone.

"We have done all that is necessary except for unforeseen circumstances, hence, we're set for the examinations in the State. We are still on our way to other centres, so far the process has been very smooth, the only centre with generator problem has been addressed," she disclosed.

While talking about improving the process for better service delivery, Prof. Ekong cited the need for the Board to revive its practice of keeping at least, a back-up server close by in case of any eventuality, noting that in

the mock examination, there was no provision for such in Akwa Ibom State. Furthermore, she urged the Board to consider starting its examination processes earlier, particularly with regard to the training of examination officials to speedily resolve other crucial matters revolving round innovations that might require testing and modifications. She stressed the need for double checking the systems, especially the servers and the Biometric Verification Machines (BVM) for effective service delivery.

She noted the need for improvement to the helplines, saying the lines were not responding when reached out to for technical assistance.

In her remarks, the JAMB Akwa Ibom State Coordinator, Mrs. Grace Olimah-William, expressed optimism especially with respect to the earlier experienced challenges, saying, all would work out fine.

In her words, "Mock examination is not only meant to familiarise candidates with the CBT environment but is also meant to test the examination delivery system ahead of the main UTME. The experienced challenges were anticipated and I assure our candidates that such an occurrence won't recur during the main UTME while we regret the inconveniences caused them by the experience." She concluded.

BE A VEHICLE OF GROWTH TO YOUR HOST COMMUNITY, DADA URGES EKITI POLY

The Ekiti State Coordinator of the Joint Admissions and Matriculation Board (JAMB), Mr. Olukayode Dada, has urged the Ekiti State Polytechnic, Isan-Ekiti, to be a vehicle of socio-economic growth in its host community.

This was part of his discussion with the Rector of the institution during his courtesy visit to the polytechnic on Thursday, 27th March, 2025.

According to Dada, he paid the visit to the Rector to encourage the institution on the need to establish a Computer-Based Test (CBT) centre

in the polytechnic. This, he said, would not only boost revenue generation of the school but also be a vehicle for promoting the socio-economic growth of its host community.
