## CANDIDATES' DATA MISMATCH AT CBT CENTRES

The Joint Admissions and Matriculation Board (JAMB) has discovered that 132 out of the 887 approved Computer-Based Test (CBT) centres have reported discrepancies in the data of one or two of their candidates. In response to these findings, the affected centres have been sanctioned

after thorough investigation and queries. Although the number of discrepancies is relatively small (200 out of 2,030,627), it remains unacceptable to the Board. The candidates who inadvertently confirmed incorrect data are also held accountable for this oversight.

## INSTITUTIONS MUST PRIORITIZE RESULTS VERIFICATION

The Joint Admissions and Matriculation Board (JAMB) has observed that some institutions are failing to verify the results used for admitting candidates, particularly those seeking direct entry.

One of the fundamental purposes of the screening process is to ensure that only

legitimate documents are used to consider and accept candidates for admission and registration. It is crucial for institutions to understand that this responsibility lies primarily with them.

JAMB initiated the Nigeria Integrated Post-Secondary Education Data System (NIPEDS) approximately two years ago

### ...JAMB An Agency Managed By Courage and Transparency - Prof. Haruna

JAMBulletin, Prof. Haruna shares his vision for the CVCNU, recounts his inspiring journey from humble beginnings to academic prominence, and offers valuable insights for Nigerian youth. He addresses topics such as the 16-year age entry limit for university, parental influence on course selections, and significant advancements in JAMB, among other engaging issues.

#### VISION FOR CVCNU:

The erudite scholar expressed his intention to leverage over three decades of experience in the Nigerian university system to revitalize the CVCNU. He stated, "My vision is to transform the CVCNU Secretariat into a hub of knowledge and advocacy that will influence policy decisions and actions within Nigerian universities. My mission is to enhance and expand the existing programs of the Secretariat while initiating projects that will provide meaningful benefits to our members."

He further emphasized his commitment to inclusivity, diversity, and equity within the Secretariat, ensuring that all voices are represented in decision-making processes. "Fostering a culture of collaboration and mutual respect is essential for achieving the Committee's goals and maintaining its status as a leading voice in higher education policy-making," he added.

#### JOURNEY TO STARDOM AND LESSONS LEARNED:

Prof. Haruna highlighted the importance of understanding his background to appreciate his perspective. He shared his humble beginnings, recounting his journey from a poor rural setting to primary school, his aversion to medical studies, and his passion for the arts, history, and languages influenced by the culture of the Lake Chad region.

"I can summarize my life's story in these few words: 'A LIFE LIVED UNDER THE GRACE OF GOD'—translated in Hausa as 'ALHERIN ALLAH,'" he reflected.

He advised parents against imposing specific career paths on their children, emphasizing the

importance of allowing them to choose their own paths.

His journey took a pivotal turn after secondary school when he remained in Maiduguri due to financial constraints and worked as a shoeshiner (a cobbler). A chance encounter with a supervisor at the Maiduguri General Post Office led to a life-changing opportunity.

At that time, she worked as a Supervisor at the Maiduguri General Post Office. She paid for the work I did, but I knew that what she paid was in excess, so when she returned to her office, I followed her and returned the excess coins. She was bewildered by my action, and she asked me: "Why did you return these few coins when I did not even know that what I paid you was above what I should pay?" I replied, "My mother had taught me a vital lesson in life that it is better to beg than to steal. There is no dignity in being a thief no matter the amount of money involved or the quantity of the items stolen." "At the end of this conversation, the Lady asked me to see her the following day in her office, though she did not tell me the reason why. I went home that evening in immensely happy, thinking that when I returned the next day, I would have more shoes to mend and more money. Alas, when I returned the next day, the Lady asked me whether I had ever gone to school. I responded in the positive, so she said, "Why were you doing the job of a shoeshiner rather than doing a regular job?" I told her that I had nobody to help me. She then invited me to her office to write an application for a job in the Post Office. I wrote the application, and that day, I was employed as a Postal Staff-in-training, and my job was to sell stamps and postal orders".

"This marked the beginning of my second journey in life," he recounted.

"Imagine if I hadn't returned those coins; I may never have received that job offer, and my path to education could have been drastically different. Honesty pays, and today's youth must understand the importance of integrity in all their endeavors, whether as students, teachers, or professionals."

16-YEAR-OLD AGE LIMIT FOR UTME

#### CANDIDATES:

Prof. Haruna addressed the rationale behind the 16-year age limit for university candidates, asserting that it is based on research and expert recommendations. "The government and educationists must have carefully considered this limit, so we should rely on their guidance to prepare Nigerian children for their future roles in society," he stated.

#### ASSESSMENT AS A STAKEHOLDER:

Reflecting on his involvement with JAMB, Prof. Haruna noted, "I have been and continue to be a stakeholder in JAMB-related activities. For instance, during my tenure as Vice Chancellor of the Federal University Gashua, I served as the Chief External Examiner for JAMB in the state."

He praised the resilience of JAMB under challenging circumstances, highlighting the Registrar's commitment to overcoming obstacles. "The Registrar views challenges as opportunities and ensures that he surrounds himself with capable individuals who are empowered to succeed. He prioritizes the welfare and security of staff, reinforcing their value to JAMB."

Prof. Haruna likened this supportive environment to the slogan of a well-known bank: "While they say 'My Bank and I,' we can say 'MY JAMB and I.'"

#### OLOYEDE: A GOAL-GETTER:

He lauded the Registrar's extensive academic background, cultural awareness, emotional intelligence, and dedication to public service. "Oloyede's comprehensive understanding of higher education challenges and opportunities, coupled with his diverse experiences, makes him a remarkable leader," he noted.

On a scale of 1 to 10, Prof. Haruna confidently rated Oloyede a 9, underscoring his belief in the Registrar's capabilities and contributions to the educational sector.

#### Education Ministry to Strengthen Safety Measures in Unity Schools:-

#### Against Proliferation of Universities:-

Dr. Olatunji Alausa, Minister of Education, has urged lawmakers to halt the excessive establishment of new Universities, warning that the Federal Government is under increasing pressure to overhaul Nigeria's education system.

Dr. Alausa made the call while featuring at the ongoing Ministerial Press Briefing series organised by the Federal Ministry of Information recently in Abuja.

Dr. Alausa emphasised the need to strengthen existing institutions rather than focusing on the creation of new ones. According to him, pushing for more universities without enhancing the capacity of existing ones places undue pressure on the president.

"We must prioritise improving our institutions instead of constantly advocating for new universities. The National Assembly is passing a significant number of bills almost 200 at the moment and this trend cannot continue", he said. Also in The Sun, Thursday, March 13, 2025.

## 2025 DE APPLICATION: REGISTRATION CLOSES IN APRIL - ADEBIYI

The Gombe State Coordinator of the Joint Admissions and Matriculation Board (JAMB), Mr. Johnson Adebisi, has urged candidates to be aware of the necessary qualifications required for the ongoing 2025 Direct Entry (DE) registration.

During a meeting with Desk Officers on Monday, March 10, 2025, Adebisi presented the guidelines for the 2025 DE registration at the State Office in Gombe. He emphasized the importance of adhering strictly to all directives regarding the registration

exercise.

According to Adebisi, all prospective candidates must provide details of their previously obtained A'level qualifications, including registration/matriculation numbers, courses studied, qualifications obtained, grades received, and the names of the awarding institutions.

He further noted that for statements of result, only those not older than three years will be accepted for DE registration.

Adebisi advised registration officers to be diligent in their interactions

with candidates and to consult relevant advisories whenever they are uncertain.

Additionally, he highlighted that the registration exercise, which commenced on March 12, 2025, will close on a date to be announced in April 2025. He encouraged prospective candidates to take full advantage of this registration period, stating, "Similar to the 2025 Unified Tertiary Matriculation Examination (UTME), there will be no extension after the closure of this exercise."

### **MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES**

**This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.**

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.

## ...Nigeria Association of the Blind Calls for Solutions in Mathematical Graphics for the Blind

solutions to these challenges would significantly benefit the blind community in Nigeria, as the mathematics requirements for university admissions have hindered many blind students from pursuing their academic aspirations.

He stated, "We sincerely appreciate the Board's ongoing efforts toward fostering inclusivity, particularly through the establishment of the JAMB-Equal Opportunities Group (JEOG). Your commitment to providing fair examination conditions for students with disabilities is commendable and has positively impacted many blind students seeking access to higher education." However, he highlighted a persistent challenge: "Mathematics, as it is traditionally taught and assessed in Nigeria, heavily relies on visual elements such as graphs, diagrams, and complex spatial reasoning, which pose considerable difficulties for blind students. While some adaptations exist, they remain largely inadequate, leading to a disproportionate disadvantage for blind candidates. Consequently, many blind students, despite excelling in other subjects, find their academic aspirations curtailed by this rigid requirement."

To address these issues, the NAB president proposed several recommendations aimed at ensuring equal access for blind students. These include:

**Alternative Assessment Methods:**

**Introducing adaptive testing methods,** such as verbal reasoning or tactile-based mathematical assessments, to accommodate the learning needs of blind students. **Course-Specific Waivers:** Advocating for a waiver or substitution policy that allows blind students to pursue their academic interests without undue restrictions, especially in university programmes that do not require mathematics as a core skill.

**Enhanced Accessibility:** Improving accessibility in teaching and examinations by collaborating with institutions and disability-focused organizations to develop more inclusive teaching methods, instructional materials, and assistive technologies for blind students studying mathematics.

**Representation on JEOG:** Requesting that the current leadership of NAB be included in JEOG to replace the former president who is currently on the committee.

**Intervention in Programme Transfers:** Urging the Board to intervene in cases where candidates are transferred from their chosen programs to education.

Onyebuchi expressed confidence in the Board's leadership and its commitment to inclusivity, believing that it can help remove barriers and create a more equitable admission process for special needs students, allowing them to achieve their full academic potential alongside their

sighted peers.

In response, the Registrar thanked the NAB delegation for their visit and noted that two NAB members already serve on the JAMB-JEOG. He reaffirmed JAMB's commitment to partnering with NAB to advocate for the best outcomes for blind students. Regarding the request for solutions to the challenges faced by blind students in mathematics, the Registrar acknowledged their plight and suggested that JEOG be tasked with exploring potential solutions. He also encouraged NAB officials to investigate how similar challenges are addressed in other regions to inform the Board's approach.

He urged NAB to submit its proposals to JEOG, which comprises over 30 experts in special education, for consideration. "What I can do is recommend to JEOG the importance of this matter. It is a group of individuals with the expertise needed to find solutions by examining practices elsewhere and advising us accordingly," he stated.

Concerning the NAB's concerns about changes in representation on JEOG, the Registrar explained that the Board periodically reviews its membership and advised NAB to have the former president resign to allow the current president to take their place.

Regarding program changes, the Registrar assured that no institution can make changes without the candidate's consent and promised that JAMB, through JEOG, would continue to provide the necessary interventions to ensure equal opportunities for all candidates without discrimination.



## FCC REAFFIRMS COMMITMENT TO EFFECTIVE COLLABORATION WITH JAMB

The Provost of the Federal Cooperative College (FCC), Kaduna, Dr. Ibrahim Auwal, has reaffirmed his institution's commitment to effective collaboration with the Joint Admissions and Matriculation Board (JAMB).

This was contained in his address during an interactive session with the Acting Zonal Director, Headquarters Annexe, Kaduna, Mr. Bello Hausawa Aminu, in his office on Monday, 10th, 2025.

The newly-appointed Provost was full of praises to JAMB for leveraging appropriate technology to solve various admission-related issues.

Responding, the Director underscored the relevance of the Central Admissions Processing System (CAPS) and the Integrated Brochure and Syllabus System (IBASS) on admission

processing to tertiary institutions in Nigeria, emphasizing that these platforms play essential roles in managing admissions, monitoring programmes, and facilitating communication among tertiary institutions, candidates and the Board.

Furthermore, he reiterated the Board's zero tolerance for underhand admissions, stressing that no institution is permitted to admit candidates outside CAPS. He said such actions violate the operational guidelines and policy statements on admission.

The Director also stressed the need for prompt processing of indemnity forms for candidates, who applied for services that required its usage, noting that delays often lead to unnecessary apprehension from candidates who

think their applications had been denied or neglected by the Board.

Additionally, he cautioned the institution against running non-accredited programmes, noting that such courses would not appear in the institution's approved list and would have negative consequences on the innocent applicants.

While taking the delegation through the procedure for signature change on the JAMB platform, he urged the institution to formally introduce the new Provost to the Board through appropriate channels of communication as well as complete the required signatory template on the portal.

Also with the Provost during the visit were: the Director of Academic Planning, Dr. Sadiq Suleiman; and the Admission Officer, Mr. S.K. Mohammed.

## RECTOR MAPOLY, COMMENDS JAMB ON INNOVATIONS

Earlier, in his welcome address, the State Coordinator, Mr. Hakeem AbdulHameed, stated that the State Office is saddled with the responsibility of ensuring that institutions in the State comply with all advisories on admission especially by conducting all admission-related processes on the Central Admission Processing System (CAPS). He also urged the Rector to take the signing of Indemnity Forms as one of his cardinal assignments as admission is the nucleus of any institution. Similarly, the Rector said he will do all within his powers to safeguard the institution's handle by working

closely with his Admission Officer towards achieving credible admission outcomes.

Mr. AbdulHameed reiterated that students must register for Part-Time regardless of the year of admission and they must not be pushed under Condonement of Undisclosed Illegal Institutional Admission (CUIIA) window while noting that there is no CUIIA or condonement of any form as from 2021. He reiterated that the Board does not entertain requests for change of name but would consider those for correction of names only.

Arc. Jolaoso urged the Coordinator not to hesitate to bring any observations about the institution to his notice.

## ETHICAL STANDARDS: SUBAIR CHARGES FRESHERS ON MORAL PRINCIPLES

The Ondo State Coordinator of the Joint Admissions and Matriculation Board (JAMB), Mr. Subair Adebayo Fasasi, fdc, MNIM, has charged the newly-matriculated students of the Federal Polytechnic, Ile-Oluji, to imbibe sound ethical standards in their conduct on campus. Speaking at the 9th Matriculation Ceremony of the institution for the 2024/2025 academic session on Thursday, 13th March, 2025, at the Twin Auditorium, he congratulated the Management of the school and

the matriculating students on the epoch-making occasion, while charging the students to be of good conduct at all times. Furthermore, he urged them to strive for excellence in terms of character and academics, emphasizing the importance of sound moral principles and good behaviours both in and outside the school campus. Speaking earlier, the Rector, Dr. Ademola Ebeloku, who was represented by the Deputy Rector, Dr. Samson Omogbehin, disclosed that one thousand and six (1006)

students were admitted into Ordinary National Diploma (OND) programmes, while two hundred and eight (208) were matriculated into the Higher National Diploma (HND) programme across the three (3) schools of Business & Management Studies, Applied Sciences and Engineering of the institution. The Rector also reiterated the institution's zero tolerance for social vices, stressing that any students caught would be decisively dealt with.

### ...Institutions Must Prioritize Results Verification



following an alarming report from Bayero University, Kano. The university revealed that out of 148 results it verified for admission, only six were genuine, while the remainder were fraudulent. NIPEDS was established to facilitate the

verification of A'level qualifications, including certificates from foreign institutions, which are required for admission into Direct Entry programmes (not O'level qualifications). Through NIPEDS, JAMB has received confirmations from foreign institutions alerting them to forged certificates presented by candidates. Recently, thirteen additional A'level certificates were identified as fake after being submitted for admission consideration, with some institutions having already proposed the candidates based on these fraudulent documents. The candidates involved have been referred to law enforcement agencies for prosecution. Consequently, institutions that

propose candidates for admission using fake certificates will be viewed as accomplices in this fraudulent activity. While NIPEDS is a valuable tool, it does not replace the need for institutions to conduct their own verification and due diligence. The most egregious example of forgery involves candidates who submitted forged IJMBE results from ABU Zaria in an attempt to gain admission to ABU itself. JAMB urges all institutions to thoroughly verify all A'level qualifications presented for admission, regardless of whether they were issued by their own institution or by others.
