## JAMB COMMENDS MR PRESIDENT FOR NEWLY-LICENCED TERTIARY INSTITUTIONS

### ...Rolls Out Admission Guidelines, CAPS, IBASS



President Bola Ahmed Tinubu, GCFR

The Joint Admissions and Matriculation Board (JAMB) has commended President Bola Ahmed Tinubu for giving approval for the

establishment of new tertiary institutions in the country.

The Registrar, Prof. Is-haq Oloyede, made the commendation at an interactive meeting with principal officers of newly-established, upgraded and adopted Universities, Polytechnics and Colleges of Education across the country on 14th April, 2025, in Abuja.

Prof. Oloyede stated that the approval of 67 new higher institutions, comprising 22 new universities, 33 new polytechnics and monotchnics, and 12 new colleges of education across the country between

## 2025 UTME COMMENCES ON APRIL 24TH; CANDIDATES CAN NOW PRINT THEIR NOTIFICATION SLIPS

The 2025 Unified Tertiary Matriculation Examination (UTME) is now set to commence on Thursday, April 24, 2025, instead of the previously scheduled date of Friday, April 25, 2025. This adjustment has been made to accommodate essential commitments by the Board and its partner agencies. In preparation for the examination, prospective candidates can now print their Notification Slips, which contain vital information regarding their exam details.

What's Included in the Notification Slip:

- Examination date
  - Venue (centre)
  - Time
  - Other essential details necessary for successfully sitting for the examination
- Candidates are encouraged to print their Notification Slips starting today, Saturday, April 19, 2025. This will provide ample time for logistical arrangements to access their assigned centres within the chosen examination towns.

### ...JAMB Commends Mr President for Newly-Licensed Tertiary Institutions

late 2024 and 2025 is a demonstration of President Tinubu's commitment to expanding access to tertiary education in the country.

The Registrar pointed out that the interactive session was to introduce them to the regulatory framework guiding admission processing on the Central Admissions Processing System (CAPS) as well as the operations of the Integrated Brochure and Syllabus System (IBASS).

According to him, JAMB, as part of its regulatory mandate, is mandated to regulate admissions into all tertiary institutions of learning across the country adding that this is being carried out

in conjunction with relevant regulatory bodies such as NUC, NBTE and NCCE, and some professional bodies as well as all tertiary institutions in Nigeria.

"It is as a result of your coming on board late in the session, that JAMB

deemed it fit to hold an interactive meeting with you," he said.

Prof Oloyede used the occasion to urge the institutions to steer clear of conducting illegal admissions or engage in any form of infractions, stressing that there would be no room for regularisation or condonement of such admissions, adding that all admissions must be done using the automated platform of the Central Admissions Processing System (CAPS).

He stated that CAPS was introduced in 2017 as a platform that automates and streamlined admission processes, while the Integrated Brochure and Syllabus System (IBASS), launched in 2018, facilitates communication among regulatory bodies as well as enable eligibility checks by candidates with respect to their respective academic programmes.

He said, "CAPS ensures transparency, fairness, and integrity in the admission process. Any institution attempting to bypass this platform risks having such admissions nullified."

He said CAPS and IBASS have replaced the paper regime and have also now been equipped with institutional mail services as the Board's sole official communication channel with institutions and



regulatory bodies.

Prof Oloyede, explained that only academic programmes approved by regulatory bodies would be activated on the JAMB platform and urged those who have not done so to do the needful. He also informed the attendees that the Board had created accounts for them on the two platforms and urged their delegated handlers to guide their password jealously as the Heads of the institutions would be held liable for any infractions committed through these platforms.

Goodwill messages were taken from Heads of regulatory institutions, Directors from the Federal Ministry of Education and some critical stakeholders, who all commended JAMB for its efficient service delivery, innovations in the conduct of the UTME and admissions into the nation's tertiary institutions.

The highlight of the meeting was the live demonstration of the use of CAPS, IBASS and its mailing system.

LEADERSHIP, SUNDAY, APRIL 13, 2025: Federal Gov't Exposes Irregularities in Student Loan Disbursements by Banks: – The National Orientation Agency (NOA) has accused tertiary institutions of conniving with banks to short-change beneficiaries in the disbursement of the federal government's student loans. The NOA said its investigations into the disbursement of the loans have uncovered several unethical practices by some institutions of higher learning. This was contained in a statement issued recently by the Deputy Director, Communications and Media, NOA, Mr. Paul Odenyi. "According to the latest report by the Community Orientation and Mobilisation Officers (COMO) of the National Orientation Agency (NOA), schools and banks are conspiring to short-change the students," it said.

"Please ensure that candidates presenting the SAISSCE are given due consideration for admission based on the specific requirements of the programme..."

LEADERSHIP, FRIDAY, APRIL 18, 2025: WAEC Revokes Licence of 574 Schools Over Examination Malpractice: - The West African Examinations Council (WAEC) Nigeria has revoked the licences of 574 schools that were found guilty of examination malpractices. The examination body stated that the schools will not be allowed to conduct examinations even as the 2025 West African Senior School Certificate Examination (WASSCE) commences from Thursday, April 24, 2025.

The Head of WAEC's National Office, Dr. Amos Dangut made this known during a press briefing at the headquarters of the examination body in Lagos.

Dr. Dangut said WAEC had forwarded the list of the affected schools to the federal government. "This year, we have shared with them a total of 574 schools that have their recognition withdrawn and that is also going to be the same for all examining bodies. "So, these are those that have got their license revoked as far as the examination centre is concerned. So we will not conduct examinations there. We don't know them as far as conducting examinations" Dangut said.

PUNCH, FRIDAY, APRIL 18, 2025: Illegal KWASU Study Centre Uncovered in Ekiti Operators Arrested - The police in Ekiti State have arrested two operators of an illegal university study centre in the state.

The Commissioner of Police in Ekiti State, Mr. Joseph Eribo, disclosed this in Ado Ekiti while reporting discoveries of the State's Criminal Investigations Department in the last three months.

He said the suspects were arraigned last week. Mr. Eribo said that the suspects were operating an illegal study centre of Kwara State University, Malet in Ekiti State and awarding fake Bachelor's and Master's degrees of the institution to unsuspecting citizens.

The police boss said, "Detectives of the Criminal Investigations Department, on February 18, received credible intelligence that some syndicates are unlawfully operating the Kwara State University study centre in Ado-Ekiti, where several Bachelor and Master degrees were issued to unsuspecting members of the public..."

### **MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES**

**This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.**

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
7. Please be guided for compliance.

The Ibadan Zonal Technical Officer (IZTO) of the Joint Admissions and Matriculation Board, (JAMB), Ms. Bukola Okelola, has submitted that the Zonal Directorate is ready for the 2025 Unified Tertiary Matriculation Examination (UTME).

# CIRCULATION OF FRAUDULENT MESSAGES TO UTME CANDIDATES

The Joint Admissions and Matriculation Board (JAMB) wishes to inform the public about the circulation of false, misleading, and criminal messages targeting candidates registered for the 2025 Unified Tertiary Matriculation Examination (UTME). These messages are being disseminated by suspected fraudsters with the intent to defraud unsuspecting individuals. The perpetrators have exploited the numerical variant of UTME, 8863, and merged it with the Board's sort code,

55019, to create a deceptive sort code that mimics JAMB's official messaging system. Through this fraudulent scheme, they have been sending misleading messages to candidates, falsely claiming to detect manipulations in their JAMB details and urging them to contact certain individuals who will "assist" in resolving these fabricated issues. We want to emphasize that these messages are not from JAMB. Security agencies have been notified and are actively tracking the perpetrators behind this scam.

Candidates are strongly advised to ignore such messages. This is a common tactic employed by fraudsters who seek to exploit the examination period to deceive and defraud innocent candidates. The public is urged to remain vigilant and critically assess the messages they receive. Any communication that does not align with JAMB's official channels or uses suspicious language or instructions should be treated as fraudulent.

## CLARIFICATION ON UTME EXAMINATION LOCATIONS - JAMB STATEMENT

The Public Communication Advisor of JAMB wishes to address a misleading publication regarding the UTME examination, which inaccurately claims that candidates cannot sit for the examination outside their state of registration. This information, widely disseminated by NAN, is incorrect. In a recent interview with a NAN reporter, I clarified that candidates are not restricted to taking the examination within their state of registration. They have the flexibility to register anywhere in the country and select any town nationwide from any registration point.

Computer-Based Test Centres are clustered according to towns for convenience, allowing candidates to choose the town where they wish to take the examination. For example, if a candidate selects Garki as their examination town, they must take the exam in a centre within the town and cannot be posted outside the town as been alleged at times. It is crucial to rectify this misunderstanding to prevent confusion among candidates. Those who have registered for the UTME and selected examination towns outside their state of registration are indeed permitted to sit for the examination in their chosen towns.

Candidates have the freedom to select their examination town from any location across the country, regardless of their state of registration. For instance, a candidate can register in Lagos and opt to take the examination in Sokoto or any other location. This flexibility is designed to accommodate candidates' preferences and ensure they can choose a location that is convenient for them. We urge the public to disregard the erroneous report from NAN in its entirety.
