## RE-UPLOAD YOUR WAEC SSCE RESULT IF YOU UPLOADED BEFORE WAEC RELEASED THE FINAL RESULTS

All candidates who uploaded their O-level results before the West African Examinations Council (WAEC) released the final 2025 SSCE results must return to the Joint Admissions and Matriculation Board (JAMB) centres and re-upload their results.

JAMB has dropped all previously uploaded results to allow candidates to upload the WAEC SSCE final results.

Candidates who sat the UTME with "awaiting results" are required to upload

their O'level results as soon as they are released; many began uploading the WAEC 2025 SSCE before the final results were released. To avoid any confusion, the Board cleared all prior uploads, and all candidates are now required to re-upload their results whether or not they differ from the earlier results uploaded. Please re-upload your 2025 SSCE result to the JAMB portal without delay to be eligible for admission consideration.

### ...MATRICULATION LIST VIOLATIONS: Affected Institutions Cautioned and Pardoned

The institutions had not complied with matriculation requirements for admitted candidates, a situation JAMB considered absurd and unacceptable, prompting the Board to invite them to a meeting.

At a meeting with JAMB on 18 August 2025, the institutions were unable to offer convincing reasons for the violations.

The Registrar, Prof. Is-haq Oloyede, in his remarks at the meeting, said the purpose was to address what he described as an aberration.

He said, "You conducted admissions on CAPS but you did not matriculate any student. We feel that before we forward the report to the government, we should interact with you."

The Registrar also stated that there are processes and procedures for matriculation as set out in the admission guidelines, and he asked the institutions whether they had studied them.

He cited Section 23, subsection 7 of the guidelines, which says: "Every institution is expected to submit/upload the matriculation list

to the Board for matriculation analysis. The result of the analysis will dictate one of the following:

- i. Approval to proceed with the matriculation ceremony;
- ii. Approval to proceed, but with advice; and
- iii. Not approved for substantial non-compliance (23.4)."

"All successful candidates whose admissions are processed appropriately through the Joint Admissions and Matriculation Board (JAMB) will be listed, and the list made publicly available to all stakeholders (23.5). Any candidate whose name is NOT on the National Matriculation List will be considered not to have been admitted by JAMB, and the admission is illegitimate. No such illegal admission will be condoned," he concluded.

The Registrar also informed the institutions that the dangers of flagrantly violating these guidelines are enormous, adding that, apart from disenfranchising candidates, they could also sue the institutions for violation of their rights.

The Registrar said the Board was

looking at ways to remedy the situation following the apologies so that no candidate unduly suffers for sins they did not commit.

At the end of the meeting, the institutions resolved, among other measures, that all concerned institutions should submit their letters of apology on CAPS within 24 hours of the resolution and upload their outstanding matriculation lists within seven days from 18 August 2025.

According to the JAMB Registrar, the apologies would be the basis for inserting their matriculation lists accordingly.

Another decision taken at the meeting was that all affiliate institutions would operate through their parent institutions, which would appoint one person to supervise each respective affiliate institution.

The meeting took note of Olusegun Agagu University, Okitipupa, and Westpring University, Benin, for their refusal to honour the Board's invitation.

## JAMB, NSCDC COLLABORATE TO ENHANCE SECURITY MEASURES IN ABAKALIKI OFFICE

In order to ensure the safety of lives and property at the Ebonyi State Office of the Joint Admissions and Matriculation Board (JAMB), the Acting State Coordinator, Mrs. Doris O. Enoch, on Monday, 18th August, 2025, held a meeting with personnel of the Nigeria Security and Civil Defence Corps (NSCDC) to discuss ways of improving security protocols in the facility. The meeting, which was attended by six NSCDC personnel, focused on key areas such as routine checks, crowd control, and property protection.

Enoch emphasized the importance of maintaining law and order, preventing unauthorised access, and ensuring the safety of staff, candidates and property of the Board. She, therefore, urged the NSCDC personnel to ensure that

they conduct regular checks on the office premises to prevent any form of infraction and to also ensure that parents do not enter the office with their wards, in line with the Board's policy. She added that the NSCDC should have two personnel on duty at all times to ensure effective security coverage. She also charged the NSCDC personnel to properly coordinate the parking arrangements at the State Office to prevent theft and

other security breaches.

In response, the Chief Operations Officer of the NSCDC, Mr. Austin A. Ibekwe, thanked the State Coordinator for facilitating the interaction and promised that his officers would adhere to the outlined security measures. He also identified areas that needed to be improved upon such as maintaining 24-hour vigilance, among others, and assured the Board that his team would work diligently to further enhance security at the State Office.

**LEADERSHIP, MONDAY, AUGUST 18, 2025: NUC Bans Satellite Campuses For Private Varsities:** National Universities Commission (NUC) has banned satellite campuses operated by private universities in the country...

The announcement was contained in a statement published on the Commission's website, titled "Revised Guidelines and Criteria on the Establishment of Private Universities in Nigeria," and signed by the Executive Secretary, Professor Abdullahi Yusufu Ribadu.

The new guidelines follow the moratorium on the establishment of private universities earlier declared by the Commission on February 10, 2025.

The announcement came on Monday in Abuja, where JAMB inaugurated a 23-member special

committee to examine cases of high-tech malpractice". The Board's Registrar, Professor Ishaq Oloyede, explained that the era of simple copying and impersonation has given way to far more sophisticated tricks designed to beat the system.

"This year we came across very strange things," Prof. Oloyede said. "We felt that it would be better if we expand our resources and bring more minds together. The initiative, she said, was driven by the Honourable Minister of Education, Dr. Maruf Tunji Alausa, ensuring that all admissions are now fully automated and strictly conducted within the approved capacity of each school, eliminating previous challenges of overstretched facilities.

The statement quoted the Minister as saying; "This reform guarantees fairness, operational efficiency, and sustained quality in our Federal Unity Colleges..."

NATION, WEDNESDAY, AUGUST 20, 2025: FG: All Varsities to be Energy-Sufficient Next Year: The Federal Ministry of Education has announced that by next year, all tertiary institutions in Nigeria will run on mini-grids that will make them fully energy-sufficient.

The Minister of Education, Dr. Tunji

Alausa, made this known at the commissioning of the newly built Olatunji Bello Auditorium, a 550-capacity multi-purpose hall donated to the Lagos State University (LASU), Epe campus, by the Chief Executive Officer of the Federal Competition and Consumer Protection Commission (FCCPC), Olatunji Bello.

Dr. Alausa said, "The President has committed that by this time next year, literally all tertiary institutions in the country will have mini-grids that will make them energy sufficient. We need this to unleash the capabilities of our youth in the area of research, technology, and everything they do..."

GUARDIAN, WEDNESDAY, AUGUST 20, 2025: 60% of Public School Teachers Lack Basic Digital Skills, Says UBEC: More than 60 per cent of public primary school teachers in Nigeria lack basic digital literacy, the Executive Secretary of the Universal Basic Education Commission (UBEC), Dr. Aisha Garba, has said.

Dr. Garba stated this recently at the closing ceremony of the first phase of the Nigeria-Korea Smart Education Project, which has delivered modern digital learning infrastructure, teacher training, and locally developed educational content to six states...

The project, implemented by the Korea International Cooperation Agency (KOICA), in partnership with UBEC, targets schools in Kano, Bauchi, Nasarawa, Ekiti, Cross River, and the Federal Capital Territory (FCT)...

AFAS PRESS, WEDNESDAY, AUGUST 20, 2025: UI Blacklists 163 Student Associations for Non-Renewal: The University of Ibadan Student Affairs Division has blacklisted 163 student associations for failing to renew their registration as required by the university regulations.

In a memorandum released on Wednesday, 20th August, 2025, the Deputy Registrar (Students) announced that the affected associations are prohibited from operating within the university

environment, organising or participating in programmes under the university's name, and presenting themselves as recognized student bodies.

The blacklisted associations include faith-based, academic, professional, and social associations, among others.

NATIONAL ACCORD, THURSDAY, AUGUST 21, 2025: ASUU Applauds FG's 7-Year Ban On New Public Universities: Academic Staff Union of Universities (ASUU) has praised the Federal Government's decision to impose a seven-year moratorium on establishing new public universities in Nigeria, calling it a critical step to strengthen existing institutions.

During a press conference in Jos on Thursday, ASUU President, Prof. Christopher Piwuna, described the policy as "long overdue" and vital for addressing the unchecked proliferation of universities. "ASUU has consistently advocated for this measure for over a decade, raising alarms about the rise of poorly planned institutions," Piwuna stated.

He criticized the previous trend of creating universities as "tools of political patronage," emphasizing that the moratorium is essential to ensure better funding and development of current institutions. "This decision is not only welcome but necessary to safeguard the quality of education," he added...

### **MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES**

**This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.**

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
7. Please be guided for compliance.

# JAMB INAUGURATES 23-MAN COMMITTEE ON EXAMINATION INFRACTIONS

**A**s part of efforts to tackle the increasingly-worrisome hi-tech examination infractions, the Joint Admissions and Matriculation Board (JAMB) has inaugurated a 23-man committee to tackle the situation headlong.

The Registrar, Prof. Is-haq Oloyede, while inaugurating the committee on Monday, 18th August, 2025, lamented the worrisome dimensions the problem has taken.

The Registrar pointed out that in recent times, examination malpractice has evolved beyond traditional methods into more technologically-sophisticated forms.

He also disclosed that in the course of its usual post-examination reviews, the Board's technical team identified multiple instances of biometric and identity-related fraud perpetrated by some accredited Computer-Based Test (CBT) centres and candidates.

Top on the new discoveries are Image Blending, Albinism falsification, Finger Blending, Falsification of Results/Credentials, among others.

Consequently, the Registrar stated that, as part of its terms of reference, the committee would be vested with the responsibility of investigating all reported cases of image blending, finger blending, false claims of albinism, and result falsifications in the 2025 examination/admission exercise.

Another is to identify the methods, patterns, tools, and technologies used to perpetrate these infractions, review current examination and registration policies and recommend improvements to strengthen the system against such malpractices.

The committee is also mandated to determine "the culpability or otherwise of each of the 6,458 suspected candidates (whose results are still being withheld and to recommend appropriate disciplinary actions or sanctions against individuals or groups found culpable. Members of the committee included Dr. Jake Epelle (Chairperson); Prof. Muhammad Yahuza Bello and Prof. Samuel G. Odewunmi (JEOG Representatives); Prof. Eric Nwajugba (former VC, Alex Ekwueme University, Ebonyi State);

Prof. Tanko Ishaya (VC, University of Jos, Cyber Security Expert) and Prof. Ibe Ifeakandu.

Other members are Mr. Damilola Bamiro (JAMB IT Consultant); Representative of Security agencies; DSS; the National Cybercrime Centre (NPF-NCCC); Representative of High-Level Security Committee (Former CP Fatai Owoseni); Executive Secretary, National Commission for Persons with Disability; and National President of the National Association of Nigerian Students (NANS).

The committee also included a Representative of the National Association of Proprietors of Private Schools; Microsoft Africa; Funmilola B. Usman, Director, ITS Dept., JAMB; Dr. Wahab Oyedokun, Director, Legal Services, JAMB; Dr. Fabian Benjamin, PCA, JAMB; Auwal Bello, ITS Dept., JAMB; Mrs. Sanusi Oluwakemi, ITS Dept., JAMB; Mrs. Egbuna Ngozi, Member and Secretary, to be assisted by Mrs. Alisabatu Jekada, and Mr. Iyilade Abiola, ITS Dept. JAMB; as Assistant Secretaries.

## NCPWD VISITS JAMB, CALLS FOR CLOSER TIES



**T**he National Commission for Persons with Disabilities (NCPWD) has paid a courtesy visit to the Registrar of the Joint Admissions and Matriculation Board, Prof. Is-haq Oloyede.

The Executive Secretary of NCPWD, Chief Ayuba Burki Gufwan, who led top management staff of the Commission to the Board on 18th August, 2025, described the event as

a "thank you visit" to thank JAMB for its various interventions on behalf of his members and commended the transformative leadership of Prof. Oloyede, particularly as it concerns persons with disabilities in Nigeria. He, therefore, called for a sustained cordial relationship with the Board.

The Executive Secretary also pleaded for a sustained and robust relationship with JAMB to improve the lot of its members, especially through the adoption of sign language as part of the language of instruction in Nigeria, and to help tackle the challenges of providing teaching aids for Mathematics and English Language for children with impairments.

He lamented that candidates with

visual and hearing impairments constitute part of the 35 million persons living with disabilities in Nigeria and hoped that a robust relationship with JAMB would go a long way towards the realisation of these objectives.

In his remarks, the Registrar commended President Bola Ahmed Tinubu for appointing Chief Gufwan to head this crucial agency saying that since his assumption of office he had made many impactful decisions capable of further strengthening the Commission as well as demonstrating his capacity to deliver on his mandate.

He pointed out that JAMB had created a Disabilities Help Desk and the JAMB Equal Opportunity Group

(JEOG) to assist candidates with disabilities.

He pointed out that JAMB has made a recommendation to appropriate quarters on the need to ensure that sign language is made an official language alongside English as well as the need to agree and adopt a particular sign language model

because of the various versions available.

With respect to the challenges experienced in the deployment of Mathematics for the disabled community during the UTME, the Registrar said the matter had gone to the National Council on Education, the highest policy-

making body on education. He assured the delegation of the continued support of JAMB where necessary to advance the cause of candidates living with disabilities in Nigeria.

The interactive session, which took place at Hajiya Sa'adatu Usman Bungudu Conference Hall, Federal Secretariat Complex, Gusau, was held to sensitise the participants on the Board's activities, particularly on the newly-introduced features.

In his opening remarks, the State Coordinator expressed appreciation to the participants for honouring his invitation and their support to the Board while charging them to continue to adhere to ethical practices, especially those guiding

against various acts of wrongdoings. He said the Board frowns against acts of misconduct and would not hesitate to wield the big stick against any erring individual and/or entity.

Dogonyaro also stressed that he had also summoned the meeting to familiarise himself with the centre owners in the State as well as create a forum, where complaints and suggestions that would promote efficiency in service delivery, could be ventilated.

In his reaction, Mr. Adekola Ademola, the Director of ICT, Federal Polytechnic, Kaura-Namoda CBT Centre, expressed appreciation to the Coordinator for the interaction while blaming candidates' desperation to access services at all cost that is making them fall prey to

extortionists.

Also, Mr. Ademola implored the Board to make a bold and comprehensive list of its major services and the amount expected to be paid by candidates for each and circulate same to all accredited facilities in the State. He noted that if the candidates could boldly see the official price list for different services being offered and the same pasted at all facilities, they would be guided accordingly.

Also reacting, the Centre Administrator, Development Trustfund CBT Centre, Talata-Mafara, Mr. Yusuf Abubakar Mafara, prayed JAMB to also consider rewarding CBT centres that perform excellently well in service delivery the same way it rewards tertiary institutions in its NATAP-MAwards.

## JAMB GOMBE, TARABA JOIN FORCES TO TRAIN CBT CENTRES ON NETWORKING

As part of efforts aimed at enhancing the Board's service delivery, the Gombe and Taraba States Offices of the Joint Admissions and Matriculation Board (JAMB) have joined forces to train the technical officers of all accredited Computer-Based Testing (CBT) centres in the two States.

The workshop, held virtually on Thursday, 21st August, 2025, was part of the strategies aimed at forestalling the few hitches usually experienced in the conduct of the Unified Tertiary Matriculation Examination (UTME) as the Board prepares for the 2026 centre

accreditation exercise.

In his opening remarks, the Gombe State Coordinator, Mr. Johnson Adebiyi, welcomed the participants and stressed that the training was borne out of the desire of both State Offices to leverage their areas of strengths to impart technical skills to participants through cross-fertilization of ideas.

He maintained that the Board is committed to giving equal opportunity to all candidates while at the same time leaving no stone unturned to ensure that the credibility of the UTME is sustained.

In his paper presentation, the Taraba State Coordinator, Mr. Segun

Adesina, noted that the majority of the problems encountered during UTME are network-related and explained that IT networking skills encompass a wide range of technical abilities and soft skills necessary for designing, implementing, managing, and troubleshooting computer networks. Adesina stressed that skills crucial for various IT roles, especially network administrators include network fundamentals, routing and switching, network security and network management. He also asserted that effective job delivery go beyond mere acquisition of technical expertise, adding that soft

skills such as strong communication, problem solving, analytical skills, teamwork, adaptability and time management, are also critical for a seamless e-examination.

While delivering the closing remarks, the Gombe State Coordinator thanked his Taraba State counterpart for his wonderful insights. He encouraged the participants to take advantage of

the window of opportunity provided by the workshop to address their underperforming areas prior to the commencement of the 2026 UTME centre accreditation exercise.

## CBT TRANSITION STRATEGY: NECO AND ERC OFFICIALS VISIT YOBE STATE OFFICE

enable NECO to draw from the Board's extensive experience in e-examination since its full adoption in 2015.

Furthermore, he disclosed that the Yobe State Government would soon unveil its plans to introduce CBT at the Junior Secondary School level. This, he said, is aimed at ensuring that students are well-prepared ahead of their Senior Secondary Certificate Examinations (SSCE), which would, in due course, be shifted to the CBT mode as well.

On his part, the State NECO Coordinator commended the JAMB Registrar, Prof. Is-haq Oloyede, and his Management Team for their unwavering commitment to maintaining the credibility of e-examinations, noting that their efforts

have erased doubts as well as earned the trust of Nigerians.

Earlier, in his welcome address, the Board's State Coordinator Mr Mohammed Mohammad had warmly received the visitors and had provided them with comprehensive briefs, as well as answered all their questions regarding CBT implementation. He had also offered professional advice on strategies for a smooth transition to CBT while assuring them of the Board's continuous support and collaboration at all times.

The Coordinator noted that the visit underscored the commitment of the nation's educational bodies to work together in achieving a seamless transition to CBT, and by so doing, ultimately enhanced the integrity and efficiency of the examination process in Nigeria.

### **ADVISORY ON PROCEDURE FOR PROCESSING OF (DEGREE) ADMISSION FOR AFFILIATED INSTITUTIONS**

In 2022, the Board proposed that universities should take full responsibility for admissions into all degree programmes offered through institutions affiliated with them. However, this directive was not fully implemented, as universities were initially given the liberty to decide on the matter, pending a final resolution. To date, only the University of Ibadan has assumed this role of overseeing and coordinating the admissions of its affiliate institutions.

2. Following the meeting held on Monday, 18th August 2025, with various institutions regarding violations of matriculation guidelines, concerns were raised about the existing admission processing structure. Notably, institutions complained that they could not be held accountable for the misdemeanors of their affiliates under the existing processing format. As a result of this, the matter was revisited.

3. Consequently, it was resolved that the previously proposed process, where Mother-Institutions take responsibility for admissions into their affiliated institutions, should now be adopted and implemented by all universities with affiliates.

4. In light of the above, the Board has developed an updated procedure for the processing of admissions by both Mother-Institutions and their affiliates, as follows:

- a. Head of the affiliated-institution logs into JAMB (CAPS) portal and downloads candidates for a particular programme;
- b. The Head of the Affiliated-Institution (wherever it is based) logs into JAMB (CAPS) portal and sets admissions criteria for every programme, such as minimum scores for UTME, post UTME, aggregate, catchment and ELDS;
- c. The Head of the affiliated institution proposes the qualified candidates for each programme on CAPS and it goes to the Head of the mother-institution;

- d. The Head of the Mother-Institution (wherever it is based) logs into the JAMB (CAPS) portal and recommends the candidate to the Registrar of JAMB (or representative) for approval or declines the proposal with a reason for the rejection;
- e. The Registrar of JAMB (or representative) approves the recommendation(s) from the Head of the Mother-Institution or declines the recommendation with a reason for the rejection;
- f. If the recommendation is approved, the candidate is notified through his/her email and SMS to either accept or reject the offer of admission. The two institutions can log in and view the status of the recommended candidates;
- g. If the candidate accepts the offer of admission, he/she can thereafter print his/her admission letter and access other services online from his/her profile.

**NOTE:** *The Head of an Affiliated-Institution has access to “VIEW ONLY” all recommendations by the Head of a Mother-Institution.*

5. All Universities serving as Mother-institutions, Polytechnics/Monotechnics, Colleges of Education and other institutes offering degrees in affiliation with universities are to be guided by this, please.
