RELEASE OF JAMB RESIT 2025 UTME

SPEECH BY THE REGISTRAR, PROF. IS-HAQ OLANREWAJU OLOYEDE, CON, FNAL ON 21ST MAY, 2025 AT THE BOARDROOM, JAMB NATIONAL HEADQUARTERS

1.0 PROTOCOL

I extend a warm welcome to all present as we announce the results of the 2025 UTME resit examination, which took place from Friday, May 16, 2025, to Monday, May 19, 2025. During a Press Conference on Thursday, May 15, 2025, we informed Nigerians that candidates affected by human negligence would be afforded the opportunity to retake the 2025 UTME. I am pleased to report that all candidates have completed their examinations, and we are here today to unveil the results so they can assess their performance.

2.0 WHY RESIT THE EXAMINATION

The decision to allow candidates to retake the examination was made for compelling reasons that could not be disclosed at the time of the press conference. While the circumstances were regrettable, they illuminated numerous discoveries, particularly regarding suspected cases of previously unidentified infections. The Board deemed it essential to conduct this examination to confirm these findings. Indeed, the resit examination has proven to be a significant asset in the fight against examination malpractice, revealing issues that the Board had long suspected but been unable to address.

ETHNIC PROFILING OF UTME RESULTS NOT IN NATIONAL INTEREST - OLOYEDE

According to the Registrar, the

CCESC would not only complement and reinforce its Ticketing/Support platform but also guaranteed timely responses and by bringing support services closer to candidates.

The Registrar stated that the Board already had all necessary facilities on ground hence, creating the platform was not a difficult task. He also pointed out that the new platform was equipped with several layers of support, with proceedings

recorded for quality assurance and documentation purposes. He noted that, the CCESC within its short span of operations, is not only efficient but has also proved to be a value addition as it offers counseling services to candidates and the general public alike.

2025 UTME: JAMB HOLDS STAKEHOLDERS MEETING

As part of efforts to assess its various operational processes, the Joint Admissions and Matriculation Board (JAMB) on Wednesday, 21st May, 2025, convened a meeting of critical stakeholders. The meeting comprised, Technocrats, Chief External Examiners (CEEs) who are Vice Chancellors, Rectors, Provosts and Civil Society Organisations,

academics, among others.

In his opening remarks, the Registrar recalled the meeting of Wednesday, 7th May, 2025, where he announced the rescheduling of the examination for Owerri and Lagos Zones, adding that his emotional breakdown was unexpected but a natural reaction to the unfortunate incident of a candidate committing suicide on account of her poor 2025 UTME

results, and was never an indication of an impending abdication of responsibility to candidates and the country.

He also regretted the machinations of mischievous characters, who are hell-bent on taking advantage of what they see as a moment of weakness of the Board.

JAMB URGES PUBLIC TO READ MANUAL OF CRITICAL ASSESSMENT COMPETENCES FOR TERTIARY EDUCATION

The Joint Admissions and Matriculation Board (JAMB) has unveiled a book to serve as guidance to educationists and public commentators to prevent frivolous claims and misinformation especially in terms of analysing the conduct of public examinations and administration in the country.

The book, which was authored by erudite scholars in the country is to serve as a guide for experts in test and measurements, among others.

The book titled: "Manual of Critical Assessment Competences for Tertiary Education Lecturers in Nigeria Tertiary Institutions," could be found on the Board's website,

NITDA IN JAMB, OFFERS TECHNICAL ASSISTANCE

The National Information Technology Development Agency (NITDA) has offered to collaborate with the Joint Admissions and Matriculation Board (JAMB) on areas of mutual interest particularly in the conduct of the Board's Unified Tertiary Matriculation Examination (UTME).

The intervention of the agency was in respect of the technical glitch experienced in the just-concluded 2025 UTME.

The agency stated this during the visit of its delegation, led by the

Director of Information Technology (IT), Project Clearance Unit, Dr. Usman Abdullahi Gambo, to the Board's National Headquarters, Abuja.

The proposed areas of collaboration, according to Dr. Gambo, include the conduct of a comprehensive technical review of the Board's systems and processes that contributed to the glitch.

The delegation is also to identify the root causes of the glitch and provide recommendations for system improvement and robust quality assurance mechanisms while

exploring and recommending measures to prevent a recurrence of such incidents in future examinations. The Registrar, Prof. Is-haq Oloyede, in his remarks, welcomed the delegation and promised that the Board would continue to make their existing inter-agency relationship more robust and cordial.

The Registrar later took the delegation through the various stages of registration, examination administration, conduct, release of results and the various quality control mechanisms of the Board.

Ex-head of Service, Afolabi Makes Case for Full University Autonomy: – Former Head of the Civil Service of the Federation, Professor Oladapo Afolabi, has called for full autonomy for Nigerian universities, arguing that the current system of centralised control stifles innovation and prevents institutions from thriving through healthy competition. Speaking at the first alumni reunion and fundraising event of the Department of Chemistry, OAU, held in Victoria Island recently, Prof. Afolabi, an alumnus of the department himself, said universities must be given the freedom to manage their affairs, including generating and spending their revenue. “What we need is a policy shift,” he said. “Let universities determine their own destiny. Allow them the autonomy to raise funds, pay their staff, and maintain their infrastructure. The current model where the government restricts commercial fees and dictates operations is unsustainable...”

THISDAY, THURSDAY, MAY 22, 2025: UTME: Oloyede Flays Calls for Resignation, Says "Truck Pushers" Cannot Direct Pilots: - Registrar of the Joint Admissions and Matriculation Board (JAMB), Professor Is-haq Oloyede, has rejected demands by critics for his resignation following challenges during the 2025 Unified Tertiary Matriculation Examination (UTME).

Speaking during a meeting with key stakeholders, including chief external examiners and civil society organisations, in Abuja, Prof. Oloyede dismissed the calls for his resignation, stating that those criticising his leadership lack the competence to question his stewardship.

"Truck pushers cannot direct pilots," he said, in reference to critics whom he believed were unqualified to advise on matters of education. Prof. Oloyede acknowledged the emotional strain experienced while announcing the UTME results but clarified that it was not indicative of institutional weakness. He stressed that JAMB remained committed to resolving issues affecting the examination process. He also rejected any suggestion that administrative failures were due to incompetence or ethnic bias. He added that many public reactions were fuelled by ignorance and misinformation, calling on stakeholders and the media to stop politicising educational issues.

-The Minister of Education, Dr. Tunji Alausa, has lamented that 85 per cent of Nigerian students sent abroad on government scholarships never returned to contribute to national development.

He also enjoined tertiary institutions nationwide to phase out satellite campuses, describing them as unsustainable and inefficient. Alausa, who spoke at a one-day engagement with heads of institutions, bursars, and procurement directors in Lagos, said the Federal Government was repositioning the funding framework to ensure public resources are used efficiently.

On foreign scholarships, Dr. Alausa revealed a shift in policy, explaining

that more funds would now be invested in building local capacity.

"Our evidence-based analysis showed that 85 per cent of Nigerian students sent abroad on government scholarships never returned to contribute to national development. Many of the programmes they studied could have been handled effectively within our own institutions," he stated...

- The National Universities Commission (NUC) Resource Assessment teams have evaluated two courses at Lagos State University (LASU).

encountered and quickly took remedial action where hitches were noticed as well as dispel rumours of a plot by the Board to shortchange the South-East educationally.

He stated that the technical glitch affected the five States of the South-East zone and Lagos State in the South-West hence, he insisted that there was no deliberate attempt to undermine students from the South-East as every candidate is a Nigerian first before any other considerations.

He said, "As the chief executive of JAMB, I don't really care where any of our staff comes from, all I know is that they have been doing their jobs well for years."

He, therefore, commended both

candidates and the staff of the Board for their resilience despite the operational and logistical setbacks. While describing the death of a candidate as a result of the examination as regrettable, he requested the meeting to observe a minute silence in honour of the deceased candidate. Furthermore, he stated that the pressure arising from the technical glitch that was experienced during the UTME in parts of the South-East and Lagos State almost led him to throw in the towel.

"When I received the news, my first reaction was to resign, but people advised me that the students will never forgive me as it will look like I have abandoned them at their hour

of need.

"The emotional breakdown on my part was not a sign of weakness neither was it an excuse to abdicate my responsibilities. Let us not descend to a level where some people begin to pontificate because they want to take advantage of the situation on ground. I want to say this clearly, I accepted responsibility, not because I do not know how to do the work but out of empathy for the trauma that affected candidates would be undergoing.

"Also, I will say it for the umpteenth time that no conspiracy theory is relevant to this case," he said.

3.0 THE EXAMINATION

As previously mentioned, the examination was conducted for a total 336,845 candidates, which reflects a difference from the previously announced figure of 379,997. This adjustment resulted from a comprehensive review exercise, during which all isolated sessions good sessions within the affected centres were excluded. Furthermore, among the 369 previously unverified candidates who had initially been included in the rescheduling, it was confirmed that 301 candidates remained unverified.

4.0 EXAMINATION INFRACTIONS DURING THE RESIT EXAMINATION

On the whole, the exercise was successfully conducted. However, one of the critical realities that emerged is the noticeable increase in examination malpractice, a challenge that transcends regional boundaries and is not confined to any specific part of the country.

It is imperative that the elite confront this growing menace with objectivity and a sense of responsibility rather than fostering an environment conducive to misconduct by promoting unfounded conspiracy theories. Efforts should be directed towards discouraging such acts and setting positive examples for the younger generation. Some of the new trends discovered are techniques referred to as 'Pairing', 'Photo Blending', and 'Finger Blending'. While the phenomenon of finger blending was first detected in 2019, predominantly in certain parts of the country and typically involving combination of the fingerprints of CBT centre officials, it has now evolved into more sophisticated forms. The current trend involves the blending of biometric data among candidates, thereby compromising the integrity of the biometric verification process. Six CBT centres involving in these malpractices have so far been apprehended. Following their arrest, confessions obtained from the suspects led to uncover their tentacles across the country. Accordingly, the results linked to these fraudulent activities are being systematically identified and withdrawn.

6.0 LESSONS LEARNED

As noted earlier, the lessons derived from this unfortunate incident are immeasurable. Firstly, technology will continue to be the cornerstone of conducting large - scale examinations like the UTME. However, it is imperative that quality assurance processes are fully automated, encompassing even the smallest components of the operation. Our review process, previously conducted months after the examination, will now be executed immediately following the examination. Additionally, we will ensure that all our software complies with the highest standards. This experience has illuminated areas for improvement and will inform our future strategies.

7.0 THE RESULTS

Candidates can now access their results by sending "UTMERESULT" to 55019 or 66019 using the phone number registered during their application, just as they have done previously.

8.0 ASSURANCE

We firmly believe that the lessons learned from this incident will enable us to enhance our operations, as we have already begun to do. Nigerians can be assured that such an occurrence will never happen again. We have gained invaluable insights that will fortify our processes and prevent future embarrassments to our nation.

9.0 BIOMETRIC FAILURE FOR CANDIDATES

For those whose biometric data failed to register during the examination, the Board is nearing the conclusion of its investigation. Once finalized, these candidates will be given the opportunity to retake their examination before the commencement of the admission exercise.

10.0 OUR COMMITMENT TO OPENNESS

Our commitment to transparency has highlighted certain misconceptions about the nature of our operations. Some individuals have requested access to candidates' answers, while others have questioned why we cannot release results immediately. There are even concerns about our fraud detection mechanisms, which are designed to prevent cheating.

While the Board has the capability to release results instantly, we adhere to globally recognized practices for selection tests. This involves a thorough normalization process that is essential for maintaining the integrity of a national examination. Consequently, we cannot provide raw scores without this critical review. Additionally, we must analyse the results to identify any infractions, utilizing technical tools such as CCTV footage from examination centres, which often reveal instances of fraud. It is ironic that those who demand a comprehensive review of the examination process are also the same individuals calling for immediate results.

We are increasingly concerned about requests from individuals seeking to view our examination materials and candidates' responses. This trend, which began with JAMB, could potentially extend to all examinations. We cannot yield to such pressures, as doing so would compromise the integrity of our assessments.

We encourage these individuals to focus on their respective responsibilities and allow us to fulfill our professional and technical duties. Our operations are guided by international standards, and as committed members of this community, we must uphold these principles.

JAMB REGISTRAR EDUCATES COMMENTATORS ON PLACEMENT AND ACHIEVEMENTS TESTS

The Registrar of the Joint Admissions and Matriculation Board (JAMB), Prof. Is-haq Oloyede, has berated critics of the Board, who are making ill-informed contributions on issues they do not have sufficient knowledge about.

The Registrar at a meeting with stakeholders in Abuja, on Wednesday, 21st May, 2025, criticised some public commentators, analysts, and opinion leaders, among others, who are fond of misrepresenting the public, the roles and mandates of the Board particularly with regard to the conduct of its annual Unified Tertiary Matriculation Examination (UTME).

He stated that achievement tests are used to elicit the level of competence a person has successfully attained in a field of study, while a placement test is used to assess a student's current

knowledge and abilities to determine the appropriate level or course placement. In essence, achievement tests measure what someone has already accomplished, while placement tests assess their current status for placement in a tertiary institution among a cohort.

He pointed out that the matriculation examination conducted by JAMB is a ranking examination for hitherto-qualified candidates seeking admission into tertiary institutions in the country.

According to the Registrar, the purpose of the examination is to rank candidates for available spaces in institutions and not to measure intelligence or overall academic potential.

The Registrar further stated that a high UTME score is not the sole determinant of admission, adding that the combined performance in the O'levels, post-UTME, and school

assessments, could significantly affect a candidate's ranking.

He said, "Many people don't know the difference between a achievements test and selection/placement test. Hence, the calls from some quarters for the extension of the validity of UTME score are misplaced as you cannot extend placement but you can surely extend the validity of achievement tests.

"The purpose of the UTME is placement and it could be likened to a quiz given to already-qualified candidates. Therefore, it's not the UTME that qualifies them but their O'level results."

He, therefore, tasked the media to educate the public on the provisions of the Arusha Convention on the five O'level credits requirements of which Nigeria is a signatory.

...JAMB Disburses N3.006 Billion to CBT Centres as Initial Payment for 2025 UTME Examination Charges

JAMB has expressed surprise at the outcry from CBT centres regarding this payment, which has been accompanied by various accusations against the Board that appear to be attempts at blackmail. While the Board acknowledges the centres' concerns—particularly in light of ongoing investigations into their operations by security agencies—it emphasizes that any centres found to be in violation of regulations will not receive payment. This has led to perceived pressure tactics from some centres to secure payment prior to the conclusion of

the examination process. Traditionally, JAMB disburses payments only after the completion of the main mop-up exercise, which has yet to take place.

It is important to note that these centres have previously received weekly payments during the registration phase until its conclusion and are familiar with the established procedures and timelines for the disbursement of examination charges, which typically occur after the UTME has been conducted.

JAMB remains resolute in not yielding

to what it describes as blackmail from the centres. The decision to make this payment is intended to prevent unnecessary distractions, especially as the Board retains the ability to recover funds from any centres implicated in ongoing investigations, even if it means instituting legal procedures.

Payments for the resit UTME will be processed once the mop-up exercise is completed.

PROMPT RESCHEDULING OF EXAMINATION NOT TO DISENFRANCHISE CANDIDATES

The Registrar of the Joint Admissions and Matriculation Board (JAMB), Prof. Is-haq Oloyede, has said the prompt rescheduling of candidate that experienced hitches were done in their best interest.

He said people, who were criticizing the Board for what they termed 'hasty rescheduling' of the examination, were not conversant with the circumstances surrounding the conduct of public examinations in the country.

He noted that there are specific windows for each examination body such that WAEC would have April-May; NECO, May-June, NABTEB, June -July. In addition, a couple of other entrance examinations to military and paramilitary institutions across the country are also scheduled for this mid-year window. Hence, the Board had implored WAEC to allow it utilize the Agric practical session slated for Friday, 16th May, 2025, for the

rescheduled examination noting that 95% of candidates took the examination.

He announced that the remaining 5% that missed the examination would be rescheduled for the upcoming Mop-Up UTME and as a bonus, those, who missed the main UTME held between Thursday, 24th May, 2025 and Wednesday, 30th May, 2025, would also be accommodated in the Mop-Up.

He also noted the emotional trauma that these candidates would have undergone had the examination been put off till a later date.

The Registrar, who disclosed that he had contemplated resigning from the job, added that he decided to shelve the idea having realized that the affected candidates would not have forgiven him for abandoning them to their fate.

JAMB ANNOUNCES MOP-UP EXAM FOR ABSENTEE CANDIDATES, OTHERS



Absentee candidates and other candidates with verifiable complaints, who missed the 2025 UTME, now have a window of opportunity to retake the examination via a mop-up test.

The Registrar, Joint Admissions and Matriculation Board (JAMB), Prof. Is-haq Oloyede, announced the mop-up examination for candidates, who

missed the 2025 Unified Tertiary Matriculation Examination (UTME) on Wednesday, 21st May, 2025.

The Registrar, who disclosed this during a meeting with Chief External Examiners (CEES) and other critical stakeholders of the Board, said the mop-up examination would provide a second chance for the estimated 5.6% of the candidates who

registered for the 2025 UTME, but who were unable to sit the examination, regardless of the reasons for their absence.

The JAMB Registrar assured the public that a date for the special mop-up examination would be announced soon.

He said, "Normally, we hold one mop-up nationwide for those with one issue or another. But this time, we are creating a new mop-up system. So that even those who missed the earlier examination on account of absence, will enjoy this opportunity.

"It is not that we are doing something extraordinary; in class, you give a make-up examination when students missed it for one reason or another; we just don't allow the abuse of that window. So, we will allow all the candidates, who missed the main examination for any reason, to take part in this mop-up," Oloyede explained.

MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES

This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
