## JAMB ADJUSTS 2025 MOCK UTME DATE

The Joint Admissions and Matriculation Board (JAMB) has rescheduled the date for the 2025 Mock UTME from April 5 to April 10, 2025. This adjustment aims to ensure that all necessary preparations are completed, incorporating a variety of innovations and enhancements designed to make this examination one of the best in history, while also accommodating the increased number of examination centres for the 2025 exercise.

Thursday, April 10, 2025 while the main UTME would start from 25th April, 2025, In line with global best practices and recent research on examination methodologies in our region, the Board recognizes the need for innovative measures to optimize the mock exercise's intended purpose.

Candidates are advised to stay tuned for the announcement regarding the printing of their Mock Notification Slip, which will provide details about the location of their examination centre.

Originally set for Saturday, April 5, 2025, the Mock UTME will now take place on

processes. The commissioners expressed their satisfaction with JAMB's preparedness and suggested that future meetings be conducted in person to better understand the details of these innovations.

In his remarks, Prof. Oloyede acknowledged the invaluable contributions of the CEEs and CTAs over the years and urged them to continue acting in the Board's best interest. He emphasized that while securing the 887 centres for the upcoming examination posed several challenges, these were overcome through the determination of stakeholders and the implementation of a software solution which effectively identified

duplicate CBT centres.

Highlighting the importance of the CEEs' role in overseeing the examination process, the Registrar noted that valuable lessons were learned from the 2024 UTME, which was deemed exemplary. These insights will be leveraged to enhance the 2025 examination experience.

Prof. Oloyede outlined the responsibilities of the CEEs, which include providing leadership to examination personnel within their states, ensuring smooth examination conduct, appointing three computer-literate proctors for each centre, addressing challenges promptly, and compiling daily summary reports.

Additionally, he expressed gratitude

to the CTAs for their commitment to maintaining high standards, urging them to remain steadfast in their support for the 2025 UTME by offering essential technical advice, resolving challenges, and safeguarding sensitive equipment. The Registrar also clarified the categorization of examination centres into two zones: Lagos (LAG) and Kaduna (KAD). Centres in the southern states, excluding Port Harcourt and Benin but including Kano and Abuja, fall under the LAG zone. In contrast, the KAD zone encompasses all northern states, including Port Harcourt and Benin, but excludes Kano and Abuja.

## 2025 MOCK: NSCDC ISSUES STERN WARNING TO IMPERSONATORS

The Nigeria Security and Civil Defence Corps (NSCDC) has issued a stern warning to impostors and other criminal elements to stay off the vicinity of the various centres to be used for the upcoming Mock-UTME and main UTME nationwide.

The Deputy Commandant-General, Operations, Mr. Philip Ayuba, gave the warning after a high-level meeting with the Board on the 2025 UTME examinations.

He disclosed that as part of the efforts to strengthen the existing cordial relationship between the Board and the Corps, State Commandants would be held liable for any infractions recorded in any of the Board's critical facilities entrusted to their care.

This measure may not be unconnected with the various reports of theft perpetrated in some State Offices of the Board as well as the reports of misdemeanours involving some unscrupulous elements in connivance with some Corps personnel.

The DCG pointed out that all the reported cases against NSCDC operatives are being investigated and assured the Board that such

would never happen again. He assured JAMB of the readiness of the Corps to cooperate with JAMB State Coordinators on better surveillance and policing of the Board's critical assets. While promising to work with JAMB to achieve her mandate, he also expressed appreciation for the logistics support provided for the Corps.

On the issue of late arrival and extortion of candidates, Ayuba assured the Board of proper and adequate surveillance of the examination centres while warning criminal elements to stay off these venues as the Corps is fully prepared to handle any attempts aimed at compromising the integrity of the examination.

Earlier in his remarks, the Registrar expressed displeasure with the loss of some critical assets but added that the Board would try to energize the relationship while reactivating all channels that would facilitate effective interaction.

He called for a more proactive approach by the Corps so as to properly man the 887 centres that would be used for the Mock-UTME slated for 10th April, 2025.

While stressing the need for prompt

arrival of its personnel, Prof. Oloyede explained that there are consequences of coming late to centre as Auditors had queried the justification of paying personnel hitherto marked absent by Biometric Verification Officers, who were, in many instances, made to refund money paid to such latecomers.

On the issue of prosecution of infractors, the Registrar explained that the Board is centralising its infraction cases for ease of prosecution and urged the officers to cooperate with the State Coordinators on this. He, therefore, urged the Corps to maintain high level of discipline and professionalism by its personnel towards tackling cases of examination misconduct.

In his closing remarks, Prof. Oloyede hinted the meeting of the planned upscaling of the refreshment allowance by 100 percent, coupled with the proposed training of the Corps arms carriers at a one-week training exercise at the National Institute of Security Studies (NISS) after the Mock-UTME to correct some observed character defects with a view to improving their capacity and security consciousness.

NTA, MONDAY, MARCH 24, 2025: The Commission will Leverage JAMB Infrastructures in its Learning and Planning Activities- Prof. Olaopa - In his effort to scale-up the ongoing reform in the Commission and the necessity to achieve his objectives in the Federal Civil Service; the Chairman, Federal Civil Service Commission (FCSC), Prof. Tunji Olaopa has said that the Commission will leverage Joint Admissions and Matriculation Board (JAMB) infrastructural facilities to drive its recruitment and promotion examinations processes.

He stated this recently when he paid a courtesy call on the Registrar of JAMB; Prof. Is-haq Oloyede in his office. Prof. Olaopa disclosed that the visit was to strengthen the existing partnership between JAMB and the Commission by tapping from the technical experience of the Board to innovatively develop core mandates of the Commission.

According to him, the Federal Civil Service Commission's processes of recruitment, promotion and discipline are currently being conducted manually. He, therefore, solicited the collaboration of JAMB in this regard in order to enhance the Commission's operational activities.

NATION, MONDAY, MARCH 24, 2025: Cosmopolitan Varsity Sign MoU with Health Ministry on Medical Training:- Cosmopolitan University, Abuja, has signed a Memorandum of Understanding (MoU) with the

Federal Ministry of Health to enhance medical education and training, particularly for nursing and other healthcare-related courses.

The signed agreement will allow students from the university to undertake their clinical training at the National Hospital, Abuja, a move that aims at addressing workforce challenges in Nigeria's healthcare sector.

Speaking at the signing ceremony, Coordinating Minister for Health and Social Welfare, Prof. Ali Pate, emphasised the significance of the partnership in strengthening the country's medical workforce.

LEADERSHIP, TUESDAY, MARCH 25, 2025: Federal Gov't Unveils 50 Local Textbooks for Tertiary Education:- The Federal Government has unveiled fifty (50) locally-written textbooks aimed at addressing the critical shortage of high-quality academic resources in Nigerian universities and colleges.

The initiative is spearheaded by the Tertiary Education Trust Fund (TETFund), under the Higher Education Book Development Intervention Project. The 50 books, authored by Nigerian scholars, were presented to the public by the Minister of Education, Dr. Maruf Tunji Alausa, in Abuja recently.

Speaking at the unveiling of the books, the Minister said... "Scarcity of tertiary-level texts in Nigeria has reached a crisis proportion as evident not only in the quality of books available but also in the quantity of books produced locally. The need to tackle this crisis head-on resulted in the establishment of TETFund's Higher Education Book Development Project." Executive Secretary, said the project is intended to equip students with skills in artificial intelligence, cybersecurity, robotics, and software development. He also said six specialised ICT hubs had already begun operations in February.

He said the additional 72 centres, expected to be inaugurated in 2025, will offer students hands-on training and improve their employability in the global job market.

**LEADERSHIP, THURSDAY, MARCH 27, 2025: Nigerian School Earns Global Recognition for Excellence in Education:-** The Regent Secondary School, Abuja has become the first and only secondary school in Nigeria and West Africa to earn an outstanding rating across all nine categories from British Schools Overseas (BSO) inspectors.

The inspection is commissioned by the UK Department for Education.

Schools inspected by BSO are evaluated against various standards, including the quality of education provided, the spiritual, moral, social, and cultural development of pupils, and the welfare, health, and safety of students among others.

The inspection visit to The Regent Secondary School took place in February 2025, where the inspectors described the quality of education at the school as broad, innovative, and child-centred, praising its effectiveness in engaging students and delivering excellent academic outcomes.

**TRIBUNE, THURSDAY, MARCH 27, 2025: Align Education Projects With National Priorities FG Tasks Stakeholders:-** THE Federal Government has appealed to stakeholders and all partners to align their projects and programmes with Nigeria's priorities to address the

country's educational challenges.

Minister of Education, Dr. Maruf Olatunji Alausa, made the call during a meeting with representatives from the Japan International Cooperation Agency (JICA), where he commended the agency for its long-standing partnership with Nigeria in the effort to address some of the challenges in the Education sector.

Dr. Alausa, however, urged JICA to collaborate more with the Universal Basic Education Commission (UBEC), especially in the area of Effective Schools, which the government plans to establish at least one in each state of the federation.

He said, "We must work together to fix our country's educational system. The era of working in isolation is gone. We need collaborative efforts to ensure that our investments yield measurable results. We must ensure that all interventions are aligned with our national priorities to effectively fix our education sector..."

**LEADERSHIP, THURSDAY, MARCH 27, 2025: FG Resumes Work on Abandoned National Library Project After 19 Years:-** After nearly two decades of abandonment, Nigeria's national library project is finally set to restart construction by June 2025.

Minister of Education, Dr. Morufu Olatunji Alausa, disclosed this in Abuja recently while inspecting the project.

The project whose construction began in 2006 and was initially scheduled for completion in 2008, faced numerous setbacks, with work coming to a halt in 2012.

Before he handed over power to President Bola Tinubu, former President Muhammadu Buhari approved the takeover and financing of the multi-billion naira library edifice by the Tertiary Education Trust Fund (TETFund).

However, Minister Alausa said that under the leadership of President Tinubu, the project has regained momentum, and the first phase of the project, which includes essential structural and aesthetic work, will lay the foundation for the completion of this long-awaited national asset.

"We have a dedicated fund from TETFund to move back to the site. And I've spoken to the consultant and the contractors that we have a deadline of moving back to the site on or before June of this year, 2025."

**LEADERSHIP, FRIDAY, MARCH 28, 2025: Senate Approves Bills to Establish Federal Varsity of Medical Sciences, COE in Abia:-** The Senate has approved the Federal University of Medical and Health Sciences, Bende (Establishment) Bill and the Federal College of Education, Bende (Establishment) Bill, for third reading, marking a significant step towards the establishment of the two tertiary institutions in Abia State.

Sponsored by the Deputy Speaker of the House of Representatives, Hon. Benjamin Kalu, the bills received Senate approval following the consideration and adoption of recommendations presented by the Senate Deputy Leader, Senator Lola Ashiru.

The proposed Federal College of Education, Bende, aims to offer full-time courses and training in various disciplines, including technology, applied sciences, commerce, social sciences, arts, and humanities.

Similarly, the Federal University of Medical and Health Sciences, Bende, if passed into law, will focus on providing full-time training in medical and health sciences. The initiative, according to Hon. Kalu, is aimed at addressing the growing demand for medical professionals in Nigeria.

University, Kano. The university revealed that out of 148 results it verified for admission, only six were genuine, while the remainder were fraudulent. NIPEDS was established to facilitate the verification of A'level qualifications, including certificates from foreign institutions, which are required for admission into Direct Entry programmes (not O'level qualifications).

Through NIPEDS, JAMB has received confirmations from foreign institutions alerting them to forged certificates presented by candidates. Recently, thirteen additional A'level certificates were identified as fake after being submitted for admission consideration, with some institutions having already proposed the

candidates based on these fraudulent documents. The candidates involved have been referred to law enforcement agencies for prosecution.

Consequently, institutions that propose candidates for admission using fake certificates will be viewed as accomplices in this fraudulent activity.

While NIPEDS is a valuable tool, it does not replace the need for institutions to conduct their own verification and due diligence.

The most egregious example of forgery involves candidates who submitted forged IJMBE results from ABU Zaria in an attempt to gain admission to ABU itself.

JAMB urges all institutions to thoroughly verify all A'level qualifications presented for admission, regardless of whether they were issued by their own institution or by others.

congratulated the participants for being among the privileged few, who are adjudged to be deemed competent for appointment as Proctors and urged them to see their engagement as a call to national assignment.

He pointed out that Proctors are expected to be computer literate and, as such, they should be able to assist candidates, who have issues with their computers during the examination. He also noted that while on the field, they are expected to maintain high ethical standards.

The Registrar equally charged the Proctors to register with JAMB and create a profile code, which would be sent to the Secretary of the Chief External Examiners adding that the profile code generated would be used in any future correspondence with the Board.

Furthermore, Prof. Oloyede enjoined the Proctors to put on their institution's identity card in addition to any form of identification to be provided by the Board to prevent infiltration of unqualified person or groups.

In terms of remuneration, the Registrar disclosed that the Board had upscaped their payments adding that the token provided was an incentive and not actually what they deserved. He stated that the payment regime was in line with

federal government regulations and within the allowable limit as specified in such rules of engagement and is in tandem with global best practices.

In a training anchored by the Board's Information and Technology Consultant, Mr. Damilola Bamiro, the participants were informed that they were appointed based on trust, and, as such, they must discharge their duties meritoriously.

In his presentation, the IT Consultant said the Proctors had a strategic role to play in the conduct of the examination and stressed the need for them to be punctual at their duty posts.

Additionally, Bamiro took the Proctors through the rudiments of the examination particularly with respect to the structure of the centres, moral obligation of the Proctors, filling of report forms, need to be vigilant, mandatory attendance of meetings, and warned against engaging in any forms of infractions, extortion or acts capable of undermining the conduct of the examination.

Bamiro also urged the Proctors to display the highest level of professionalism, maintain their cool and pay attention to details especially with regard to the list of prohibited objects, biometrics verification procedures, going

through the checklist, adding that on no account should they allow candidates to enter the examination hall one hour after start time while candidates cannot exit the examination hall less than one hour into the examination.

In her contribution, the Director of Information Technology Services (ITS), Mrs. Funmi B-Usman, urged the Proctors to pay specific attention to cases of examination malpractice by taking full advantage of the CCTV cameras installed in centres to capture cases of examination malpractice while taking note of the imperative of using appropriate code in filling the malpractice forms.

Similarly, the Chairman, Chief Technical Advisors, Prof. Bashir Galandanci, said the Proctors are extremely important noting that the training would no doubt help them to perform well in their responsibilities.

Earlier, in her welcome address, the Director, Test Administration, Mrs. Ville Pius, thanked the critical stakeholders for their roles in the conduct of the Board's various examination over the years noting that the training was also aimed at assessing the conduct of the 2024 UTME for valuable insights.

### **MANDATORY USE OF THE NATIONAL IDENTIFICATION NUMBER (NIN) FOR REGISTRATION WITH JAMB BY CANDIDATES APPLYING FOR NON-REGULAR PROGRAMMES**

**This Advisory is issued to all the concerned institutions, and candidates desirous of applying to study under the non-regular mode of study in tertiary institutions in Nigeria.**

As part of measures to checkmate the nefarious activities of fraudulent characters, who are scheming to compromise candidates' records through dubious registration channels and in compliance with its enabling act, JAMB has mandated that all applicants desirous of studying in Nigerian tertiary institutions must provide their NIN while registering for any programme of study in any tertiary institution in Nigeria irrespective of whether the mode of study is **regular and non-regular**.

2. Consequently, it has now become mandatory for all prospective candidates in the **non-regular category (NOUN, Distance Learning, Part-time and Sandwich programmes)** to create a profile code, before registering with JAMB, by sending their NIN, through their unique phone number to either of the Board's sort code (55019 or 66019).
3. Immediately after the creation of profile, each candidate will proceed to a CBT Centre for registration. After the registration, the candidate's details will appear on the CAPS of the institution of choice under non-regular admission. The institution will then propose and recommend to the Board for approval and the candidate will accept and print admission letter.
4. Furthermore, all previous candidates in the non-regular programmes, who had not integrated their NIN or unique phone number on the Board's platform, would have to create a profile using their respective NINs to access any of the services of the Board.
5. No candidate can use the process to change any of the data already supplied to the Board.
6. JAMB, as a responsive organisation that is conscious of the peculiarities of the non-regular studies, will continue to make the registration process as flexible as possible by making its platform available throughout the year. It is, therefore, expected that candidates, who fall under this category, will apply through JAMB before approaching their preferred institutions to process their admission with their respective JAMB registration numbers. They would also be expected to pay their preferred institution a processing fee as determined by the respective institutions.
7. Please be guided for compliance.

Failure to do so will result in disqualification from consideration for the 2024 DE admission.

During the 2024 DE registration period, some candidates registered

with awaiting results from IJMB and JUPEB but have not yet uploaded these results. Please note that no candidate will be considered for admission with awaiting results, similar to the policy for UTME candidates.

Any application marked as "awaiting result" (AR) that does not comply with this directive will be disqualified from admission consideration.

It is essential that all candidate

credentials are verified to determine their eligibility.

Candidates without uploaded results will be regarded as not having any results.

Additionally, candidates applying for the 2025 DE are encouraged to be proactive. Ensure that your awaiting results are uploaded promptly upon release to change your status from AR and enhance your chances of admission.
