In her welcome address, the Vice

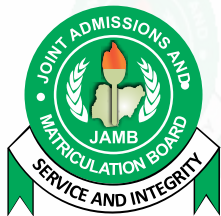

ADVISORY ON PROCEDURE FOR EMERGENCY TRANSFER OF RETURNEE NIGERIAN STUDENTS INTO NIGERIAN UNIVERSITY SYSTEM IN TIME OF CRISIS

Please find below the procedure for processing transfer of Returnee Nigerian Students into Nigerian University system in time of crisis:

1. A prospective student travelling abroad for undergraduate studies normally registers (document his/her travel) with the Federal Ministry of Education (FME) and obtains a Document ID. It is called "Notification to Study Abroad". In case of crises such registration becomes helpful.
2. Anyone who did not but has now become a returnee who is desirous of transfer into a Nigerian University must do a retroactive registration with the Federal Ministry of Education as follows:
 - Go to FME website - www.education.gov.ng
 - Go to attestation of academic documents or <http://ess.education.gov.ng>
 - Tick the certificates you want to evaluate (Tick your highest qualification in Nigeria to enable you pick a date)
 - Pick a date
 - Make payment via remittal - RRR code
 - Print Appointment Slip
 - Go to FME Revenue Unit - 2nd floor
 - Go to 8th floor - Evaluation Accreditation Division with original copies of your credentials base on your Date of Appointment

4. In the IBASS page, the Returnee Student uploads the registration slip obtained from the FME and then completes the Returnee Transfer Personal data:
 - a. Name
 - b. NIN
 - c. Telephone Number
 - d. Active e-mail address
 - e. Current University
 - f. Country and City of Study
 - g. Programme
 - h. Year of Entry
 - i. Current Level of Study
5. Returnee Student selects intended University of Choice and Programme.
6. Returnee Student uploads scanned copy of the following documents:
 - a. Current University Admission letter;
 - b. Transcript/Student Semester Results;
 - c. Data page of International Passport; and
 - d. Sworn Affidavit (confirming the genuineness of information supplied and that insincere or false information shall lead to withdrawal from studies and/or of certificates (in the event of issuance). Prosecution may also follow.
7. Returnee Student clicks SUBMIT button, which now sends an email to intended University of Choice for Request for Application to Apply for Inter-University Transfer.

8. Notification page for successful request is loaded and presented on the screen by IBASS System.
 9. Returnee Student gets a notification email and SMS for his/her application request sent to the intended University of Choice.
 10. Student's University of Choice gets an IBASS mail of the Student's Request for Application to Apply for Inter-University Transfer
 11. Intended University evaluates Student's credentials for possible consideration.
 12. If the Intended University of Choice is satisfied/unsatisfied with the credentials presented by the Returnee Student, a notification is sent on JAMB-IBASS-mail for Qualified/Unqualified for consideration.
 13. Qualified Returnee Student is directed via the email and SMS to approach any JAMB Office (in person) to complete the Inter-University Transfer Application.
- Note** that the process is tracked by JAMB, NUC and the candidate as follows:
- (a) Submitted
 - (b) Being reviewed by the University
 - (c) Successful/Unsuccessful
14. The intended University of Choice then follows the Advisory on Inter-University Transfer of Students earlier sent to the institutions in 2019 (see attached).

ADVISORY ON PROCEDURE FOR APPLICATION FOR FOREIGN INTER-UNIVERSITY TRANSFER FOR STALITES (NOT FRESHERS)

Please find below the procedure for application for foreign inter-University transfer for Stalites:

1. The proposed institution sends a list of all candidates (not Freshers) for foreign Inter-University transfer to State JAMB Office with a letter of indemnity.
2. The proposed institution directs each candidate to State JAMB Office to create his/her profile on efacility platform (Candidate not on the list earlier sent by the proposed institution would be rejected by the State JAMB Office and cannot process any application on the system).
3. At State JAMB Office, the candidate fills the INTER-UNIVERSITY TRANSFER APPLICATION FORM FOR STALITES (NOT FRESHERS) FROM FOREIGN UNIVERSITIES online which would be available only at the State JAMB Office (Note that only the State JAMB Office that the institution is located can attend to the candidates).
4. Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her Current and Proposed Institutions for the signature of the Heads of the Institutions to indemnify JAMB on the accuracy of the information provided by the candidate. The form is to be endorsed first by the current institution.
5. The Proposed Institution sends the endorsed and indemnified form to the Coordinator of the State JAMB Office.
6. The form is uploaded from the State JAMB Office to the Headquarters and made available to the efacility platform for processing.
1. If the application is approved, the candidate is notified through his/her email.
2. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

ADVISORY ON PROCEDURE FOR APPLICATION OF FRESH FOREIGN CANDIDATES (EXTRA ORDINARY)

Please find below the procedure for application for fresh foreign candidates (this supersedes the advisory issued in November, 2019):

1. The University sends a list of all fresh foreign candidates (for current admission) to State JAMB Office with a letter of indemnity signed by Head of the Institution. The letter of indemnity will read in part "I confirm that the listed candidate as forwarded to JAMB all met the admission requirements into my institution and hereby indemnify JAMB against any inaccuracy of the claims".
2. The same list and letter as in (1) above should be sent to the JAMB Director of Admissions through the CAPS mail.
3. The institution directs candidates to State JAMB Office to create their profiles individually on efacility platform (Note that only the State JAMB Office that the institution is located can attend to the candidates).
4. At State JAMB Office, the candidate fills FRESH FOREIGN Application form online which would be available only at the State JAMB Office (Candidate not on the list earlier sent by the institution would be rejected by the State JAMB Office and cannot process any application on the system).
5. Immediately the registration is completed at the JAMB Office, a Registration Number would be generated and assigned to the candidate alongside his/her transaction ID.
6. Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her institution for the signature of the Head of the Institution, to again indemnify JAMB on the accuracy of the information provided by the candidate.
7. The Head of the Institution authorises the candidate's application online. At this point the details of the candidate is now made available on CAPS to enable the institution Propose and Recommend the candidate to JAMB for approval.
8. The Head of the Institution would now send the endorsed indemnified physical form to the Coordinator of the State JAMB Office for immediate upload to CAPS for approval.
9. NO UPLOAD OF INDEMNIFIED PHYSICAL FORM, NO APPROVAL ON CAPS BY JAMB
10. If the application is approved, the candidate is notified through his/her email. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

SHITTU VISITS LAGOS STATE EDUCATION COMMISSIONER AHEAD OF SERVICOM WEEK

The Ag. Director/Coordinator of the JAMB National Headquarters ANNEX (NHA), Lagos, Mr. Shittu Billiaminu, has paid a courtesy visit to the newly-appointed Lagos State Commissioner for Basic and Secondary Education, Hon. Jamiu Alli Balogun. The visit was to congratulate him on his recent appointment and to discuss how to address the issue of data mismatch during candidates' enrolment for UTME/DE ahead of the SERVICOM Week slated to hold from Monday, 6th to Friday, 10th November, 2023. According to Shittu, "Lagos State

ranks highest nationally in terms of secondary school enrolment, a situation which accounts for the State high UTME enrolment figures. Furthermore, the Ag. Director stated that the Board prides itself on zero tolerance for malpractice while adhering to international best practices in assessment practices. He cited the existence of a robust Psychometrics Department, which ascertains the difficulty level of each item before deployment to ensure fair assessment. He expressed the readiness of the Board to collaborate with the Lagos State Government in the administration of its examinations. The visit also afforded the Board to apprise the State Government of the high level of candidates' NIMC data mismatch during candidates' enrolment for UTME/DE. This was part of the observations made by Mrs. Taofikat Ojomu, of the SERVICOM Unit, NHA, who stated that since the Board started pulling candidates' biodata directly from

the NIMC portal, there had been recurrent requests for change of name, date of birth and state of origin, adding that these cardinal issues are some of the rationale for holding the SERVICOM event. She also detailed plans to visit secondary schools across the State to sensitise students, especially those in SS2/SS3 about the operations of the Board and intimating them of the need to ensure uniformity in their biodata before the commencement of the 2024 UTME/DE registration. The Commissioner thanked the Board for the initiative and offered to help in bringing the SS3 students together at a venue to make it easier to address them at once. He also reiterated the zero tolerance of the State Government for examination malpractice while disclosing the readiness of the State to establishing her own mega CBT centre for the conduct of UTME and other examinations.

OLATUNJI-BELLO AS A HUMAN DYNAMO AT WORK

For any one who knows her well, the truth is that you can hardly afford to look elsewhere when Ibiyemi Olatunji-Bello, professor of physiology and Vice-Chancellor of the Lagos State University is within the same social or official space with you. She is as energetic as delectable. Sampler: Duty beckoned recently and my dutiful VC had to go to England for a programme that involved some other Nigerian Vice-Chancellors including University of Lagos' Prof Ogunshola and Federal University of Akure's Professor Oladiji (OLADIJI AS THE FRESH FERVOUR FOR FUTA | The Nation Newspaper (thenationonline.net). What, however, has turned out to be earning the utmost mileage, till date, deriving from the London programme is a photograph of the three female academic icons. The image has

remained the reference for prayer points on Facebook and several homes. You don't have to be a stakeholder in any of the three institutions to get glued to the photograph either for the reason of the aesthetics of the poise of the characters or for inspiration for some of us who have ambitious daughters. Indomitable Ibiyemi was, sometime in March 2023, again in Abuja at the instance of the then Ministry of Communication Technology and Digital Culture to formally take delivery of facilities for broadband internet for select universities in Nigeria. She was prompt and yet related with panache with her fellow VCs and others. The compere of the event and Head of Online Media for Nigeria Communication Commission, NCC, Dr Omoniyi Ibieta could not hold back her admiration for "the faithful and respectable VC. I'm sure

she is doing well for your institution", he later mentioned to me in some exchange. VC Olatunji-Bello's accomplishments have taken LASU to great heights in what may be reckoned as the trendiest version and one fully supportive of the proclaimed preference of the owner-government. Prior to Olatunji-Bello's assumption of office, the Lagos State Government had announced that it was resorting to e-governance for a lot of transactions that citizens might want to do with it thus relieving citizens of avoidable travels and troubles of preponderant louts. Olatunji-Bello took charge in LASU and made conscious efforts to ensure LASU became the model LASG needed to properly run its e-governance system. How? Even as she may be susceptible to the

comfort of her towering duty post, VC Olatunji-Bello never leaves anyone in doubt about her dynamic disposition to both domestic and official matters which, incidentally attract a lot of benefits to the LASU she loves. Promptly, she inspired optimal functionality for Nigeria's first ever university online safety application called LASU Monitor. Globally available online on Google Playstore, the app, once downloaded and activated, helps distressed device owners to alert LASU DICT centre to detect location and other details for possible rescue of the concerned. According to the Director of LASU DICT, effervescent Prof Enikuomelin, the motherly VC as a perfectionist inspired additional reporting tools for the app as, according to him, "VC is keen on making LASU West Africa's best university with zero record of tragedy of any form, let alone kidnapping plaguing the nation at the time of her assumption of office."

In what seemed like breathing life into the maxim that the ICT world is one endowed with infinite possibilities, there's no stopping the motherly VC's ingenious deployment of IT. Under her, the university went ahead to digitalize virtually all key operations and processes such that students may not have physical interaction with any officer from the point of admission to graduation. According to the information unit of the VC's office, "LASU, in an unprecedented stride in Nigeria, has upgraded its certificate to one embedded with an instant Verification Feature, with which individuals and organisations can verify the authenticity of a LASU certificate immediately, from anywhere in the world.

"In addition, we have also undertaken the installation of plagiarism detector in the University; installation of Remote Lecture room, lecture recording studios and smart classroom in the Postgraduate Schools; installation of thesis repository management centre in the Postgraduate School; commencement of automation of issuance of matriculation number in the Postgraduate School; commencement of online clearance and result uploading portal

in the Postgraduate School; introduction of digital forensic training with participants from multinationals and other sectors; introduction of a course in cyber policing; introduction of LASU Senate decision extracts management system; introduction of e-Senate and Senate file management with access for all members; automation of all diploma programmes with result portal in the University; digitalization of all University's records from 1985 – 2015". So much in the realm of ICT, you would probably say.

Alongside this level of digitech surefootedness has been physical development across all the campuses of the Great LASU. The main campus at Ojo is literally one vast construction site now even as this Olatunji-Bello administration is ensuring even distribution of the new facilities. Although Madam VC is of LASUCOM, beneficiaries range from the pioneering Arts Faculty to others, including Communication and Media Studies Faculty now ensconced in a new block befitting its planned commemoration of two decades of inception September 2023.

For Olatunji-Bello however, the physical development of the campuses has been such a guided one smacking of environmental impact assessment as advocated by environmentalists. No wonder, LASU deservedly bagged the 2022 edition of Best Green/Environmentally Friendly University, not only in Nigeria but the entire West Africa. The parameters for the award according to the promoters included Setting and Infrastructure; Energy and Climate Change; Transportation and Education.

Such are the overlapping phases of development that LASU has emerged the toast of the chief executives of educational agencies of the Federal Government of Nigeria. After series of commendation from Tertiary Education Trust Fund, TETFund, for instance, as recently as June 2023, the Executive Secretary of the National Universities Commission, NUC, Prof Abdul Rasheed, offered to come and commission the new TETFund supported building of FCMS. The NUC boss was unsparing in his celebration

of the efforts of LASU's Amazon that has transformed to a Dynamo on account of her relentlessness and matching achievements. Earlier, the nation's integrity icon in the public service who is the registrar and chief executive of the Joint Admissions and Matriculation Board, JAMB, Prof Is-haq Oloyede, had paid VC Olatunji-Bello a courtesy call. On that occasion Oloyede commended the LASU leader on her commitment to development especially with her trajectory as a former Deputy Vice-Chancellor. No LASUITE, staff or student, however could forget Prof Olatunji-Bello's inimitable records as the Director of the Lagos State University's Directorate of Advancement, LASUDA. It is therefore not for nothing that the VC's averted expectation of a continually supportive LASUDA occasioned by the sudden death of its immediate past director, Prof Yinka Okubena, registered most impactfully on all.

Beyond technological and physical developments is the primacy of psychological wellness of LASUITES even as the university unmistakably subscribes to global values and best practices. The university today has well resourced counselling centres on all the campuses complemented by well orchestrated campaign against Gender Based Violence, GBV. Most commendably too, LASU's Centre for the Actualisation of United Nations Sustainable Development Goals, LASU-SDG, is also in the forefront of the advocacy for Agenda 2030 component of the UN's Sustainable Development Goals, SDG. Indeed, the Centre has just concluded a well attended conference where no fewer than 109 academic papers were presented.

Two years after mounting the saddle of LASU's numero uno officer, Madam VC's posturing of one with rolled up sleeves is tellingly revealing even as the ground covered is unmistakably impressive. The march towards the leadership of West African universities looks promising. This situation will however be more reassuring if cadres of LASUITES across staff and students pledge to subscribe to the vision of institution's number one Martriach.

- 🌿 No Institution should advertise or sell “application forms” for admissions into the programmes. Institutions should advertise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
- 🌿 Joint Admissions and Matriculation Board (JAMB) and the three (3) Regulatory Agencies (National Universities Commission (NUC), National Board for Technical Education (NBTE) and National Commission for Colleges of Education (NCCE) will ensure that all Tertiary Institutions comply with this policy directive. Other Professional Regulatory Agencies will also play a role in sanitizing the process.
- 🌿 The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

- 🌿 Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.
- 🌿 It should be reiterated that no Institution should advertise or sell “application forms” for admissions into the programmes listed above. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
