## YMENT TO CBT CENTRES

#### ... Meets Financial Institutions, Vendors

he Joint Admissions and Matriculation Board(JAMB) is set to incur not less than N50 million as added commission to its financial vendors following the introduction of the cashless regime introduced in the 2022/23 UTME/DE Registration exercise.

According to the Registrar, the additional financial burden is the price the Board is prepared to pay owing to its passionate concern for the plight of hapless UTME/DE candidates by shylock centre owners. He added that the measure would also put a stop to other sharp practices that usually trailed the payments of direct service charges for registration at these centres.

The Registrar, Prof. Is-haq Oloyede, disclosed this at a virtual meeting with financial institutions and other vendors who desire to participate in the sales of the 2022 UTME and Direct Entry application e-PINs.

The Registrar pointed out that every candidate who desires to purchase the e-PIN would have to pay the sum of N4,700 as the total cost of the e-PIN which is N3,500

# LOW SUBSCRIPTION: NORTH-EAST EDUCATION COUNCIL VISITS JAMB

s part of measures to address the low subscription of candidates from the North-Eastern States of the Federation to tertiary institutions, especially those that have these States as their catchment areas, the zone under its newly-established body, the North-East Educational Council (NEEC), was at the Board's Headquarters, Bwari, to find a lasting solution to the problem.

It should be borne in mind that the formation of NEEC was the fallout out of a brainstorming meeting of the North-East Governors Forum and the Registrar of the Joint Admissions and Matriculation Board(JAMB), Prof. Is-haq Oloyede, who was invited by the Forum to address some critical issues bordering on poor enrollment and other educational matters at the 4th North-East Governors Forum meeting held in November 2020.

The meeting, which was held in Bauchi, had Governor Babagana Zulum (Borno) as Chairman, Rt. Hon Ahmadu Umaru Fintiri (Adamawa) Vice Chairman, Inuwa Yahaya (Gombe) and the host, Senator Bala Mohammed (Bauchi), in attendance, while the Deputy Governors of Yobe and Taraba States represented their respective Governors.

The Forum, in a communique issued at its mentor but also an extremely

deliberations, observed that there was a need to be aggressive in repositioning education in the subregion and, therefore, agreed to establish the Council with the mandate to improve quality of education and performance of students, as well as serving as a peer review mechanism.

The meeting had also resolved to set up a Joint Task Force to ensure the protection of schools in the region given the series of school abductions even as it took cognisance of the robust efforts of the security agencies in tackling the menace.

To effectively coordinate the affairs of the Council, the Forum appointed a veteran journalist, academic and the Bauchi State Commissioner of Education, Dr Aliyu Tilde, as its pioneer Chairman.

In furtherance of their resolutions and the presentation of the JAMB Registrar, Dr Tilde was at JAMB National Headquarters on Tuesday, 1st February 2022, to explore workable solutions to the identified issues.

The NEEC Chairman pointed out that his visit, in addition to meeting minds with JAMB, would also request data of applicants to the nation's tertiary institutions from the zone to ascertain those who meet the various cutoff points into the various categories of tertiary institutions in the country and intervening appropriately.

Earlier, Dr Tilde, in his address, described Prof.Oloyede, as not only a mentor but also an extremely hardworking, honest and proven man of integrity.

In his remarks, the Registrar commended the Commissioner on his appointment as the Chairman of the Council and expressed his optimism that Dr Tilde would deliver on the onerous responsibilities entrusted to him considering his pedigree as an academic and writer of international repute.

Prof.Oloyede also commended the character and passion for the education of the Chairman of the Forum, Bornu State Governor, Prof. Babagan Zulum, his love for the masses which was demonstrated times without numbers when he put his life on the line to make life better for the citizens of the State.

He reiterated the commitment of the Board to do everything possible within allowable limits to support the quest of the zone as it seeks to take its rightful place in the country's educational system.

The Registrar assured the NEEC that appropriate machinery had been set in motion to address the identified deficits and directed relevant functionaries of the Board to follow up on the applications of those who are genuinely qualified and had scored the minimum entry scores are admitted.

He pointed out that nobody should be ashamed of being admitted on the basis of being from an Educationally Less Disadvantaged States (ELDS) as enshrined in the national admission policy guidelines as affirmative actions are practised the world over.

TRIBUNE NEWSPAPER MONDAY, 31ST JANUARY, 2022 – UTME Now to Hold From May 6th -JAMB: The Joint Admissions and Matriculation Board (JAMB) has announced minor changes in its initial timelines for the conduct of the 2022 Unified Tertiary Matriculation Examination (UTME).

It has also introduced Computer Studies and Physical and Health Education as part of its UTME subjects for 2022. It also said it would adopt an additional optional USSD code to enable candidates to seamlessly register for the 2022 UTME without much stress or difficulty.

According to the announcement made available in the Board's Weekly Bulletin, the UTME exercise initially scheduled for April 20 to 30, would now hold from Friday, May 6 to Monday, May 16. Similarly, the mock-UTME exercise earlier scheduled for April 2, would now be held on April 16.

However, JAMB said the date for the commencement of the sale of the 2022 UTME/DE application forms fixed for February 12 to March 19 remains. Also in Daily Sun, Tuesday, February 1, 2022, Nation, Tuesday, February 1, 2022, Punch, Tuesday, February 1, 2022, Leadership, Tuesday, February 1, 2022.

VANGUARD NEWSPAPER TUESDAY, 1ST FEBRUARY, 2022 – Malpractice: WAEC Releases Withheld Results of Exonerated WASSCE 2020, 2021 Candidates: The West African Examinations Council has announced the immediate release of withheld results of West African Senior School Certificate Examination 2020 and 2021 candidates.

In a communique at the end of the 72nd meeting of the Nigeria Examinations Committee, WAEC said only results of candidates exonerated of exam malpractices were released.

The examination body also stated that it had authorised that the entire results of candidates proven to have been involved in malpractice cases be cancelled, while subject results of candidates proven to have been involved in malpractice cases which attract the penalty of Cancellation of Subject Results (CSR) be similarly cancelled. "Furthermore, some

candidates will also suffer other sanctions such as being barred from sitting the Council's examinations for two years. Some schools will be de-recognised for a specified number of years or have their recognition completely withdrawn." Also in Vanguard, February 1, 2022.

that the equipment had helped greatly in the fight against the deadly virus.



# JAMB REGISTRAR READS THE RIOT ACT TO CBT CENTRE OPERATORS

head of the 2022 Unified Tertiary Matriculation Examination(UTME) and Direct Entry(DE) Registration exercise nationwide, the Registrar of the Joint Admissions and Matriculation Board

(JAMB), Prof. Is-haq Oloyede has charged proprietors of Computer-Based Test(CBT) centres to consider their engagement with the Board as a national assignment.

The Registrar gave the charge at a virtual meeting with the proprietors of accredited CBT centres preparatory to the 2022 UTME/DE Registration exercise.

He urged the centre owners to be mindful of their sensitive responsibilities given the strategic importance of the registration exercise to the nation.

He said JAMB would continue to partner with reliable CBT centres, noting that some centres were sanctioned on account of the various infractions committed during the 2021 exercise. He added that the Board would not hesitate to do the same should any of them be found wanting. He said, "I urged you to play your roles responsibly. We would continue to identify bad eggs among you and apply necessary sanctions as the exercise is too important to the nation to be

ieopardised by the interests of a few

fraudulent individuals."

Prof. Oloyede warned against unwholesome behaviours like extortion, overnight registration, movement of routers to other locations other than the approved centre, attending to candidates by proxy, among others, adding that the Board has put mechanisms in place to detect

The Registrar extolled the virtues of the cashless regime in this year's UTME registration exercise, stating that the idea was conceived to prevent warehousing of candidates, extortion and other exploitative tendencies of some fraudulent operators of CBT centres

all forms of infractions.

To test the readiness of the centres for the upcoming UTME, the Registrar disclosed that there would be an Autobot test before the commencement of registration in the over 600 CBT centres, adding that all centres must be on approved IP addresses in addition to complying with all other regulations as laid down by the Board.

The Registrar also disclosed that the Board has approved the recommendations of the JAMB Equal Opportunity Group (JEOG) for the smooth conduct of the UTME for Blind Candidates. In the same vein, special arrangements are also being put in place to ease the taking of the examination for the Deaf Candidates in line with the recommendations of the Nigerian National Association for the Deaf (NNAD). He said the use of National Identification Number(NIN) as a precondition for registration was mandatory for all candidates, staff and ad-hoc staff.

He advised the centres to guard their sensitive equipment jealously as the Board would not take kindly to any reported loss of any sensitive equipment.

Some of the centre owners, in their interactions with JAMBulletin at the end of the virtual meeting, expressed appreciation to the Board for being a worthy partner. They said it had been worthwhile partnering with the Board in its bid to enrich the conduct of public examinations in the country. They urged the Board not to hesitate in withdrawing accreditation from centres that flout its guidelines but implored its Management to consider an upward review of their fees in view of the rising operational costs of running their centres.

## JICCS DECLARES DIVIDENDS FOR 2021 FINANCIAL YEAR

he Joint Admissions and Matriculation Board (JAMB) Staff Investment and Credit Cooperative Society (JICCS) has declared its dividend for the 2021 Financial Year.

for the e-PIN as subsidised by the Federal Government, N500 for the compulsory reading text which is paid to the publisher, and N700 regulated service charge for CBT centres, which candidates used to pay directly to the centres, but would now be paid along with the cost of the e-PINs by all candidates. The Board would later transmit all accrued entitlements to respective CBT centres on

a weekly basis or any time frame agreeable to respective centres, to curtail all noticeable infractions.

Prof. Oloyede stated that in spearheading the collection of the N700 services charge on behalf of the centres, the Board would be taking on additional responsibilities not least is the N25 commission, which amounted to over N50 million the previous year.

The Registrar enjoined all the financial institutions to live up to expectations as the vendors would be held responsible for any act of misdemeanours or infractions committed by their agents.

The vendors, in their various reactions, commended the Board for its consistency in churning out innovations aimed at safeguarding the interests of candidates. Similarly, they made useful suggestions on how to ensure a seamless flow of e-PINs from the Board to participating financial houses for speedy and prompt access by candidates.

## D CODE: 66019 THE NEW ADDITION D 55019

he Joint Admissions and Matriculation Board(JAMB) has adopted 66019 as an additional and optional USSD code besides the 55019 code that had been in operation since 2018 for UTME/DE registration and other essential services offered by the Board.

This is to facilitate a hitch-free 2022 UTME/DE registration exercise by ensuring that there is no difficulty whatsoever in the creation of profiles by candidates, especially in a situation whereby many of them would be sending their requests via just one USSD code as hitherto the case.

In essence, the 55019 and 66019 are to be used to create their profiles for registration by candidates sitting the 2022/23 UTME/DE. As usual, candidates are required to send their National Identification Number(NIN) via either of these USSD codes for their details to be pulled from the NIMC database before they proceed to any accredited centre for biometric capturing.

It would be recalled that the Board had earlier given indications that, in its efforts to eliminating all bottlenecks associated with the creation of profiles, it was perfecting arrangements aimed at adopting an additional USSD code (66019) besides the 55019, which the Board had used exclusively since 2018 for its UTME/DE registration and examination exercises.

To this end, ASD Technologies, the developer of the WhatsApp solution,

# JAMB INTRODUCES COMPUTER STUDIES AND PHYSICAL AND HEALTH EDUCATION AS UTME SUBJECTS

andidates sitting the Unified Tertiary Matriculation Examination (UTME) can now pick Computer Studies or Physical and Health Education as part of their four UTME subjects if they so desire or as dictated by their programme preferences.

This is made possible following the addition, by the Joint Admissions and

Matriculation Board (JAMB), of the two subjects to the existing 23 UTME subjects to make them 25 beginning from the 2022 UTME exercise.

This addition is to enhance the career prospects of students transiting to tertiary institutions. At present, the 23 UTME subjects are :Agricultural Science, Arabic, Art, Biology, Chemistry, Christian

Religious Studies, Commerce, Economics, French, Geography, Government, Hausa, History, Home Economics, Igbo, Islamic Studies, Literature-in-English, Mathematics, Music, Physics, Principles of Accounts, Use of English and Yoruba.

## ADVISORY TO INSTITUTIONS ON HOW TO HANDLE THE CONDONEMENT OF UNDISCLOSED ILLEGAL INSTITUTIONAL ADMISSIONS (CUIIA)

### (ADMISSIONS CONDUCTED OUTSIDE CAPS 2017-2020)

The Board introduced the **Central Admissions Processing System (CAPS)** in 2017 as the transparent platform for all admissions. Regrettably, some of the institutions continued to admit some, indeed large number of candidates (undisclosed to JAMB), thereby jeopardizing the interest of such candidates admitted through under-the table deals.

Recent events made the candidates protest the disadvantages of such non-disclosure and lack of formal recognition of their degrees. Such Institutions are now being compelled by necessity to confess their past deeds of undisclosed admission.

This Advisory is to guide the affected institutions on how the candidates can be rescued:

- I. The institutions should first and foremost declare the number of candidates admitted outside CAPS by sending a formal letter of confession and disclosure (LCD) to the Registrar of JAMB.
- ii. The letter of confession and disclosure shou<mark>ld have</mark> the list of candidates attached. A copy of the letter and the list of candidates should be sent to JAMB state office where the institution is located. The list and total number of affected candidates for each year of admission should be clearly specified with the Programme (i.e Course of Study).
- iii. If the Board upon receiving the letter (and after due scrutiny and investigations) grants approval, the institution shall be contacted within 2 weeks of acknowledged receipt of the LCD.
- iv. The portal is then opened for the Institution to upload the list of candidates already submitted.
- v. The letter of approval from JAMB to the institution and the uploaded list shall contain the following:
  - the academic year for which the retroactive approval is granted;
  - total number of candidates, and
  - the period of grace (not exceeding 60 days) within which the affected candidates must complete the process of Condonement of Undisclosed Illegal Institutional Admission (CUIIA). Only the candidates declared by the institutions are to visit JAMB office and complete the appropriate form online after paying the prescribed fee (i.e) the application fee of N4,000 only is paid by those without JAMB Registration number for the year and N5,000 penalty paid by every candidate involved.
- vi. The records of the candidates shall then be made available on CAPS after they have completed the online process.
- vii. The Admission Officer of the Institution shall retroactively propose formally the candidates to the Head of Institution who in turn shall recommend the candidates within the specified time.
- viii. The JAMB Desk officer too, shall retroactively approve the candidates on CAPS within the original list submitted by the institution. After approval, the previously illegal students will be able to print their JAMB admission letters from e-facility on JAMB Portal.
- ix. It should be noted that the admission letter would henceforth carry the date of the retroactive approval and not backdated to protect the Board's integrity of the data it might have provided before the condonement. The admission letter would also be named "Retroactive Letter of Admission" to reflect the correct history of the admission.
- x. Please **NOTE** that only candidates on the list declared by the institutions shall be attended to at the JAMB office. The Board shall not extend the period of grace granted to each institution. Any candidate that does not complete the process within the allotted (maximum two months) grace period loses the remedial opportunity.
