he National Tertiary Admissions Performance Merit Awards (NATAP-M Awards) instituted by the Board, is fast becoming one of the notable educational awards in Nigeria.

### ABIA STATE COORDINATOR TASKS STAFF ON MAINTENANCE CULTURE

call has gone to the members of staff of the Abia State Office of the Board to jealously guard the infrastructural facilities in their respective Units and Departments, which were provided by the Management for their comfort and that of visitors.

This call was contained in a statement made available to JAMBulletin at the end of an interactive workshop titled: "Imbibing a Maintenance Culture" organised by the Abia State Coordinator, Mr. Johnson Adebiyi, for members of the State Office.

According to the State Coordinator, the workshop was designed to inculcate in staff, the habit of regularly and consistently, maintaining, for optimal use, all fixed and movable items meant to make life more meaningful for them for effective discharge of their duties.

Also, Mr Adebiyi disclosed that ensuring that all Board's facilities are put to proper use would not only reduce maintenance costs, especially in view of the current economic realities in the country, but also inculcate in the staff a sound maintenance culture.

Consequently, the staff are charged to form the habit of regularly and consistently keeping the Board's buildings, items of equipment, electrical appliances, facilities, machines, motor vehicles, infrastructures, among others, in prime condition. He decried a situation whereby many of these items of comfort are being misused on a daily basis.

Furthermore, he stated that many of the incidence of fire outbreaks recorded in government offices are as a result of the nonchalant attitude of some staff who would, for instance, not care to switch off electrical appliances at the close of work. He, therefore, admonished staff to develop a positive attitude towards handling all Board's facilities by seeing these them as their own.

At the end of the training, many of the participants expressed their gratitude to the Coordinator for his efforts at repositioning the State Office for a more robust and efficient service delivery.

# JAMB HOLDS 3RD PHASE OF PSYCHOMETRICS TRAINING FOR EDUCATORS IN OYO, JIGAWA STATES

he Joint Admissions and Matriculation Board (JAMB) has held the third phase of its landmark "Trainings in Test Development and Psychometrics Series" for tertiary institution lecturers and secondary school teachers, particularly those who did not have their background in Education, simultaneously in Ibadan, Oyo State, and Dutse, Jigawa State, between Monday, 1st to Friday, 5th August, 2022. The trainings were organised by the Board to democratise test development and psychometrics practices through enhancing the participation of more professionals through partnership and collaboration. The theme of the workshop is "Critical Assessment Competences for Secondary Education Teachers and Tertiary Education Lecturers in Nigeria."

In his opening remarks on the occasion, the Registrar, who was simultaneously represented by Director of Quality Assurance, Mrs. Mabel Agbebaku, in Ibadan and Director of Test Development Department, Mr. David Akanbi, in Dutse, said as educators, "participants have a responsibility of redirecting our nation towards the path of progress." Speaking further, the Registrar said the driving force behind the organisation of the programme was the pursuit of excellence, to clearly improve secondary and tertiary education in Nigeria, and to democratise test development and psychometrics processes towards improving the quality of assessment and enhancing the educational sector at large.

The Registrar further elucidated on the practicalities of psychometric competences as theorised in the modules presented and implored participants and facilitators to adopt scientific testing through the infusion of psychometric values towards the elevation of assessment practices as well as taming the hydra-headed monster called examination malpractice. Hence, the training, according to him, would focus on the exploration of all aspects of assessment from a scientific viewpoint in order to prioritise psychometric literacy.

The Chairman of the workshop, Prof. B.G Nworgu, set the tone for the technical modules formulated for the workshop in collaboration with participants and facilitators drawn from different institutions in all the geopolitical zones of

#### the country.

The central message of the workshop, which was amplified by Prof. Tony Afemikhe in his module titled: "Conceptual and Policy Issues in Assessment". In the presentation, the assessment guru explained the role of policy and implementation by instructors which he asserted would make for informed testing procedures, motivation of instructors and policy evaluation by policymakers.

In another brilliant presentation by a renowned Psychometrician, Prof. Bayo Lawal, presentations were drawn from diverse works on competence and assessment with the aim of discovering how feedbacks from all parties could aid the democratisation of test development and psychometrics procedures to further improve assessment practices.

Other areas of discussion included: "Quality and Confidence in Assessment", "Administration of Test and Scoring", "Feedback and Reporting", "Understanding Test Scores", "E-testing" and "Credibility Issues in Examination." Adequate attention was also paid to such concepts as validity, reliability, fairness, integrity of the test process, aggregation

The affected persons missed the examination over issues such as fingerprint peculiarities; technical problems in some centres and Biometric Verification challenges, according to the data collated from the website of the Joint Admissions and Matriculation Board by our correspondent on Sunday.

The data also showed that some candidates had their examination cancelled due to malpractices in 10 examination centres across five states.

BLUEPRINT NEWSPAPER MONDAY AUGUST 1ST 2022 - JAMB Opens Up On Cut-Off Point For Admission To Nigerian Universities: The Joint Admissions and Matriculation Board (JAMB) has explained that there is nothing like uniform admission cut-off marks as the recently adopted 140 is a baseline and not uniform cut-off mark for admissions to Nigerian universities as being speculated. JAMB said, "The 140 score in the Unified Tertiary Matriculation Examination (UTME) is only a minimum benchmark for universities to consider for admissions."

The Board added that it has no hand in setting the benchmark, noting that it was a collective decision among all tertiary institutions in the country.

This clarification, contained in a statement by Fabian Benjamin, JAMB's head of public affairs and protocol, was in response to a comment by a former president of the Academic Staff Union of Universities (ASUU), Nasir Fagge, who during an interview suggested that JAMB, as an agency, decides the uniform minimum UTME points required for admission. # **PARENTAL INFLUENCE: BANE OF EXAMINATION - JAMB**

Under the challenges militating against the effective nurturing of future leaders for the country. This was the position of the three-man delegation from the Joint Admissions and Matriculation Board (JAMB) on the NTA morning show, "Good Morning Nigeria". The Board made that assertion while fielding questions from panalists on the 'Review of 2022 UTME' on the programme.

"Some parents, in their desperation, are always hell-bent on following their wards to the examination centres even into the examination hall and any resistance by the officials at the centre sometimes leads to assaults," the trio stated.

Speaking further, a member of the Board's delegation pointed out that the desperation being exhibited by these parents could be attributed to their desire to add their children's profiles to their own as they craved such titles as "Medical Doctor's father", "Lawyer's mother", among others. Hence, they would go to any length, whether legal or otherwise to compromise the process such as getting underhand admissions for their children, sending their underage children to early-childhood schools, registering them for First School Leaving Certificate Examination in Primary Five as against Primary Six, as well as pushing

them to take the Senior School Certificate Examination at SS 2 instead of SS 3.

Hence, these children, who are not psychologically matured enough for tertiary education, are exposed to series of anti-social behaviours such as cultism, prostitution, fraud and other vices.

The Board's delegation on the programme included: the Registrar, Prof. Is-haq Oloyede, who joined virtually via zoom, Mr. Fabian Okoro, Director of Information Technology Services, Dr. Fabian Benjamin, Head, Public Affairs and Protocols, and Mr. Abdulahi Ashura, Assistant Director, Registrar's Office.

#### ...NATAP-M Awards Has Impacted on Profile and Global Ranking of ABU - Vice-Chancellor

The Vice-Chancellor, Prof. Kabiru Bala, received the three prizes won by the University while describing the epochmaking event as encouraging, stating that ABU would use the prizes won to further improve on the infrastructure of the University.

The renowned Professor of Construction Management, in a chat with JAMBulletin, attributed the winning streak exhibited by the University, to the adherence to the ideals of its founding fathers.

Speaking further, he said, "More profoundly was the declaration of the first Chancellor of the University, the Premier of Northern Nigeria, Sir Ahmadu Bello, who declared at his investiture ceremony on 23rd November, 1963, that: "The cardinal principle upon which our University is founded is to impart knowledge and learning to men and women of all races without any distinction on the grounds of race, religious, or political beliefs."

"This principle is enshrined in the University Law. Only through freedom of membership and freedom of enquiry and research can a university be drawn into the full ferment of thought from which new knowledge comes. Only if it adheres to those freedoms can it become truly great. If our staff and students are drawn from all parts of the world, then the mixture of international minds working together in an atmosphere of academic freedom can produce a university true to its ideal and meaning," he said.

Commenting on the impact of the NATAP-M Awards on the institution, Prof. Bala said, "Apart from the physical improvements of our facilities that we achieved through the proceeds of the award, the Awards has positively impacted on the profile, visibility and global ranking of the University. For instance, we were able to improve on the physical facilities of our University, the quality of programmes we air on our Campus FM Radio Station, as well as the rehabilitation of some campus roads and carry out further development on some aspects of the Phase II of our University." While reacting to the perception of the NATAP-M Awards as a promoter of excellence and service compliance, he said, "Like every human endeavour, reward for compliance with set standards is fulfilling and boosts self-esteem and also acts as motivator to others to strive. This is in line with global best practices."

On the advice to the Board on consolidation of the Awards, the University Don said, "It would not be out of place to reduce the gap between the prize money of grand winners and the runners-up. In addition, he suggested that rather than giving flat rates, the Awards prize money could also be weighted in accordance with their impact in the fulfillment of the broad goals of Nigeria's higher education sector in terms of access, inclusivity and diversity."

Fielding questions on his future ambition towards making the University greater than he met it, the hardworking Vice-Chancellor said, "I have the very ambitious goal of launching ABU, Zaria, into the league of top 100 Universities in the Times Higher Education (THE) world ranking of universities in addition to achieving financial self-sufficiency by the year 2062, when the University would have attained its centenary."

"My desire is to carve a niche for the University and to consolidate on the gains of my predecessors and make the institution the best in the world through sustainable growth and development based on adherence to the University Law, Statutes, Policies, Regulations and Plans. # JAMB CONSOLIDATES SECURITY FEATURES ON Admission documents

In accordance with its firm belief in transparency while safeguarding the interests of its teeming population of aspiring candidates from the wiles of fraudsters, who, on a daily basis, prey on innocent candidates, the Board has rejigged its security architecture for improved performance.

While sharing some security tips with participants during the just-concluded 2022 Policy Meeting on Admissions, held at the International Conference Centre (ICC), Abuja, the Registrar, Prof. Is-haq Oloyede, disclosed that institutions, parents and candidates alike should, as a matter of policy, always authenticate the genuineness of all admission documents as they feature potent security features.

Speaking further, he stated that some of these security features are embedded in the barcodes on all admission-related documents, Registration, Examination, and Result Slips, as well as Admission Letters, among others, adding that the barcodes could be decoded with JAMB QR Scanner available on Google PlayStore for Android users and Apple Store for iphone users.

The Registrar added that other noticeable features embedded in the barcode include: Candidate's Registration Number, Name, Course, Institution of Choice and other items of biodata. He noted that the barcode facility was not new as it was introduced in 2018 and had undergone tremendous improvements since then to make it more user-friendly and accurate.

#### ...JAMB Conducts 2022 Mop-Up UTME for 40,399 Candidates Nationwide

Joint Admissions and Matriculation Board (JAMB), in the spirit of equity and fairness, has conducted a mop-up examination for the affected candidates numbering about 40,399 candidates on Saturday, 6th August, 2022.

The mop-up examination, which took place in (45) centres across the country, was seamless given the various measures put in place by the Board for a hitch-free exercise.

It would be recalled that ahead of the exercise, a series of stakeholders' meetings were held both virtually and physically to sensitise examination officials and emplace all necessary logistics for the smooth conduct of the examination.

In a statement made available to JAMBulletin on Thursday, 4th August, 2022, 40,399 candidates were expected to participate in the examination across the 36 States of the Federation including the Federal Capital Territory, Abuja.

According to the statement, topping the list of the rescheduled candidates was Imo State with the total number of 8, 913 candidates. This was followed by Anambra State with 5,786 while Lagos State had 5, 143 and Adamawa State, the least, with 65 candidates.

On a general assessment, the 2022 mop-up examination was a huge success.

The Registrar, Prof. Is- haq Oloyede, who monitored the conduct of the examination in some centres in Lagos,

commended the process and gave assurances that the selection of centres for the 2023 UTME would eliminate all instances of centre failure on account of technical challenges.

The Registrar was accompanied on the monitoring exercise by the Director, General Services, Mr. Mohammed Shehu; the Director, of Legal Services, Dr. Abdul Wahab Oyedukun and the Head, Public Affairs & Protocols, Dr. Fabian Benjamin.

### **FEW FACTS ABOUT JAMB**

- The Joint Admissions and Matriculation Board (JAMB) was established for the general control of the conduct of matriculation examinations for admissions into all universities, polytechnics, monotechnics, colleges of education and (recently added) Innovation Enterprise Institutes (IEIs).
- Section 5 (2)of the ACT establishing the Board provided as stated: For the avoidance of doubt, the Board shall be responsible for determining matriculation requirements and conducting examinations leading to undergraduate admissions and also for admissions to National Diploma and the Nigerian Certificate in Education courses, but shall not be responsible for examinations or any other selective process for postgraduate courses and any other courses offered by the tertiary institutions. In the implementation of this section, there is always a synergy with the National Universities Commission(NUC), the National Board for Technical Education(NBTE) and the National Commission for Colleges of Education(NCCE) with the endorsement of the National Council on Education(NCE).
- In exercising this power, the Board is always guided by admission guidelines approved by the Policy Meeting under the Chairmanship of the Hon. Minister of Education with all Heads of Tertiary Institutions and other stakeholders in attendance.
- Since the inception of the Interim Joint Matriculation Board Examination (IJMBE), JAMB appoints moderators for all its questions as well as the grading of candidates scores. It has always done this without failing to still accommodate 'HSC' within the current 6-3-3-4 system. The National Council on Education(NCE) guidelines for the Joint Universities Preliminary Examinations Board (JUPEB) also endorsed the practice for JUPEB.
- The Joint Admissions and Matriculation Board shall continue to operate within its laws.

### POLICY MAKERS URGED TO EXEMPT CANDIDATES WITH SPECIAL NEEDS FROM POST-UTME

s part of measures aimed at facilitating robust enrolment of Landidates with special needs into the nation's tertiary institutions, participants at the 2022 Policy Meeting on Admissions held at the International Conference Centre (ICC), Abuja, on 21st July, 2022, and chaired by the Hon. Minister of Education, Malam Adamu Adamu, appealed to all stakeholders on admissions, especially the tertiary

institutions and other regulatory agencies, to approve the exemption of candidates with special needs who have met basic requirements for admissions from further partaking in any entrance screening, popularly known as Post-UTME.

The Board, which believes firmly in the popular saying that "disability is not inability", stated that this category of candidates should not be burdened with excessive screenings that could adversely impact their upward educational mobility.

Listed as intended beneficiaries of this gesture, are candidates with visual or hearing impairments, prison inmates and foreign candidates who sat their UTME from another country whether they are Nigerians or otherwise.



## MOP-UP UTME: JAMB CHARGES NSCDC TO BE VIGILANT

head of the 2022 Mop-Up UTME scheduled for Saturday, 6th August, 2022, the Joint Admissions and Matriculation Board (JAMB) has charged the Nigeria Security and Civil Defense Corps (NSCDC) to be vigilant to tackle any form of threats to the sanctity of the examination.

The Registrar, Prof. Is-haq Oloyede, gave this charge at a virtual meeting with top officials of the NSCDC on Wednesday, 3rd August, 2022.

The Registrar, in his address, urged all examination officials to be at alert with a view to nipping in the bud any act that could undermine the conduct of the examination. Prof. Oloyede pointed out that the meeting was necessary to evaluate the security measures that had been put in place to checkmate all sorts of roguish behaviours that might be unleashed by unscrupulous elements hell-bent on compromising the smooth conduct of the exercise.

According to him, "The Unified Tertiary Matriculation Examination (UTME) is critical to the Board and the nation. If we fail in its smooth conduct, it would greatly affect the nation, hence, we need to make sure that no stone is left unturned to checkmate any sharp practices." While recalling the observed security breaches during the 2022 UTME, the Registrar pointed out that the conduct of the Mop-up UTME was a consequence of these series of security lapses occasioned, in most cases, by the greed of some of the personnel of the Corps who were compromised by unscrupulous elements to sabotage an examination that had hitherto, commenced on a successful note.

The Registrar further noted that the negative effects of these nefarious acts were not confined to only the candidates but also to the Board, which had to deploy extra resources to conduct another examination, and some examination centres, which were delisted and barred from future participation in the examination. In his words, "Some centres were cancelled, results of criminally-minded candidates withheld and many innocent candidates psychologically traumatised as they had to resit the examination. Therefore, it is essential that this second chance given to these candidates should not be ieopardised under any guise."

"We need to tell ourselves the truth as partners and stakeholders as there were a lot of security lapses during the conduct of the 2022 UTME. This is because we received series of reports of security personnel colluding with 'paid examination takers' and even parents to compromise the examination. This act is unacceptable and the Board would not condone it," he warned.

The Board's helmsman also stated that those corrupt officers were the bad eggs giving the NSCDC a bad name and urged the Corps Commandants to take necessary action against those found culpable while ensuring that only officers of sound reputation were drafted to provide security during the conduct of the Board's examinations at all times.

Speaking on behalf of the Commandant-General, Dr. Ahmed Audi, Deputy Commandant-General, (DCG) Claudius Yakubu, Head, Directorate of Critical National Assets and Infrastructure (CNAI), assured the Board of a seamless Mop-Up UTME as only tested and trusted officers would be deployed to the examination centres. He said, "The NSCDC has enjoyed a remarkable relationship with the Board over the years and we would do our best to ensure that adequate security measures are in place to thwart any security threat."

### ADVISORY ON EXTENDING THE SCOPE OF SERVICE FOR CBT CENTRES

Following persistent requests from CBT centres, the Board has approved that some services hitherto, restricted to JAMB Offices, be extended to other approved CBT centres.

- 2. These services being extended to the CBT centres are registrations for:
  - (i) Part-time
  - (ii) NOUN
  - (iii) Sandwich
  - (iv) Distance Learning
- 3. The following steps are to be followed by each centre while attending to these category of candidates:
  - a. First create a Profile for the candidate (note that profile creation is free);
  - b. Login to the Candidate's Profile on e-Facility;
  - c. Expand the "Other Registrations" Tab and select the appropriate registration for the candidate;
  - d. Follow the prompts to make the payment of N3,500 application fees online using the candidate's ATM card (do not collect any candidate's card details, let the candidate be the one to enter his/her card details);
  - e. After payment, the centre will proceed to register the candidate on the Registration App platform and print out the Registration Slip.
  - f. For DE candidates of 2017 onwards, after registration, only the Registration Slip is to be given to them as the candidate's registration information goes straight to CAPS;
  - g. For candidates of year 2016 and before, after registration, the centre is expected to give them both the Registration Slip and an Indemnity Form;
  - h. The service charge for this type of registration is N700 only and payable directly to the centre.
- 4. Do not write down or copy any vital data of the candidates such as card details, profile code, password etc.
- 5. Recall that like the UTME/DE, the template is to be uploaded while candidates are to go away with the original (hard copy) template.
- 6. CBT centres shall abide by the rules as severe sanctions would be meted out to infractors.

### ADVISORY TO INSTITUTIONS ON HOW TO HANDLE THE CONDONEMENT OF UNDISCLOSED ILLEGAL INSTITUTIONAL ADMISSIONS (CUIIA) (ADMISSIONS CONDUCTED OUTSIDE CAPS 2017-2020)

The Board introduced the **Central Admissions Processing System (CAPS)** in 2017 as the transparent platform for all admissions. Regrettably, some of the institutions continued to admit some, indeed large number of candidates (undisclosed to JAMB), thereby jeopardizing the interest of such candidates admitted through under-the table deals.

Recent events made the candidates protest the disadvantages of such non-disclosure and lack of formal recognition of their degrees. Such Institutions are now being compelled by necessity to confess their past deeds of undisclosed admission.

This Advisory is to guide the affected institutions on how the candidates can be rescued:

- I. The institutions should first and foremost declare the number of candidates admitted outside CAPS by sending a formal letter of confession and disclosure (LCD) to the Registrar of JAMB.
- ii. The letter of confession and disclosure should have the list of candidates attached. A copy of the letter and the list of candidates should be sent to JAMB state office where the institution is located. The list and total number of affected candidates for each year of admission should be clearly specified with the Programme (i.e Course of Study).
- iii. If the Board upon receiving the letter (and after due scrutiny and investigations) grants approval, the institution shall be contacted within 2 weeks of acknowledged receipt of the LCD.
- iv. The portal is then opened for the Institution to upload the list of candidates already submitted.
- v. The letter of approval from JAMB to the institution and the uploaded list shall contain the following:
  - the academic year for which the retroactive approval is granted;
  - total number of candidates, and

.

the period of grace (not exceeding 60 days) within which the affected candidates must complete the process of **Condonement of Undisclosed Illegal Institutional Admission (CUIIA)**. Only the candidates declared by the institutions are to visit JAMB office and complete the appropriate form online after paying the prescribed fee (i.e) the application fee of N4,000 only is paid by those without JAMB Registration number for the year and N5,000 penalty paid by every candidate involved.

- vi. The records of the candidates shall then be made available on CAPS after they have completed the online process.
- vii. The Admission Officer of the Institution shall retroactively propose formally the candidates to the Head of Institution who in turn shall recommend the candidates within the specified time.
- viii. The JAMB Desk officer too, shall retroactively approve the candidates on CAPS within the original list submitted by the institution. After approval, the previously illegal students will be able to print their JAMB admission letters from e-facility on JAMB Portal.
- ix. It should be noted that the admission letter would henceforth carry the date of the retroactive approval and not backdated to protect the Board's integrity of the data it might have provided before the condonement. The admission letter would also be named **"Retroactive Letter of Admission"** to reflect the correct history of the admission.
- x. Please NOTE that only candidates on the list declared by the institutions shall be attended to at the JAMB office. The Board shall not extend the period of grace granted to each institution. Any candidate that does not complete the process within the allotted (maximum two months) grace period loses the remedial opportunity.
