



NATION NEWSPAPER TUESDAY 4TH JANUARY, 2022 — Nigeria Accounts for 28% of African Edtech Companies: The Director-General, National Information Technology Development Agency (NITDA) Mr Kashifu Inuwa Abdullahi, has said Nigeria currently has 28per cent of education technology (edutech) companies in sub-Saharan Africa which he said had generated about \$3.46million in 2020.

The DG, while speaking at the maiden National Conference on Functional Education at Bilyaminu Polytechnic, Hadejia, organized by the Centre for Semi-Arid Research and Development said: "It is important to seek to explore the benefits of innovations and creativity to bring about the functional education system for the country."

PUNCH NEWSPAPER TUESDAY 4TH JANUARY, 2022 – UBEC Accuses States of Failing to Fund Basic Education: The Chairman, Governing Board of the Universal Basic Education Council, Prof. Adamu Usman, did not accuse state governments of allegedly abdicating the responsibility of funding basic education in their states to the councils but only stated the position of unclaimed allocation due to the inability of most states to pay the counterpart funds expected of them.

PUNCH NEWSPAPER TUESDAY 4TH JANUARY, 2022 – Prevailing Circumstances Beyond the Board's Control to Delay UTME Registration-Says JAMB: The Joint Admissions and Matriculation Board (JAMB) has announced that pre-examination activities, including registration for the 2022 Unified Tertiary Matriculation Examination would start late due to forces beyond its control.

The Board also defended its decision to enforce the National Identity Number requirement in the registration process. The Head, Public Affairs and Protocol, JAMB, Dr Fabian Benjamin, said, "Most of the Board's pre-examination activities, including the 2022 UTME registration, are starting late owing to some circumstances beyond our control. We are, however, ready to do all that is necessary not only to meet up with the schedule but also to make the 2022 UTME registration and examination the best so far. The decision of the Board to implement the NIN is a game-changer in the fight against impersonation."

TRIBUNE NEWSPAPER THURSDAY 6TH JANUARY, 2022 – FG Set to Review Secondary Schools' Curriculum: The Executive Secretary of National Senior Secondary Education Commission (NSSEC), Dr Benjamin Abakpa, said, "The

Federal Government is already in the process of reviewing curricula being used for teaching and learning in secondary schools in the country." This move became necessary due to calls from stakeholders in the education sector who are worried that graduates of secondary education in Nigeria lack employable and requisite skills to function in the society as such artisans and other skilled workers are imported into the country from neighbouring countries.

He also revealed that the Nigerian Educational Research and Development Council (NERDC) had been directed to work with other relevant agencies of the government to undertake the review of the curriculum, adding that NSSEC is one of the agencies collaborating with NERDC to achieve this goal.

<u>Digitisation Project:</u> The Tertiary Education Trust Fund (TETFund) has commenced a process to digitise thesis and projects in tertiary institutions of learning to ensure seamless access to research outputs and end the 'evil' of plagiarism.

Its Executive Secretary, Prof Suleiman Bogoro, made this known at a workshop on thesis digitisation project for beneficiary institutions in Abuja. According to him, "The world has gone digital and we cannot continue to operate analogue. We know that several materials from thesis at the postgraduate level and even undergraduate have disappeared."

He also pointed out that this transformation would assist in checking plagiarism by researchers at any level.

He explained further that the decision of TETFund to fund the digitalisation of the thesis would shore up the ranking of universities and other tertiary institutions in the country, noting that plagiarism in higher institutions had become a source of worry.

The President was said to have spoken through a director of the commission, Mr John Ahmadu, at the Federal University, Oye-Ekiti, Ekiti State.

He said, "The unions can do more to assist in addressing these issues for a much better university system. Funding is a major problem confronting the Nigerian university system as well as the primary basis of incessant industrial actions in the ivory towers. We will continue to support the university system through improved funding and infrastructural development. In this regard, my government has repositioned the TETFUND to be able to address the infrastructural gaps in our tertiary institutions."

He tasked them to carefully select their priorities based on adequate planning and budgetary provisions. He said that the ability to establish a sustainable balance between short, medium and long term priorities of an institution was an important hallmark of developmental leadership.

#### **EXPEDITE ACTION ON COMPLETION OF 2021 ADMISSION EXERCISE - IAMB**

Il tertiary institutions in Nigeria have been called upon to expedite action on the completion of the 2021 Admission exercise.

This call became necessary following the negligible number of fully-processed 2021 Admissions on the Central Admissions Processing System (CAPS) out of the teeming population of eligible candidates with the requisite qualifications yearning for admission.

The Board is aware of the numerous challenges that have impacted the academic calendars of tertiary institutions as well as the smooth processing of admission requests but urged them to devise acceptable means of closing the gap and complete the 2021 Admission exercise on schedule.

The Director of Admissions, Mr Mohammed Babaji Ahmed, while briefing some selected institutional Desk Officers, implored them to interact with their respective institutions to ensure that even if they are not ready for the students to resume, they can conduct such admissions prior to their respective chosen resumption dates to enable their candidates know their fate.

He also disclosed that the Board was on the verge of rolling out the 2022 UTME application documents hence the need for Desk Officers to be proactive. He expressed the resolve of the Board to prevent candidates from incurring unnecessary expenses through buying new e-pins that they may not use if they are eventually admitted.

The Director decried the situation whereby only about one hundred thousand candidates have been processed out of the over six hundred thousand eligible candidates.

It would be recalled that over 1.4m candidates registered for both the 2021 Unified Tertiary Matriculation Examination(UTME) and Direct Entry(DE) out of which only about 600,000 possessed the requisite qualifications to be admitted based on available records with the Board.
