IMPERSONATION: EDUCATION MINISTER'S DIRECTIVE ON USE OF IMAGES AND BIOMETRIC YIELDING RESULTS

-Directive, A Potent Weapon To Break The Backbone In Public Examinations... Says JAMB

What appears to be yet another vindication of the potency of the directive of the Hon. Minister of Education on the mandatory use of pictures taken during Unified Tertiary Matriculation Examination (UTME)/ Direct Entry (DE) candidates' registration by institutions to forestall impersonation, came to light

recently with the arrest of the duo of Mr. Buhari Abubakar Ismail and Mr. Mohammed Ajeru in Kano.

Mr. Abubakar, a candidate, had paid Ajeru to source for an examination-taker to sit the UTME 2020 for him, on the basis of which he secured admission into Bayero University,

Kano (BUK). However, the arrangement ran into hitches when all the candidate's details including his identity card carried the passport of the hired examination-taker. This scoop was made possible because BUK had complied fully with the

ministerial directive that only data supplied by candidates during registration should be used by institutions during the fresher's registration. The decision was a drastic measure to break the backbones of impersonators.

Mr Abubakar had sought ways he could change the passport of the examination-taker to his own but was unsuccessful in the course of which he was arrested. He had even sworn an affidavit falsely in his desperation to replace the image on his identity card. It would be noted that were it not for the implementation of the policy, this particular candidate would have brought in a fresh passport and got himself properly registered into the university without anyone being the wiser. This is just one out of the many arrests that the Board had made in recent times with respect to candidates who hired 'mercenaries' to sit the examination only to discover that they cannot change the images and biometric attached to their details.

PUNCH, TUESDAY, FEBRUARY 9, 2021- Nigeria's COVID-19 Vaccine Candidate on WHO List- Researcher: The leader of the vaccine candidate research, Dr. Oladipo Kolawole, who is also a lecturer at the Adeleke University, Ede, has announced that the COVID-19 candidate vaccine developed by Nigerian researchers has been listed on World Health Organisation draft landscape of COVID-19 candidate vaccines. Kolawole said the research was carried out at the Helix Biogen Consult, Ogbomoso, Oyo state.

The WHO draft landscape is the list of all COVID-19 vaccine candidates in the world, showing different stages and it is usually found on WHO's site. Kolawole said there were 235 candidate vaccines on the list and two were from Africa; Nigeria and Egypt.

He explained that the candidate vaccine would boost the economy of Nigeria if given the needed support, adding that it would be important for the government to find local solutions to the country's challenges instead of depending on western countries.

NATION, MONDAY, FEBRUARY 8, 2021- UNILORIN Researchers Develop New Maize Breed: Researchers in the Faculty of Agriculture, University of Ilorin have developed a new breed of maize, named ILOMAZ-1. Prof. Gbolagade Adesiji, a former Ag. Dean of the Faculty made this announcement recently in Ilorin.

Adesiji said that the research effort that

produced the innovation was done in collaboration with the International Institute of Tropical Agriculture (IITA), Ibadan. The don said, "The grains have been approved for release and cultivation by farmers in different agro-ecologies of Nigeria by the National Variety Release Committee (NVRC)." He assured farmers that the grains would be readily available to them during the 2021 growing season. **Also in Thisday, Wednesday, February 8, 2021.**

THISDAY, THURSDAY, FEBRUARY 11, 2021- 52 Varsities to Feature in HiFI 2021 Tournament: A total of 52 universities are expected to be part of this year's Higher Institution Football League (HiFL) with over 50 games to be played across 20 cities in 18 weeks of the third edition in the fourth year of the competition. Pace Sports and Entertainment Marketing Company, organisers of the event said that it has concluded plans to stage a special edition this year noting that the event could not hold last year due to the ongoing pandemic in the country.

Director, Pace Sports and Entertainment Marketing, Sola Fijabi, however, announced that the 2021 edition would be staged in compliance with COVID-19 protocols in a special way. **Also in Guardian, Wednesday, February 10, 2021.**

PUNCH, FRIDAY, FEBRUARY 12, 2021- Turkey Gives 90% Tuition Waiver to Students, Says Coordinator: The International Relations Coordinator of Tokat Gaziosmanpasa University, Turkey, Prof. Kubilay Ozyer, says Turkey gives a 90 per cent tuition waiver for African students.

Ozyer made this known at the Goodmus Learning Centre, Lagos, while supervising the foreign students' entrance examination into Turkish Universities. He explained that the examination was organised to test students' intelligence quotient in philosophy and logic.

He said, "Turkish government has subsidised the tuition, food and accommodation. Nigerians have chances to have high quality education and affordable education in Turkey". The CEO, Goodmus Learning Centre, Mr. Adekunle Badmus, explained that the ongoing

entrance examinations into Tokat Gaziosmanpasa University in Turkey would help students discover their right field of study.

PUNCH, FRIDAY, FEBRUARY 12, 2021- Implementation of SDG 4,5 Attainable in Africa- Sanusi: A former Emir of Kano State, Sanusi Lamido Sanusi, has said the implementation of Sustainable Development Goals in Africa is attainable. Sanusi made this known at the virtual orientation of the ten finalists of the Muhammad Sanusi II Sustainable Development Goals Challenge which was announced in early January 2021.

The 10 finalists, who would receive a five hundred dollar grant which would be used to fund their individual educational project, with a goal of incubating and scaling up 150 projects in the next 10 years, were selected based on the inventiveness and originality of their ideas.

Caught In Examination Infraction: The Joint Admissions and Matriculation Board announced that it would cost about N100m for it to effectively prosecute 200 of the over 400 persons involved in impersonation in the 2020 UTME. The directive, however, has paid off as the Board paraded 2 suspects, Buhari Abubakar and one Ajero, for offence of impersonation at its headquarters in Bwari, Abuja. Both Abubakar and Ajero confessed to the crime with the later indicating that he was paid the sum of 20,000 naira to hire an examination-taker on behalf of the former. Not happy with the development, especially as over 400 candidates currently seeking admission into the nation's tertiary institutions were

involved in this fraud, the Registrar called on all institutions to be diligent in the process of registering their candidates to fish out those with different images and biometrics. compromise standard and quality for mediocrity, noting that the desire to have positive narratives about the Board's selection processes was his cardinal objective. As such, he said he had been unwavering in proffering enduring solutions that would enhance the integrity of public examinations devoid of any unwholesome practices.

He said, "When we take certain decisions, there are some who understandably may not know the reason or the rationale behind it, you will recollect that we are very strict about the issue of missing SIM cards used in registering for the UTME or DE early this year and, of course, a large number of candidates have complained that they had lost their SIM cards and the Board had refused to condone their request to either accept substitute SIMs or bypass its use. It 'll be irresponsible for us to condone such because as a government agency, we are aware of what the government is doing to sanitise the ownership of SIM to allow candidates to

circumvent the well-meaning security process and other essential provisions of a registered SIM."

"It is interesting to note that rather than doing a welcome back of their lost SIMs, many of these candidates had resorted to blackmail, not knowing that blackmail does not work with JAMB as we are poised to safeguarding the integrity of the nation and the credibility of our system."

The Registrar also lauded the directive of the Hon. Minister of Education, Mall. Adamu Adamu, that no institution should take a fresh passport or biometric details of their intakes other than the ones these candidates took while registering for either UTME or DE and which the Board had subsequently forwarded to the various institutions. He stated that this decision had gone a long way in curbing the incidences of impersonation in public examinations in the country.

He added, "As for us in JAMB we are monitoring all institutions for compliance on our platform. We have devised means through relevant technology to know

whether institutions would discover cases of impersonation and report or not. At the right time we will make full disclosure of those we know are aiding and abetting impersonation."

The JAMB boss added that tertiary institutions engaging in change of photographs and biometrics of candidates contrary to the directive of the Minister would be sanctioned appropriately. He warned that any public institutions that violates the directive would be treated as an accomplice and named, and shamed, while private institutions could have their licences withdrawn.

Prof. Oloyede appealed to the various institutions to be vigilant while registering their admitted candidates while advising candidates who wished to engage impersonators to shelve the idea as there is nothing they could do that would not be detected at the appropriate time.



AL-ISTIQAMAH UNIVERSITY VISITS JAMB, SEEKS CLOSER TIES

The Vice-Chancellor, Al- Istiqamah University, Prof.Salisu Shehu, has sought the support of the Joint Admissions and Matriculation Board (JAMB) toward the successful take-off of the institution.

Others are B. Sc. Biology, Chemistry, Mathematics, Computer Science,

Software Engineering and B. Sc. Physics with Electronics.

The Registrar, Joint Admissions and Matriculation Board, Prof. Is-haq Oloyede, in his response, congratulated Prof. Shehu on his appointment as the pioneer Vice-Chancellor of the University while assuring him that the Board would give him and the other newly-established universities all the support required for them to begin on a sound footing. He directed the relevant Departments of the Board to immediately create the necessary links to enable the institution to commence all essential processes for admission. Some of the services simplified for readers include: creation of profile, conversion of UTME to DE, CBT centre services and charges to avoid exploitation by some unscrupulous agents, correction of data and registration procedures.

Others include procedure for printing of admissions letters and results slips, other ancillary registration exercises like that of the National Open University of Nigeria (NOUN), sandwich, part-time and

distance learning programmes of many other tertiary institutions.

Other services in the training manual also include application for transfer, download, local transfer, foreign candidates' transfers, among others.

It is, therefore, hoped that the manual would resolve many of the challenges most CBT centres faced that lead to constant calls for assistance from the National Headquarters, Abuja, during the conduct of examinations.

“DON'T SHY AWAY FROM YOUR RESPONSIBILITIES” ...REGISTRAR CHARGES ZONAL DIRECTORS, STATE COORDINATORS

The Registrar of the Joint Admissions and Matriculation Board (JAMB) Prof. Is-haq Oloyede, has charged Zonal Directors and State Coordinators to be alive to their responsibilities in their various jurisdictions.

The Registrar handed down this warning during an interaction with the Zonal Directors and State Coordinators of the Board. He pointed out that as the highest-ranking officials in the Outstations, they are expected to guide the conduct of their subordinates in line

with the ideals of the Board.

The subtle warning came on the heels of the reprehensible conduct of two members of staff from Benue and Imo States who were discovered to be involved in acts unbecoming of officers of the Board.

The Registrar pointed out that with strict supervision and proper scheduling of duties, many untoward acts would not only be curbed but also that the energy being dissipated on unrewarding activities would be positively channelled.

He stated that the culprits had attempted to circumvent the operational processes of the Board for a pecuniary motive. He revealed that their nefarious activities came to light owing to the foolproof system deployed by the Board which is not only tamperproof but also has inbuilt capacity to detect and record malicious activities targeted at it.

He disclosed that the affected staff were undergoing disciplinary procedures to serve as a deterrent to others.

the Board as he pointed out that with all the measures put in place by Management, no one in his right senses would wish to engage in any fraudulent acts.

The Registrar urged bad eggs within the establishment to turn a new leaf or face the wrath of the Board. He added that, in the meantime, the affected staff had been placed on suspension and would

be subjected to the same sanctions meted out to erring candidates and other undesirable elements alike when their misdeeds came to light.

fact that there is no room for impersonation as whatever information a candidate provides at the point of UTME/DE registration would be what will be on his/her identity card in the school of his/her choice and his/her certificates after graduation, among others. With this fateful outcome, it is important that institutions that are yet to fully comply with this ministerial directive do so with

immediate effect otherwise they would be seen as aiding and abetting impersonation.

Mr. Abubakar had confessed during interrogation that he paid Mr. Ajeru the sum of N25, 000 to get a 'mercenary' to register and take the examination for him. Checks by the Board revealed that the said registration was done at SMS ICT Institute of Training Ltd, Kano. The centre

had since been blacklisted by the Board to serve as deterrent to others.

The Minister of Education, Mal. Adamu Adamu had at the Policy Meeting, warned that any institution that violates the directive on the use of the data obtained from JAMB should be treated as an accomplice.
