

JAMB CAUTIONS ATAP ON ILLEGAL ADMISSIONS

he Joint Admissions and Matriculation Board(JAMB) has warned Abubakar Tatari Ali Polytechnic, Bauchi, against its continued involvement in backdoor admissions. The Zonal Director, Bauchi, Hon.Danladi Mohammed, sounded the note of warning during the visit of the management of the institution to his office in Bauchi. He stated that JAMB

would no longer condone admissions done outside the Board's Central Admissions Processing System(CAPS). According to the Director, based on observations made in the Zonal Office, the majority of the regularisation cases treated in the office are from the institution. He pointed out that the implication of that is that the institution

has done more illegal admissions than any other institution in the State. He, therefore, restated that as from 2021 onwards, any admission conducted outside CAPS would not be condoned by the Board. He, therefore, advised the institution to take advantage of the window of opportunity provided by the Board to clear its backlog of illegally-conducted admissions. The

Director, however, commended the institution on its drive to re-invigorate its Computer-Based Testing centre and their plan to, as a matter of urgency, construct an additional centre within the institution to cater for the Board's UTME examination as well as its desire to switch to Computer-Based Testing mode for the institution's internal examinations. Earlier, the management of the institution led by its Rector, Dr Hashim Sabo Bello, said the visit was to strengthen the existing cordial relationship between the institution and the Zonal Office. The Rector stressed

that the Polytechnic's core mandate is the award of National Diploma and Higher National Diploma, but because of incessant demand, ATAP has been producing candidates in other programmes through its affiliation with Abubakar Tafawa Balewa University, Bauchi. He promised to heed the warning on the conduct of illegal admissions by conducting all its admissions through CAPS. The Rector was accompanied on the visit by the Registrar, Alh. Lawal Sambo; the Bursar, Alh. Lamaran Muhammad Gidado; the Director of Works and Maintenance, Engineer Muhammad Mujtaba Jibril; the Director, Degree Programmes, Engineer Aliyu Mohammed Lawal; and the Admission Officer, Bello Gimba.

AI MAKES PLAGIARISM HARDER TO DETECT, ARGUE ACADEMICS

Paper Written by Chatbot ... As culled from The Chronicle of Education

n academic paper entitled Chatting and Cheating: Ensuring Academic Integrity in the Era of ChatGPT was published recently in an education journal, describing how artificial intelligence (AI) tools "raise a number of challenges and concerns, particularly in relation to academic honesty and plagiarism".

What readers – and indeed the peer reviewers who cleared it for publication – did not know was that the paper itself had been written by the controversial Al chatbot ChatGPT.

"We wanted to show that ChatGPT is writing at a very high level," said Prof Debby Cotton, Director of Academic Practice at Plymouth Marjon University, who pretended to be the paper's lead author. "This is an arms race," she said. "The technology is improving very fast and it's going to be difficult for universities to outrunit."

Prof. Cotton, along with two

colleagues from Plymouth University who also claimed to be co-authors, tipped off editors of the journal Innovations in Education and Teaching International. But the four academics who peer-reviewed it assumed it was written by these three scholars.

For years, universities have been trying to banish the plague of essay mills selling pre-written essays and other academic work to any students trying to cheat the system. But now academics suspect even the essay mills are using ChatGPT, and institutions admit they are racing to catch up with – and catch out – anyone passing off the popular chatbot's work as their own.

The Observer has spoken to a number of universities that say they are planning to expel students who are caught using the software.

Thomas Lancaster, a computer scientist and expert on contract cheating at Imperial College

London, said many universities were "panicking".

"If all we have in front of us is a written document, it is incredibly tough to prove it has been written by a machine because the standard of writing is often good," he said. "The use of English and quality of grammar is often better than from a student."

Lancaster warned that the latest version of the AI model, ChatGPT-4, which was released last week, was meant to be much better and capable of writing in a way that felt "more human".

Nonetheless, he said academics could still look for clues that a student had used ChatGPT. Perhaps the biggest of these is that it does not properly understand academic referencing – a vital part of written university work – and often uses "suspect" references, or makes them up completely.

Bola Ahmed Tinubu is resolutely determined to reset Nigeria's education sector as a critical component of his renewed hope agenda.

Minister of Education, Professor Tahir Mamman, SAN, made this statement at a one-day national stakeholders' workshop on the development of a roadmap for the Nigerian education sector (2023–2027) in Abuja on Thursday 19th October, 2023.

During the workshop, the House of Representatives Committee on University Education called for salary increments for primary, secondary, and university teachers. The Chairman of the Committee, Hon. Abubakar Fulata, specifically said that teachers should not earn less than N250,000, N500,000, and N1 million, respectively, as their monthly remuneration.

Cotton said that in order to ensure their academic paper hoodwinked the reviewers, references had to be changed and added.

Lancaster thought that ChatGPT, which was created by the San Francisco-based tech company OpenAI, would "probably do a good job with earlier assignments" on a degree course, but warned it would let them down in the end. "As your course becomes more specialised, it will become much harder to outsource work to a machine," he said. "I don't think it could write your whole dissertation."

Bristol University is one of a number of academic institutions to have issued new guidance for staff on how to detect that a student has used ChatGPT to cheat. This could lead to

expulsion for repeat offenders.

Prof Kate Whittington, an associate pro-vice-chancellor at the university, said: "It's not a case of one offence and you're out. But we are very clear that we won't accept cheating because we need to maintain standards."

She added: "If you cheat your way to a degree, you might get an initial job, but you won't do well and your career won't progress the way you want it to."

Irene Glendinning, head of academic integrity at Coventry University, said: "We are redoubling our efforts to get the message out to students that if they use these tools to cheat, they can be withdrawn."

Anyone caught would have to do

training on the appropriate use of Al. If they continued to cheat, the university would expel them. "My colleagues are already finding cases and dealing with them. We don't know how many we are missing but we are picking up cases," she said.

Glendinning urged academics to be alert to language that a student would not normally use. "If you can't hear your student's voice, that is a warning," she said. Another is content with "lots of facts and little critique".

She said that students who can't spot the weaknesses in what the bot is producing may slip up. "In my subject of computer science, Al tools can generate code but it will often contain bugs," she explained. "You

ADVISORY ON PROCEDURE FOR EMERGENCY TRANSFER OF RETURNEE NIGERIAN STUDENTS INTO NIGERIAN UNIVERSITY SYSTEM IN TIME OF CRISIS

Please find below the procedure for processing transfer of Returnee Nigerian Students into Nigerian University system in time of crisis:

- A prospective student travelling abroad for undergraduate studies normally registers (document his/her travel) with the Federal Ministry of Education (FME) and obtains a Document ID. It is called "Notification to Study Abroad". In case of crises such registration becomes helpful.
- 2. Anyone who did not but has now become a returnee who is desirous of transfer into a Nigerian University must do a retroactive registration with the Federal Ministry of Education as follows:
 - Go to FME website www.education.gov.ng
 - Go to attestation of academic documents or http://.ess.education.gov.ng
 - Tick the certificates you want to evaluate (Tick your highest qualification in Nigeria to enable you pick a date)
 - Pick a date
 - Make payment via remittal RRR code
 - Print Appointment Slip
 - Go to FME Revenue Unit 2nd floor
 - Go to 8th floor Evaluation Accreditation Division with original copies of your credentials base on your Date of Appointment

 - h. Year of Entry
 - i. Current Level of Study
- 5. Returnee Student selects intended University of Choice and Programme.
- Returnee Student uploads scanned copy of the following documents: 6.
 - a. Current University Admission letter;
 - b. Transcript/Student Semester Results;
 - c. Data page of International Passport; and
 - d. Sworn Affidavit (confirming the genuineness of information supplied and that insincere or false information shall lead to withdrawal from studies and/or of certificates (in the event of issuance). Prosecution may also follow.
- 7. Returnee Student clicks SUBMIT button, which now sends an email to intended University of Choice for Request for Application to Apply for Inter-University Transfer.

- 8. Notification page for successful request is loaded and presented on the screen by IBASS System.
- 9. Returnee Student gets a notification email and SMS for his/her application request sent to the intended University of Choice.
- 10. Student's University of Choice gets an IBASS mail of the Student's Request for Application to Apply for Inter-University Transfer
- 11. Intended University evaluates Student's credentials for possible consideration.
- 12. If the Intended University of Choice is satisfied/unsatisfied with the credentials presented by the Returnee Student, a notification is sent on <u>JAMB-IBASS-mail for</u> Qualified/Unqualified for consideration.
- 13. Qualified Returnee Student is directed via the email and SMS to approach any JAMB Office (in person) to complete the Inter-University Transfer Application.

Note that the process is tracked by JAMB, NUC and the candidate as follows:

- (a) Submitted (b) Being reviewed by the University
 - (c) Successful/Unsuccessful
- 14. The intended University of Choice then follows the Advisory on <u>Inter-University</u> Transfer of Students earlier sent to the institutions in 2019 (see attached).

ADVISORY ON PROCEDURE FOR APPLICATION FOR FOREIGN INTER-UNIVERSITY TRANSFER FOR STALITES (NOT FRESHERS)

Please find below the procedure for application for foreign inter-University transfer for Stalites:

- 1. The proposed institution sends a list of all candidates (not Freshers) for foreign Inter-University transfer to State JAMB Office with a letter of indemnity.
- 2. The proposed institution directs each candidate to State JAMB Office to create his/her profile on efacility platform (Candidate not on the list earlier sent by the proposed institution would be rejected by the State JAMB Office and cannot process any application on the system).
- 3. At State JAMB Office, the candidate fills the INTER-UNIVERSITY TRANSFER APPLICATION FORM FOR STALITES (NOT FRESHERS) FROM FOREIGN UNIVERSITIES online which would be available only at the State JAMB Office (Note that only the State JAMB Office that the institution is located can attend to the candidates).
- 4. Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her Current and Proposed Institutions for the signature of the Heads of the Institutions to indemnify JAMB on the accuracy of the information provided by the candidate. The form is to be endorsed first by the current institution.
- 5. The Proposed Institution sends the endorsed and indemnified form to the Coordinator of the State JAMB Office.
- 6. The form is uploaded from the State JAMB Office to the Headquarters and made available to the efacility platform for processing.
- 1. If the application is approved, the candidate is notified through his/her email.
- 2. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

Board, it might be a little difficult as the total of 6 billion naira is what is needed to pay salaries but the surplus returned this year was 4 billion naira and that is far from the amount needed. He said the money is protected and prepares the Board for any eventualities.

He further stated that work on the proposed Southwest 7.000 capacity Professional Test Centre has been put on hold because those working on the project are waiting for the issues on the land to be resolved. He, however, clarified that the Certificate of Occupancy had been issued to the Board by the former Governor of the state, Mr. Ibikunle Amosun. He said when the centre is ready, candidates from the Southwest are free to choose to write UTME in Abeokuta as all examinations could even be conducted there.

Mrs Kafayat Ibiwoye, Head, Matriculation Monitoring, explained that the cost of diesel and electricity unit has increased and this must not

stop the office from rendering services to the public. She pleaded that something should be done about it.

The Registrar responded that there might be a review of service charges upward as the running cost of the organisation is affected by the general increase in the cost of living in the country.

He stated categorically that he had information about corruption in the office and directed that a comprehensive report be sent to him in that regard. He also gave directives which would enhance the smooth-running and well-defined structure of the office and steps have been taken in this regard.

The State Coordinator, Mr. Hakeem AbdulHameed who was represented by a number of staff on ground appreciated the Registrar for his visit, constant transparency, initiatives and prayed that the Board under his administration be more efficient and effective.

ADVISORY ON PROCEDURE FOR APPLICATION OF FRESH FOREIGN CANDIDATES (EXTRA ORDINARY)

Please find below the procedure for application for fresh foreign candidates (this **supersedes** the advisory issued in November, 2019):

- The University sends a list of all fresh foreign candidates (for current admission) to State JAMB Office with
 a letter of indemnity signed by Head of the Institution. The letter of indemnity will read in part "I confirm
 that the listed candidate as forwarded to JAMB all met the admission requirements into my institution and
 hereby indemnify JAMB against any inaccuracy of the claims".
- The same list and letter as in (1) above should be sent to the JAMB Director of Admissions through the CAPS mail.
- The institution directs candidates to State JAMB Office to create their profiles individually on efacility platform (Note that only the State JAMB Office that the institution is located can attend to the candidates).
- At State JAMB Office, the candidate fills FRESH FOREIGN Application form online which would be available
 only at the State JAMB Office (Candidate not on the list earlier sent by the institution would be rejected by
 the State JAMB Office and cannot process any application on the system).
- Immediately the registration is completed at the JAMB Office, a Registration Number would be generated and assigned to the candidate alongside his/her transaction ID.
- Each candidate is expected to print and submit the auto-generated Indemnity Form after completing the application to his/her institution for the signature of the Head of the Institution to again indemnify JAMB on the accuracy of the information provided by the candidate.
- The <u>Head of the Institution authorises the candidate's application online</u>. At this point the details
 of the candidate is now made available on CAPS to enable the institution Propose and Recommend the
 candidate to JAMB for approval.
- The Head of the Institution would now send the endorsed indemnified <u>physical</u> form to the Coordinator of the State JAMB Office for immediate upload to CAPS for approval.
- NO UPLOAD OF INDEMNIFIED PHYSICAL FORM, NO APPROVAL ON CAPS BY JAMB
- If the application is approved, the candidate is notified through his/her email. The candidate can thereafter print his/her admission letter and access other services online from his/her profile.

Note: Each candidate is to pay for the services online (www.jamb.gov.ng) using ATM cards, Quick Teller or other e-payment channels available for any of the Board's services.

Other Professional Regulatory Agencies will also play a role in sanitizing the process.
- The duration of all Non-Full Time Studies must be maintained as approved by the Regulatory Agencies. This is generally not less than one hundred and fifty percent (150%) of the equivalence of Full Time.

<u>ADVERTORIALS</u>

- Institutions that desire to place advertisement can do so with the requirement that candidates who sat for the current **UTME** (or **DE** candidates) should change to their institutions as First (1st) Choice rather than requesting the candidates to purchase another application form or apply. This is to prevent the issue of double registration which is a violation of the mandate of JAMB.
- It should be reiterated that no Institution should advertise or sell "application forms" for admissions into the programmes listed above. Institutions should advise candidates to apply to them through Joint Admissions and Matriculation Board (JAMB). Duplication of application forms is **NOT** allowed.
